

# Preface to the Fourth Edition

This new edition differs from the Third in two major respects. First, a number of new worked examples have been added. This has been done in response to the comments of many students that such examples would be an aid in understanding the material and useful in preparing them to do the problem sets. My task was to add enough examples to be helpful, without at the same time lengthening the text significantly. (Two reviewers urged me not to lengthen the book at all, inadvertently providing an answer to Sr. de Cervantes' question.)

The second major difference between this edition and its predecessor involves switching the roles of the two spherical angles  $\theta$  and  $\phi$ . Years ago, when the book was written it was common to use  $\theta$  as the polar angle and  $\phi$  as the azimuthal. Nowadays, the more common convention reverses this, making  $\theta$  the azimuthal angle and  $\phi$  the polar, the convention we adopt in this edition.

I wish to thank the many readers who, over the years, have written me with suggestions for improvements in the text. These suggestions have often been adopted and have been an important reason for the book's very long lifetime.

# Introduction, Vector Functions, and Electrostatics

## *Introduction*

In this text the subject of vector calculus is presented in the context of simple electrostatics. We follow this procedure for two reasons. First, much of vector calculus was invented for use in electromagnetic theory and is ideally suited to it. This presentation will therefore show what vector calculus is and at the same time give you an idea of what it's for. Second, we have a deep-seated conviction that mathematics—in any case *some* mathematics—is best discussed in a context that is not exclusively mathematical. Thus, we will soft-pedal mathematical rigor,

which we think is an obstacle to learning this subject on a first exposure to it, and appeal as much as possible to physical and geometric intuition.

Now, if you want to learn vector calculus but know little or nothing about electrostatics, you needn't be put off by our approach; no very great knowledge of physics is required to read and understand this text. Only the simplest features of electrostatics are involved, and these are presented in a few pages near the beginning. It should not be an impediment to anyone. In fact, the entire discussion is based on a search for a convenient method of finding the electrostatic field given the distribution of electric charges which produce it. This is the thread that runs through, and unifies, our presentation, so that as a bare minimum all you really need do is take our word for the fact that the electric field is an important enough quantity to warrant spending some time and effort in setting up a general method for calculating it. In the process, we hope you will learn the elements of vector calculus.

Having said what you do *not* need to know, we must now say what you *do* need to know. To begin with, you should, of course, be fluent in elementary calculus. Beyond that you should know how to work with functions of several variables, partial derivatives, and multiple (double and triple) integrals.<sup>1</sup> Finally, you must know something about vectors. This, however, is a subject of which too many writers and teachers have made heavy weather. What you should know about it can be listed quickly: definition of vector, addition and subtraction of vectors, multiplication of vectors by scalars, dot and cross products, and finally, resolution of vectors into components. An hour's time with any reasonable text on the subject should provide you with all you need to know of it to follow this text.

## ***Vector Functions***

One of the most important quantities we deal with in the study of electricity is the electric field, and much of our presentation will make use of this quantity. Since the electric field is an example of what we call a vector function, we begin our discussion with a brief résumé of the function concept.

A function of one variable, generally written  $y = f(x)$ , is a *rule*

which tells us how to associate two numbers  $x$  and  $y$ ; given  $x$ , the function tells us how to determine the associated value of  $y$ . Thus, for example, if  $y = f(x) = x^2 - 2$ , then we calculate  $y$  by squaring  $x$  and then subtracting 2. So, if  $x = 3$ ,

$$y = 3^2 - 2 = 7.$$

Functions of more than one variable are also rules for associating sets of numbers. For example, a function of three variables designated  $w = F(x, y, z)$  tells how to assign a value to  $w$  given  $x$ ,  $y$ , and  $z$ . It is helpful to view this concept geometrically; taking  $(x, y, z)$  to be the Cartesian coordinates of a point in space, the function  $F(x, y, z)$  tells us how to associate a number with each point. As an illustration, a function  $T(x, y, z)$  might give the temperature at any point  $(x, y, z)$  in a room.

The functions so far discussed are *scalar* functions; the result of “plugging”  $x$  in  $f(x)$  is the scalar  $y = f(x)$ . The result of “plugging” the three numbers  $x$ ,  $y$ , and  $z$  in  $T(x, y, z)$  is the temperature, a scalar. The generalization to vector functions is straightforward. A vector function (in three dimensions) is a rule which tells us how to associate a *vector* with each point  $(x, y, z)$ . An example is the velocity of a fluid. Designating this function  $\mathbf{v}(x, y, z)$ , it specifies the *speed* of the fluid as well as the *direction* of flow at the point  $(x, y, z)$ . In general, a vector function  $\mathbf{F}(x, y, z)$  specifies a *magnitude* and a *direction* at every point  $(x, y, z)$  in some region of space. We can picture a vector function as a collection of arrows (Figure I-1), one for each point  $(x, y, z)$ .



The direction of the arrow at any point is the direction specified by the vector function, and its length is proportional to the magnitude of the function.



nents, as in Figure I-2. Letting  $\mathbf{i}$ ,  $\mathbf{j}$ , and  $\mathbf{k}$  be unit vectors along the  $x$ -,  $y$ -, and  $z$ -axes, respectively, we write

$$\mathbf{F}(x, y, z) = \mathbf{i}F_x(x, y, z) + \mathbf{j}F_y(x, y, z) + \mathbf{k}F_z(x, y, z).$$

The three quantities  $F_x$ ,  $F_y$ , and  $F_z$ , which are themselves scalar functions of  $x$ ,  $y$ , and  $z$ , are the three Cartesian components of the vector function  $\mathbf{F}(x, y, z)$  in some coordinate system.<sup>2</sup>

An example of a vector function (in two dimensions for simplicity) is provided by

$$\mathbf{F}(x, y) = \mathbf{i}x + \mathbf{j}y,$$

which is illustrated in Figure I-3. You probably recognize this



function as the position vector  $\mathbf{r}$ . Each arrow in the figure is in the *radial* direction (that is, directed along a line emanating from the origin) and has a length equal to its distance from the origin.<sup>3</sup> A second example,

$$\mathbf{G}(x, y) = \frac{-\mathbf{i}y + \mathbf{j}x}{\sqrt{x^2 + y^2}},$$

is shown in Figure I-4. You should verify for yourself that for this vector function all the arrows are in the tangential direction



(that is, each is tangent to a circle centered at the origin) and all have the same length.

## Electrostatics

We shall base our discussion of electrostatics on three experimental facts. The first of these facts is the existence of electric charge itself. There are two kinds of charge, positive and negative, and every material body contains electric charge,<sup>4</sup> although often the positive and negative charges are present in equal amounts so that there is zero *net* charge.

The second fact is called Coulomb's law, after the French physicist who discovered it. This law states that the electrostatic



force between two charged particles (a) is proportional to the product of their charges, (b) is inversely proportional to the square of the distance between them, and (c) acts along the line joining them. Thus, if  $q_0$  and  $q$  are the charges of two particles a distance  $r$  apart (Figure I-5), then the force on  $q_0$  due to  $q$  is

$$\mathbf{F} = K \frac{qq_0}{r^2} \hat{\mathbf{u}},$$

where  $\hat{\mathbf{u}}$  is a unit vector (that is, a vector of length 1) pointing from  $q$  to  $q_0$ , and  $K$  is a constant of proportionality. In this text we'll use rationalized MKS units. In that system length, mass, and time are measured in meters, kilograms, and seconds, respectively, and electric charge in coulombs. With this choice of units  $K = 1/(4\pi\epsilon_0)$ , where the constant  $\epsilon_0$ , called the permittivity of free space, has the value  $8.854 \times 10^{-12}$  coulombs<sup>2</sup> per newton-meters<sup>2</sup>, and Coulomb's law reads

$$\mathbf{F} = \frac{1}{4\pi\epsilon_0} \frac{qq_0}{r^2} \hat{\mathbf{u}}. \quad (\text{I-1})$$

You should convince yourself that the familiar rule "like charges repel, unlike charges attract" is built into this formula.

The third and last fact is called the principle of superposition. If  $\mathbf{F}_1$  is the force exerted on  $q_0$  by  $q_1$  when there are no other charges nearby, and  $\mathbf{F}_2$  is the force exerted on  $q_0$  by  $q_2$  when there are no other charges nearby, then the principle of superposition says that the net force exerted on  $q_0$  by  $q_1$  and  $q_2$  when they are both present is the vector sum  $\mathbf{F}_1 + \mathbf{F}_2$ . This is a deeper statement than it appears at first glance. It says not merely that electrostatic forces add vectorially (*all* forces add vectorially), but that the force between two charged particles is not modified by the presence of other charged particles.

We now introduce a vector function of position, which will play a leading role in our discussion. It is the electrostatic field,

denoted  $\mathbf{E}(\mathbf{r})$  and defined by the equation  $\mathbf{E}(\mathbf{r}) = \mathbf{F}(\mathbf{r})/q_0$ , or  $\mathbf{F}(\mathbf{r}) = q_0\mathbf{E}(\mathbf{r})$ . That is, the electrostatic field is the force per unit charge. From Equation (I-1) we have

$$\mathbf{E}(\mathbf{r}) = \frac{\mathbf{F}(\mathbf{r})}{q_0} = \frac{1}{4\pi\epsilon_0} \frac{q}{r^2} \hat{\mathbf{u}}. \quad (\text{I-2})$$

This is the electrostatic field at  $\mathbf{r}$  due to the charge  $q$ .

A natural extension of these ideas is the following. Suppose we have a group of  $N$  charges with  $q_1$  situated at  $\mathbf{r}_1$ ,  $q_2$  at  $\mathbf{r}_2$ ,  $\dots$ ,  $q_N$  at  $\mathbf{r}_N$ . Then the electrostatic force these charges exert on a charge  $q_0$  situated at  $\mathbf{r}$  is

$$\mathbf{F}(\mathbf{r}) = \frac{1}{4\pi\epsilon_0} \sum_{l=1}^N \frac{q_0 q_l}{|\mathbf{r} - \mathbf{r}_l|^2} \hat{\mathbf{u}}_l, \quad (\text{I-3})$$

where  $\hat{\mathbf{u}}_l$  is the unit vector pointing from  $\mathbf{r}_l$  to  $\mathbf{r}$ . From Equation (I-3) we have

$$\mathbf{E}(\mathbf{r}) = \frac{1}{4\pi\epsilon_0} \sum_{l=1}^N \frac{q_l}{|\mathbf{r} - \mathbf{r}_l|^2} \hat{\mathbf{u}}_l. \quad (\text{I-4})$$

This is the electrostatic field at  $\mathbf{r} = ix + jy + kz$  produced by the charges  $q_l$  at  $\mathbf{r}_l$  ( $l = 1, 2, \dots, N$ ). Equation (I-4) says that the field due to a group of charges is the vector sum of the fields each produces alone. That is, superposition holds for fields as well as forces. You may think of the region of space in the vicinity of a charge or group of charges as “pervaded” by an electrostatic field; the net electrostatic force exerted by those charges on a charge  $q$  at a point  $\mathbf{r}$  is then  $q\mathbf{E}(\mathbf{r})$ .

You may be a bit mystified about our bothering to introduce a new vector function, the electrostatic field, which differs in an apparently trivial way from the electrostatic force. There are two major reasons for doing this. First, in electrostatics we are interested in the effect that a given set of charges produces on another set. This problem can be conveniently divided into two parts by introducing the electrostatic field, for then we can (a) calculate the field due to a given distribution of charges without worrying about the effect these charges have on *other* charges in the vicinity and (b) calculate the effect a given field has on charges placed in it without worrying about the distribution of charges that produced the field. In this book we will be concerned with the first of these.

The second reason for introducing the electrostatic field is more basic. It turns out that all classical electromagnetic theory can be codified in terms of four equations, called Maxwell's equations, which relate fields (electric and magnetic) to each other and to the charges and currents which produce them. Thus, electromagnetism is a *field theory* and the electric field ultimately plays a role and assumes an importance which far transcends its simple elementary definition as "force per unit charge."

Very often it is convenient to treat a distribution of electric charge as if it were continuous. To do this, we proceed as follows. Suppose in some region of space of volume  $\Delta V$  the total electric charge is  $\Delta Q$ . We define the *average charge density* in  $\Delta V$  as

$$\bar{\rho}_{\Delta V} \equiv \frac{\Delta Q}{\Delta V}. \quad (\text{I-5})$$

Using this, we can define the charge density at the point  $(x, y, z)$ , denoted  $\rho(x, y, z)$ , by taking the limit of  $\bar{\rho}_{\Delta V}$  as  $\Delta V$  shrinks down about the point  $(x, y, z)$ :

$$\rho(x, y, z) \equiv \lim_{\substack{\Delta V \rightarrow 0 \\ \text{about } (x, y, z)}} \frac{\Delta Q}{\Delta V} = \lim_{\substack{\Delta V \rightarrow 0 \\ \text{about } (x, y, z)}} \bar{\rho}_{\Delta V}. \quad (\text{I-6})$$

The electric charge in some region of volume  $V$  can then be expressed as the triple integral of  $\rho(x, y, z)$  over the volume  $V$ ; that is,

$$Q = \iiint_V \rho(x, y, z) dV.$$

In much the same way it follows that for a continuous distribution of charges, Equation (I-4) is replaced by

$$\mathbf{E}(\mathbf{r}) = \frac{1}{4\pi\epsilon_0} \iiint_V \frac{\rho(\mathbf{r}') \hat{\mathbf{u}}(\mathbf{r}')}{|\mathbf{r} - \mathbf{r}'|^2} dV'. \quad (\text{I-7})$$

**I-1** Using arrows of the proper magnitude and direction, sketch each of the following vector functions:

(a) $iy + jx$ .	(e) $jk$ .
(b) $(i + j)/\sqrt{2}$ .	(f) $(iy + jx)/\sqrt{x^2 + y^2}$ , $(x, y) \neq (0, 0)$ .
(c) $ix - jy$ .	(g) $iy + jxy$ .
(d) $iy$ .	(h) $i + jy$ .

**I-2** Using arrows, sketch the electric field of a unit positive charge situated at the origin. [Note: You may simplify the problem by confining your sketch to one of the coordinate planes. Does it matter which plane you choose?]

**I-3** (a) Write a formula for a vector function in two dimensions which is in the positive radial direction and whose magnitude is 1.

(b) Write a formula for a vector function in two dimensions whose direction makes an angle of  $45^\circ$  with the  $x$ -axis and whose magnitude at any point  $(x, y)$  is  $(x + y)^2$ .

(c) Write a formula for a vector function in two dimensions whose direction is tangential (in the sense of the example on page 5) and whose magnitude at any point  $(x, y)$  is equal to its distance from the origin.

(d) Write a formula for a vector function in three dimensions which is in the positive radial direction and whose magnitude is 1.

**I-4** An object moves in the  $xy$ -plane in such a way that its position vector  $\mathbf{r}$  is given as a function of time  $t$  by

$$\mathbf{r} = \mathbf{i}a \cos \omega t + \mathbf{j}b \sin \omega t,$$

where  $a$ ,  $b$ , and  $\omega$  are constants.

(a) How far is the object from the origin at any time  $t$ ?


(b) Find the object's velocity and acceleration as functions of time.

**I-5** A charge  $+1$  is situated at the point  $(1, 0, 0)$  and a charge  $-1$  is situated at the point  $(-1, 0, 0)$ . Find the electric field of these two charges at an arbitrary point  $(0, y, 0)$  on the  $y$ -axis.

**I-6** Instead of using arrows to represent vector functions (as in Problems I-1 and I-2), we sometimes use families of curves called *field lines*. A curve  $y = y(x)$  is a field line of the vector function  $\mathbf{F}(x, y)$  if at each point  $(x_0, y_0)$  on the curve,  $\mathbf{F}(x_0, y_0)$  is tangent to the curve (see the figure).



(a) Show that the field lines  $y = y(x)$  of a vector function

$$\mathbf{F}(x, y) = \mathbf{i}F_x(x, y) + \mathbf{j}F_y(x, y)$$

are solutions of the differential equation

$$\frac{dy}{dx} = \frac{F_y(x, y)}{F_x(x, y)}.$$

(b) Determine the field lines of each of the functions of Problem I-1. Draw the field lines and compare with the arrow diagrams of Problem I-1.

# Surface Integrals and the Divergence

## *Gauss' Law*

Since the electrostatic field is so important a quantity in electrostatics, it follows that we need some convenient way to find it, given a set of charges. At first glance it might appear that we solved this problem before we even stated it, for, after all, do not Equations (I-4) and (I-7) provide us with a means of finding  $\mathbf{E}$ ? The answer is, in general, no. Unless there are very few charges in the system and/or they are arranged simply or very symmetrically, the sum in Equation (I-4) and the integral in Equation (I-7) are usually prohibitively difficult—and frequently impossible—to perform. Thus, these two equations provide what is

usually only a “formal” solution<sup>1</sup> to the problem, not a practical one, and we must cast about for some other way to calculate the field  $\mathbf{E}$ .

In the course of this casting about, we come inevitably to that remarkable relation known as Gauss’ law. We say “inevitably” because it is hard to think of any other expression in elementary electricity and magnetism containing the electric field [apart, of course, from Equations (I-4) and (I-7), which we have already rejected]. Gauss’ law is

$$\iint_S \mathbf{E} \cdot \hat{\mathbf{n}} \, dS = \frac{q}{\epsilon_0}. \quad (\text{II-1})$$

If you don’t understand this equation, don’t panic. The left-hand side of this equation is an example of what is called a surface integral, an important concept in vector calculus and one that is probably new to you. The integrand of this integral is the dot product of the electric field and the quantity  $\hat{\mathbf{n}}$ , which is called a “unit normal vector” and is probably also unfamiliar. We are about to discuss both surface integrals and unit normal vectors in excruciating detail, and one of our main reasons for quoting Gauss’ law at this point in our narrative is to motivate this discussion.

We won’t stop here to derive Gauss’ law, since the derivation wouldn’t mean much to you until you have read the next few sections. Then you can consult almost any text on electricity and magnetism for the gory details. And if you can contain yourself, wait until we’ve discussed the divergence theorem (pages 45–52), after which you will be able to derive Gauss’ law easily (see Problem II-27).

## *The Unit Normal Vector*

One of the factors in the integrand in Gauss’ law [Equation (II-1)] is a quantity designated  $\hat{\mathbf{n}}$  and called the unit normal vector. This quantity is part of the integrand in most if not all of the surface integrals we’ll encounter; furthermore, as we’ll see, it plays an important role in the evaluation of surface integrals even

<sup>1</sup> The word “formal” in this context is a euphemism for “useless.”

## The Unit Normal Vector

when it does not appear explicitly. Thus, before discussing surface integrals themselves, we'll dispose of the questions of how this vector function is defined and calculated.

The word "normal" in the present context means, loosely speaking, "perpendicular." Thus, a vector  $\mathbf{N}$  normal to the  $xy$ -plane is clearly one parallel to the  $z$ -axis (Figure II-1), while a



vector normal to a spherical surface must be in the radial direction (Figure II-2). To give a precise definition of a vector normal to a



surface, consider an arbitrary surface  $S$ , as shown in Figure II-3. Construct two noncollinear vectors  $\mathbf{u}$  and  $\mathbf{v}$  tangent to  $S$  at some point  $P$ . A vector  $\mathbf{N}$  which is perpendicular to both  $\mathbf{u}$  and  $\mathbf{v}$  at  $P$  is, by definition, normal to  $S$  at  $P$ . Now, as we know, the vector



product of  $\mathbf{u}$  and  $\mathbf{v}$  has precisely this property; it is perpendicular to both  $\mathbf{u}$  and  $\mathbf{v}$ . Thus, we may write  $\mathbf{N} = \mathbf{u} \times \mathbf{v}$ . To make this a *unit* vector (that is, one whose length is 1) is simple: we just divide  $\mathbf{N}$  by its magnitude  $N$ . Thus,

$$\hat{\mathbf{n}} = \frac{\mathbf{N}}{N} = \frac{\mathbf{u} \times \mathbf{v}}{|\mathbf{u} \times \mathbf{v}|}$$

is a unit vector normal to  $S$  at  $P$ .

To find an expression for  $\hat{\mathbf{n}}$ , we consider some surface  $S$  given by the equation  $z = f(x, y)$ ; see Figure II-4. Following the proce-



dure suggested by the preceding discussion, we'll find two vectors  $\mathbf{u}$  and  $\mathbf{v}$  whose cross product will yield the required normal vector  $\hat{\mathbf{n}}$ . For this purpose let's construct a plane through a point  $P$  on  $S$  and parallel to the  $xz$ -plane, as shown in Figure II-4. This plane intersects the surface  $S$  in a curve  $C$ . We construct the vec-

tor  $\mathbf{u}$  tangent to  $C$  at  $P$  and having an  $x$ -component of arbitrary length  $u_x$ . The  $z$ -component of  $\mathbf{u}$  is  $(\partial f/\partial x)u_x$ ; in this expression we use the fact that the slope of  $\mathbf{u}$  is, by construction, the same as



that of the surface  $S$  in the  $x$ -direction (see Figure II-5). Thus,

$$\mathbf{u} = \mathbf{i}u_x + \mathbf{k}\left(\frac{\partial f}{\partial x}\right)u_x = \left[\mathbf{i} + \mathbf{k}\left(\frac{\partial f}{\partial x}\right)\right]u_x. \quad (\text{II-2})$$

To find  $\mathbf{v}$ , the second of our two vectors, we pass another plane through the point  $P$  on  $S$ , but in this case parallel to the  $yz$ -plane (Figure II-6). It intersects  $S$  in a curve  $C'$ , and the vector  $\mathbf{v}$  can



now be constructed tangent to  $C'$  at  $P$  with a  $y$ -component of arbitrary length  $v_y$ . Arguing as above, we have

$$\mathbf{v} = \mathbf{j}v_y + \mathbf{k}\left(\frac{\partial f}{\partial y}\right)v_y = \left[\mathbf{j} + \mathbf{k}\left(\frac{\partial f}{\partial y}\right)\right]v_y. \quad (\text{II-3})$$

Using the two vectors  $\mathbf{u}$  and  $\mathbf{v}$  as given in Equations (II-2) and (II-3), we now construct their cross product. The result,

$$\mathbf{u} \times \mathbf{v} = \left[ -\mathbf{i} \left( \frac{\partial f}{\partial x} \right) - \mathbf{j} \left( \frac{\partial f}{\partial y} \right) + \mathbf{k} \right] u_x v_y,$$

is a vector, which as we stated above, is normal to  $S$  at  $P$ . To make a *unit* vector of this, we divide it by its magnitude to get

$$\hat{\mathbf{n}}(x, y, z) = \frac{\mathbf{u} \times \mathbf{v}}{|\mathbf{u} \times \mathbf{v}|} = \frac{-\mathbf{i} \frac{\partial f}{\partial x} - \mathbf{j} \frac{\partial f}{\partial y} + \mathbf{k}}{\sqrt{1 + \left( \frac{\partial f}{\partial x} \right)^2 + \left( \frac{\partial f}{\partial y} \right)^2}}. \quad (\text{II-4})$$

This, then, is the unit vector normal to the surface  $z = f(x, y)$  at the point  $(x, y, z)$  on the surface.<sup>2</sup> Note that it is independent of the two arbitrary quantities  $u_x$  and  $v_y$ .

A couple of examples may be in order here. First a trivial one: What is the unit vector normal to the  $xy$ -plane? The answer, of course, is  $\mathbf{k}$  (see Figure II-1). Let's see how Equation (II-4) provides us with this answer. The equation of the  $xy$ -plane is

$$z = f(x, y) = 0,$$

whence we have the profound observations

$$\frac{\partial f}{\partial x} = 0 \quad \text{and} \quad \frac{\partial f}{\partial y} = 0.$$

Substituting these in Equation (II-4), we get  $\hat{\mathbf{n}} = \mathbf{k}/\sqrt{1} = \mathbf{k}$ , as advertised.

As a second example, consider the sphere of radius 1 centered at the origin (Figure II-2). Its upper hemisphere is given by

$$z = f(x, y) = (1 - x^2 - y^2)^{1/2},$$

<sup>2</sup> The uniqueness of our result [Equation (II-4)] may be questioned on two counts. The first of these is a sign ambiguity: If  $\hat{\mathbf{n}}$  is a unit normal vector, so is  $-\hat{\mathbf{n}}$ . The matter of which sign to use is discussed below. The second question arises from the fact that the two tangent vectors  $\mathbf{u}$  and  $\mathbf{v}$  used in determining  $\hat{\mathbf{n}}$  are rather special, since each is parallel to one of the coordinate planes. Would we get the same result using two arbitrary tangent vectors? This issue is considered in Problem IV-26, where it is shown that  $\hat{\mathbf{n}}$  as given by Equation (II-4) is, apart from sign, indeed unique.

whence

$$\frac{\partial f}{\partial x} = -\frac{x}{z} \quad \text{and} \quad \frac{\partial f}{\partial y} = -\frac{y}{z}.$$

Using these in Equation (II-4) leads to

$$\hat{\mathbf{n}} = \frac{\mathbf{i}x + \mathbf{j}y + \mathbf{k}}{\sqrt{\frac{x^2}{z^2} + \frac{y^2}{z^2} + 1}} = \frac{\mathbf{i}x + \mathbf{j}y + \mathbf{k}z}{\sqrt{x^2 + y^2 + z^2}} = \mathbf{i}x + \mathbf{j}y + \mathbf{k}z,$$

where we have used the equation of the unit sphere  $x^2 + y^2 + z^2 = 1$ . This is, as expected, a vector in the radial direction (see Figure II-2). To show that its length is 1, we observe that  $\hat{\mathbf{n}} \cdot \hat{\mathbf{n}} = x^2 + y^2 + z^2 = 1$ .


With the matter of the unit normal vector now disposed of, we turn to our next task, a discussion of surface integrals.

**Definition of Surface Integrals**

We now define the surface integral of the normal component of a vector function  $\mathbf{F}(x, y, z)$ . This quantity is denoted by

$$\iint_S \mathbf{F} \cdot \hat{\mathbf{n}} \, dS, \quad (\text{II-5})$$

and as you can see, Gauss' law [Equation (II-1)] is expressed in terms of just such an integral. Let  $z = f(x, y)$  be the equation of some surface. We'll consider a limited portion of this surface, which we designate  $S$  (see Figure II-7). Our first step in formulat-



ing the definition of the surface integral (II-5) is to approximate  $S$  by a polyhedron consisting of  $N$  plane faces each of which is tangent to  $S$  at some point. Figure II-8 shows how this approximat-



ing polyhedron might look for an octant of a spherical shell. We concentrate our attention on one of these plane faces, say the  $l$ th one (Figure II-9). Let its area be denoted  $\Delta S_l$  and let  $(x_l, y_l, z_l)$  be



the coordinates of the point at which the face is tangent to the surface  $S$ . We evaluate the function  $\mathbf{F}$  at this point and then form its dot product with  $\hat{\mathbf{n}}_l$ , the unit vector normal to the  $l$ th face. The resulting quantity,  $\mathbf{F}(x_l, y_l, z_l) \cdot \hat{\mathbf{n}}_l$ , is then multiplied by the area  $\Delta S_l$  of the face to give

$$\mathbf{F}(x_l, y_l, z_l) \cdot \hat{\mathbf{n}}_l \Delta S_l.$$

We carry out this same process for each of the  $N$  faces of the approximating polyhedron and then form the sum over all  $N$  faces:

$$\sum_{l=1}^N \mathbf{F}(x_l, y_l, z_l) \cdot \hat{\mathbf{n}}_l \Delta S_l.$$

## Definition of Surface Integrals

The surface integral (II-5) is defined as the *limit* of this sum as the number of faces,  $N$ , approaches infinity and the area of *each* face approaches zero.<sup>3</sup> Thus,

$$\iint_S \mathbf{F} \cdot \hat{\mathbf{n}} \, dS = \lim_{\substack{N \rightarrow \infty \\ \text{each } \Delta S_i \rightarrow 0}} \sum_{i=1}^N \mathbf{F}(x_i, y_i, z_i) \cdot \hat{\mathbf{n}}_i \Delta S_i. \quad (\text{II-6})$$

If we want to cross all the  $t$ 's and dot all the  $i$ 's, this integral, strictly speaking, should be written

$$\iint_S \mathbf{F}(x, y, z) \cdot \hat{\mathbf{n}}(x, y, z) \, dS$$

since both  $\mathbf{F}$  and  $\hat{\mathbf{n}}$  are, in general, functions of position. We prefer, and where possible will use, the less cluttered notation

$$\iint_S \mathbf{F} \cdot \hat{\mathbf{n}} \, dS$$

with the arguments of the functions understood.

The surface  $S$  over which we integrate a surface integral can be one of two kinds: closed or open. A closed surface, such as a spherical shell, divides space into two parts, an inside and an outside, and to get from inside to outside, you must go *through* the surface. An open surface, such as a flat piece of paper, does not have this property; it is possible to get from one side of the sheet to the other without going through it. The definition of surface integrals given in Equation (II-6) applies equally well to both closed and open surfaces. However, the surface integral is not well defined until we specify which of the two possible directions of the normal we are to use (see Figure II-10). In the case of an



<sup>3</sup> The statement “each  $\Delta S_i \rightarrow 0$ ” is not quite precise. The area of a rectangular patch, for example, might tend to zero because its width decreases while its length remains fixed. This would not be acceptable. Here and elsewhere we must interpret “each  $\Delta S_i \rightarrow 0$ ” to mean that *all* linear dimensions of the  $i$ th patch tend to zero.

open surface, the direction must be given as part of the statement of the problem. In the case of a closed surface, there is a gentlemen's agreement which specifies the direction once and for all: the normal is chosen so that it points *outward* from the volume enclosed by the surface.

The integral in Gauss' law [Equation (II-1)] is taken over a closed surface. Gauss' law, in fact, says that the surface integral of the normal component of the electric field over a closed surface is equal to the total (net) charge enclosed by the surface, divided by  $\epsilon_0$ . Below (pages 33–37 and Problems II-11, II-12, and II-13) we'll see how, when the charges are arranged neatly and symmetrically, Gauss' law can be used to determine the electric field. But the thrust of our whole discussion will be to subject Gauss' law to a series of harrowing adventures which eventually transform it into an expression useful for finding  $\mathbf{E}$  even when we don't have symmetry to help us.

Sometimes we encounter surface integrals which are a little simpler than the kind we've just defined, although basically they are almost the same. These are surface integrals of the form

$$\iint_S G(x, y, z) dS, \quad (\text{II-7})$$

where the integrand  $G(x, y, z)$  is a *given* scalar function rather than the dot product of two vector functions as in (II-5) and (II-6). We go about defining this kind of surface integral much as we did above: we approximate  $S$  by a polyhedron, form the product  $G(x_l, y_l, z_l) \Delta S_l$ , sum over all faces, and then take the limit:

$$\iint_S G(x, y, z) dS = \lim_{\substack{N \rightarrow \infty \\ \text{each } \Delta S_l \rightarrow 0}} \sum_{l=1}^N G(x_l, y_l, z_l) \Delta S_l. \quad (\text{II-8})$$

As an example of this kind of surface integral, suppose we have a surface of negligible thickness with surface density (that is, mass per unit area)  $\sigma(x, y, z)$ , and we wish to determine its total mass. Approximating this surface by a polyhedron as above, we recognize that  $\sigma(x_l, y_l, z_l) \Delta S_l$  is approximately the mass of the  $l$ th face of the polyhedron and that

$$\sum_{l=1}^N \sigma(x_l, y_l, z_l) \Delta S_l$$

is approximately the mass of the entire surface. Taking the limit

$$\lim_{N \rightarrow \infty} \sum_{l=1}^N \sigma(x_l, y_l, z_l) \Delta S_l = \iint_S \sigma(x, y, z) dS,$$

each  $\Delta S_l \rightarrow 0$

we get the total mass of the surface.

An example of an even simpler surface integral of this kind is

$$\iint_S dS.$$

This integral is taken as the definition of the surface area of  $S$ .


## Evaluating Surface Integrals

Now that we have defined surface integrals, we must develop methods to evaluate them, and that will be our task here. For simplicity we'll deal with surface integrals of the form (II-7), where the integrand is a given scalar function, rather than the slightly more complicated form (II-5). There will be no loss of generality in doing this for all our results can be made to apply to integrals of the form (II-5) just by replacing  $G(x, y, z)$  everywhere by  $\mathbf{F}(x, y, z) \cdot \hat{\mathbf{n}}$ .

To evaluate the integral

$$\iint_S G(x, y, z) dS$$

over a portion  $S$  of the surface  $z = f(x, y)$  (see Figure II-11), we go back to the definition of the surface integral [Equation (II-8)].





Our strategy will be to relate  $\Delta S_l$  to the area  $\Delta R_l$  of its projection on the  $xy$ -plane, as shown in Figure II-12. Doing so, as we'll see, will enable us to express the surface integral over  $S$  in terms of an ordinary double integral over  $R$ , which is the projection of  $S$  on the  $xy$ -plane, as shown in Figure II-11.

Relating  $\Delta S_l$  to  $\Delta R_l$  is not difficult if we recall that  $\Delta S_l$  (like the area of any plane surface) can be approximated to any desired degree of accuracy by a set of rectangles as shown in Figure II-13.



For this reason we need only find the relation between the area of a rectangle and its projection on the  $xy$ -plane. Thus, consider a rectangle so oriented that one pair of its sides is parallel to the  $xy$ -plane (Figure II-14). If we call the lengths of these sides  $a$ , it's clear that their projections on the  $xy$ -plane also have length  $a$ . But the other pair of sides, of length  $b$ , have projections of length  $b'$ , and in general,  $b$  and  $b'$  are *not* equal. Thus, to relate the area of the rectangle  $ab$  to the area of its projection  $ab'$ , we must express



$b$  in terms of  $b'$ . This is easy to do, for if  $\theta$  is the angle shown in Figure II-14, we have  $b = b'/\cos \theta$ , and so

$$ab = \frac{ab'}{\cos \theta}.$$

If we let  $\hat{\mathbf{n}}$  denote the unit vector normal to our rectangle, then we can readily convince ourselves that  $\cos \theta = \hat{\mathbf{n}} \cdot \mathbf{k}$  where  $\mathbf{k}$ , as always, is the unit vector in the positive  $z$ -direction. Thus,

$$ab = \frac{ab'}{\hat{\mathbf{n}} \cdot \mathbf{k}}.$$

Since the area  $\Delta S_l$  can be approximated with arbitrary accuracy by such rectangles, it follows that

$$\Delta S_l = \frac{\Delta R_l}{\hat{\mathbf{n}}_l \cdot \mathbf{k}},$$

where, of course,  $\hat{\mathbf{n}}_l$  is the unit vector normal to the  $l$ th plane surface.

We can now rewrite the definition of the surface integral [Equation (II-8)] as

$$\iint_S G(x, y, z) dS = \lim_{\substack{N \rightarrow \infty \\ \text{each } \Delta R_l \rightarrow 0}} \sum_{l=1}^N G(x_l, y_l, z_l) \frac{\Delta R_l}{\hat{\mathbf{n}}_l \cdot \mathbf{k}}, \quad (\text{II-9})$$

where the statement “each  $\Delta S_l \rightarrow 0$ ” has been replaced by the equivalent but now more appropriate “each  $\Delta R_l \rightarrow 0$ .” We are

now obviously well on the road to rewriting the surface integral over  $S$  as a double integral over  $R$ . In fact,

$$\lim_{\substack{N \rightarrow \infty \\ \text{each } \Delta R_i \rightarrow 0}} \sum_{i=1}^N \frac{G(x_i, y_i, z_i)}{\hat{\mathbf{n}}_i \cdot \mathbf{k}} \Delta R_i \equiv \iint_R \frac{G(x, y, z)}{\hat{\mathbf{n}}(x, y, z) \cdot \mathbf{k}} dx dy, \quad (\text{II-10})$$

where  $\hat{\mathbf{n}}(x, y, z)$  is the unit vector normal to the surface  $S$  at the point  $(x, y, z)$ . This is a double integral over  $R$  even though it does not quite look like one. What appears to spoil it is that nasty  $z$  in  $G$  and  $\hat{\mathbf{n}}$ ; a double integral over a region in the  $xy$ -plane clearly has no business containing any  $z$ 's. But the  $z$ -dependence is spurious because  $(x, y, z)$  are the coordinates of a point on  $S$ , and so  $z = f(x, y)$ . Hence, at the expense of making the integral look even fiercer than it already does in Equation (II-10), we can eliminate the apparent  $z$ -dependence of the integrand and write

$$\iint_R \frac{G[x, y, f(x, y)]}{\hat{\mathbf{n}}[x, y, f(x, y)] \cdot \mathbf{k}} dx dy. \quad (\text{II-11})$$

The faint of heart can take courage; in most cases this integrand reduces quickly to something much simpler and pleasanter looking—a fact we will demonstrate by example below. At this point we introduce the expression for the unit normal vector [Equation (II-4)]. We find

$$\hat{\mathbf{n}} \cdot \mathbf{k} = \frac{1}{\sqrt{1 + (\partial f / \partial x)^2 + (\partial f / \partial y)^2}},$$

and so Equation (II-11) becomes

$$\begin{aligned} \iint_S G(x, y, z) dS &= \iint_R G[x, y, f(x, y)] \\ &\quad \cdot \sqrt{1 + \left(\frac{\partial f}{\partial x}\right)^2 + \left(\frac{\partial f}{\partial y}\right)^2} dx dy. \quad (\text{II-12}) \end{aligned}$$

Thus, the surface integral of  $G(x, y, z)$  over the surface  $S$  has been expressed as a double integral of a messy-looking function over the region  $R$ , the projection of  $S$  in the  $xy$ -plane. As we remarked above, in practice the integral is usually much less ghastly than it

appears written out in Equations (II-11) or (II-12). You will see this in the examples we now give.

Let's first compute the surface integral

$$\iint_S (x + z) \, dS$$

where  $S$  is the portion of the plane  $x + y + z = 1$  in the first octant shown in Figure II-15(a). The projection of  $S$  on the  $xy$ -plane



is the triangle  $R$  shown in the figure. The equation of  $S$  can be written

$$z = f(x, y) = 1 - x - y$$

from which we get

$$\frac{\partial f}{\partial x} = \frac{\partial f}{\partial y} = -1,$$

so that

$$\sqrt{1 + \left(\frac{\partial f}{\partial x}\right)^2 + \left(\frac{\partial f}{\partial y}\right)^2} = \sqrt{3}.$$

Hence

$$\iint_S (x + z) \, dS = \sqrt{3} \iint_R (x + z) \, dx \, dy =$$

$$25 \quad \sqrt{3} \iint_R (x + 1 - x - y) \, dx \, dy = \sqrt{3} \iint_R (1 - y) \, dx \, dy,$$

where we have used  $z = 1 - x - y$ . This is a simple double integral with value  $1/\sqrt{3}$ , as you should be able to verify.

As a second example let's compute the surface integral

$$\iint_S z^2 dS,$$

where  $S$  is the octant of the sphere of radius 1 centered at the origin as shown in Figure II-15(b). The projection of  $S$  on the



$xy$ -plane (that is,  $R$ ) is the area enclosed by the quarter circle. The equation of  $S$  is  $x^2 + y^2 + z^2 = 1$ , or

$$z = f(x, y) = +\sqrt{1 - x^2 - y^2}.$$

It follows then that

$$\frac{\partial f}{\partial x} = -\frac{x}{z} \quad \text{and} \quad \frac{\partial f}{\partial y} = -\frac{y}{z},$$

so that

$$\begin{aligned} \sqrt{1 + \left(\frac{\partial f}{\partial x}\right)^2 + \left(\frac{\partial f}{\partial y}\right)^2} &= \sqrt{1 + \frac{x^2}{z^2} + \frac{y^2}{z^2}} \\ &= \frac{1}{z} \sqrt{x^2 + y^2 + z^2} = \frac{1}{z}, \end{aligned}$$

where we have used  $x^2 + y^2 + z^2 = 1$ . Hence,

$$\iint_S z^2 dS = \iint_R z^2 \frac{1}{z} dx dy = \iint_R z dx dy.$$

Substituting for  $z$  in terms of  $x$  and  $y$ , we get

$$\iint_S z^2 dS = \iint_R \sqrt{1 - x^2 - y^2} dx dy.$$

This is an ordinary double integral, and you should verify that its value is  $\pi/6$ . [Suggestion: Convert to polar coordinates:  $x = r \cos \theta$ , and  $y = r \sin \theta$ . The integration is then trivial.]

It should be emphasized that the foregoing discussion was based on the assumption that the surface  $S$  is described by an equation of the form  $z = f(x, y)$ ; in such a situation a surface integral is converted into a double integral over a region in the  $xy$ -plane. But it may happen that a given surface is more conveniently described by an equation of the form  $y = g(x, z)$  as in Figure II-16(a). If this is so, then

$$\begin{aligned} \iint_S G(x, y, z) dS \\ = \iint_R G[x, g(x, z), z] \sqrt{1 + \left(\frac{\partial g}{\partial x}\right)^2 + \left(\frac{\partial g}{\partial z}\right)^2} dx dz, \end{aligned}$$



where  $R$  is a region in the  $xz$ -plane. Similarly, if we have a surface described by  $x = h(y, z)$ , as in Figure II-16(b), then we use

$$\iint_S G(x, y, z) dS$$

$$= \iint_R G[h(y, z), y, z] \sqrt{1 + \left(\frac{\partial h}{\partial y}\right)^2 + \left(\frac{\partial h}{\partial z}\right)^2} dy dz,$$



where  $R$  in this case is a region in the  $yz$ -plane. Finally, a surface may have several parts, and it may then be convenient to project different parts on different coordinate planes.

To evaluate surface integrals of the form (II-5), that is,

$$\iint_S \mathbf{F} \cdot \hat{\mathbf{n}} \, dS,$$

we merely replace  $G$  by  $\mathbf{F} \cdot \hat{\mathbf{n}}$  in Equation (II-12) to get

$$\iint_S \mathbf{F} \cdot \hat{\mathbf{n}} \, dS = \iint_R \mathbf{F} \cdot \hat{\mathbf{n}} \sqrt{1 + \left(\frac{\partial f}{\partial x}\right)^2 + \left(\frac{\partial f}{\partial y}\right)^2} \, dx \, dy.$$

If we now use Equation (II-4) to write this out in detail, we find that the square root factor cancels and we get

$$\begin{aligned} \iint_S \mathbf{F} \cdot \hat{\mathbf{n}} \, dS &= \iint_R \left\{ -F_x[x, y, f(x, y)] \frac{\partial f}{\partial x} \right. \\ &\quad \left. - F_y[x, y, f(x, y)] \frac{\partial f}{\partial y} + F_z[x, y, f(x, y)] \right\} dx \, dy. \quad (\text{II-13}) \end{aligned}$$

We leave it to the reader to write down the analogous formulas when the surface  $S$  is given by  $y = g(x, z)$  or  $x = h(y, z)$ , which must be projected onto regions in the  $xz$ - and  $yz$ -planes, respectively.

This last equation [Equation (II-13)] is enough to make strong men weep, but, as before, in most calculations it quickly reduces to something quite tame. For example, suppose we wish to calculate  $\iint_S \mathbf{F} \cdot \hat{\mathbf{n}} \, dS$ , where  $\mathbf{F}(x, y, z) = iz - \mathbf{j}y + \mathbf{k}x$  and  $S$  is the portion of the plane



bounded by the coordinate planes, that is, the triangle reclining gracefully in Figure II-17(a). The normal vector  $\hat{\mathbf{n}}$  is chosen so that it points away from the origin as shown in Figure II-17(a), and we'll project  $S$  onto the  $xy$ -plane. We have

$$z = f(x, y) = 1 - \frac{x}{2} - y,$$

and so

$$\frac{\partial f}{\partial x} = -\frac{1}{2}, \quad \frac{\partial f}{\partial y} = -1.$$

We also have

$$F_x = z = 1 - \frac{x}{2} - y, \quad F_y = -y, \quad F_z = x.$$

Hence

$$\begin{aligned} \iint_S \mathbf{F} \cdot \hat{\mathbf{n}} \, dS &= \iint_R \left\{ \left[ -\left( 1 - \frac{x}{2} - y \right) \right] \left( -\frac{1}{2} \right) + y(-1) + x \right\} dx \, dy \\ &= \iint_R \left( \frac{3x}{4} - \frac{3y}{2} + \frac{1}{2} \right) dx \, dy \end{aligned}$$

The region  $R$  over which the integral must be taken is shown in Figure II-17(b). The problem has thus been reduced to the compu-



tation of a rather simple double integral, and you should carry out the integration yourself (the answer is  $\frac{1}{2}$ ).

As a second example, suppose

$$\mathbf{F}(x, y, z) = ixz + kz^2$$

For  $S$  let's take the octant of the spherical surface shown in Figure II-15. Then  $z = f(x, y) = \sqrt{1 - x^2 - y^2}$ , and we have already shown (see page 25) that

$$\frac{\partial f}{\partial x} = -\frac{x}{z} \quad \text{and} \quad \frac{\partial f}{\partial y} = -\frac{y}{z}$$

Thus

$$\begin{aligned} \iint_S \mathbf{F} \cdot \hat{\mathbf{n}} \, dS &= \iint_R \left[ -xz \left( -\frac{x}{z} \right) + z^2 \right] dx \, dy = \iint_R (x^2 + 1 - x^2 - y^2) dx \, dy \\ &= \iint_R (1 - y^2) dx \, dy = \iint_R dx \, dy - \iint_R y^2 dx \, dy \end{aligned}$$

where  $R$ , we recall, is the quarter-circle shown in Figure II-15. The first integral in the last equality above is just the area of the quarter-circle of radius 1, and is therefore equal to  $\pi/4$ . The second integral can be done by introducing polar coordinates. We get

$$\begin{aligned} \iint_R y^2 dx \, dy &= \int_0^{\pi/2} \int_0^1 r^2 \sin^2 \theta r \, dr \, d\theta \\ &= \int_0^{\pi/2} \sin^2 \theta \, d\theta \int_0^1 r^3 \, dr \end{aligned}$$

Both the  $r$  and  $\theta$  integrals here are elementary, and you should have no trouble showing that this expression is equal to  $\pi/16$ . Thus  $\iint_S \mathbf{F} \cdot \hat{\mathbf{n}} dS = \pi/4 - \pi/16 = 3\pi/16$ .

## Flux

An integral of the type

$$\iint_S \mathbf{F}(x, y, z) \cdot \hat{\mathbf{n}} dS \quad (\text{II-14})$$

is sometimes called the “flux of  $\mathbf{F}$ .” Thus Gauss’ law [Equation (II-1)] states that the flux of the electrostatic field over some closed surface is the enclosed charge divided by  $\epsilon_0$ .

It is useful in obtaining a geometrical feeling for some aspects of vector calculus to understand the significance of the word *flux* (Latin for “flow”) used in this context. For this purpose let us consider a fluid of density  $\rho$  moving with velocity  $\mathbf{v}$ . We ask for the total mass of fluid that crosses an area  $\Delta S$  perpendicular to the direction of flow in a time  $\Delta t$ . Clearly, all the fluid in the cylinder of length  $v \Delta t$  with the patch  $\Delta S$  as base will cross  $\Delta S$  in the interval  $\Delta t$  (Figure II-18). The volume of this cylinder is  $v \Delta t \Delta S$ , and it



contains a total mass  $\rho v \Delta t \Delta S$ . Dividing out the  $\Delta t$  will give the rate of flow. Thus,

$$\left( \begin{array}{c} \text{Rate of flow} \\ \text{through } \Delta S \end{array} \right) = \rho v \Delta S.$$

Now let us consider a somewhat more complicated case in which the area  $\Delta S$  is not perpendicular to the direction of flow (Figure II-19). The volume containing the material that will flow



through  $\Delta S$  in time  $\Delta t$  is now just the volume of the little skewed cylinder shown in the diagram. The volume is  $v \Delta t \Delta S \cos \theta$ , where  $\theta$  is the angle between the velocity vector  $\mathbf{v}$  and  $\hat{\mathbf{n}}$ , the unit vector normal to  $\Delta S$  and pointing outward from the skewed cylinder. But  $v \cos \theta = \mathbf{v} \cdot \hat{\mathbf{n}}$ . So, multiplying by  $\rho$  and dividing by  $\Delta t$ , we get

$$\left( \begin{array}{c} \text{Rate of flow} \\ \text{through } \Delta S \end{array} \right) = \rho \mathbf{v} \cdot \hat{\mathbf{n}} \Delta S.$$

Finally, consider a surface  $S$  in some region of space containing flowing matter (Figure II-20). Approximate the surface by a poly-



hedron. By the above argument, the rate at which matter flows through the  $l$ th face of this polyhedron is approximately

$$\rho(x_l, y_l, z_l) \mathbf{v}(x_l, y_l, z_l) \cdot \hat{\mathbf{n}}_l \Delta S_l.$$

Here, of course,  $(x_l, y_l, z_l)$  are the coordinates of the point on the  $l$ th face at which it is tangent to  $S$ , and  $\hat{\mathbf{n}}_l$  is the unit vector normal to the  $l$ th face. Summing over all the faces and taking the limit, we get

$$\left( \begin{array}{c} \text{Rate of flow} \\ \text{through } S \end{array} \right) = \iint_S \rho(x, y, z) \mathbf{v}(x, y, z) \cdot \hat{\mathbf{n}} \, dS.$$

If  $S$  happens to be a closed surface and there is a net rate of flow *out* of the volume it encloses, then you can convince yourself that

this integral will be positive, and if there is a net rate of flow *in*, the integral will be negative.

If in this last equation we put

$$\mathbf{F}(x, y, z) = \rho(x, y, z)\mathbf{v}(x, y, z),$$

the integral is seen to be formally identical with that in Equation (II-14). For this reason any integral of the form (II-14) is called “the flux of  $\mathbf{F}$  over the surface  $S$ ,” even when the function  $\mathbf{F}$  is *not* the product of a density and a velocity! The reason for stressing this point about flux is that, misnomer though it may be, it nonetheless gives a good geometric or physical picture of Gauss’ law: The electric field “flows” out of a surface enclosing charge, and the “amount” of this “flow” is proportional to the net charge enclosed. *Warning:* This is not to be taken literally; the electric field is not flowing in the sense in which fluid flows. It is merely picturesque language intended to aid us in understanding the physics in Gauss’ law.

## *Using Gauss’ Law to Find the Field*

Having rejected the two expressions for  $\mathbf{E}$  [Equations (I-4) and (I-7)], we find that the only candidate left for providing us with a good general method for calculating the field is Gauss’ law. At first glance it does not appear to be a very likely candidate because, unlike Equations (I-4) and (I-7), it is not an *explicit* expression for  $\mathbf{E}$ . That is, it does not say “ $\mathbf{E}$  equals something.” Rather, it says “The flux of  $\mathbf{E}$  (the surface integral of the normal component of  $\mathbf{E}$ ) equals something.” Thus, to use Gauss’ law, we must “disentangle”  $\mathbf{E}$  from its surroundings. Despite this, there are situations in which Gauss’ law can be used to find the field, as an example will now show.

Consider a point charge  $q$  placed at the origin of a coordinate system. Symmetry considerations tell us two things about its electric field: (1) It must be in the radial direction (that is, it must point directly toward, or directly away from, the origin), and (2) it must have the same magnitude at all points on the surface of a sphere centered at the origin. Stating this in symbols, we have  $\mathbf{E} = \hat{\mathbf{e}}_r E(r)$ , where  $\hat{\mathbf{e}}_r = \mathbf{r}/r$  is a unit vector in the radial direction. Thus, Gauss’ law becomes

$$\iint_S E(r) \hat{\mathbf{e}}_r \cdot \hat{\mathbf{n}} dS = q/\epsilon_0.$$

If, for the surface  $S$ , we now choose a spherical shell of radius  $r$  centered at the origin, a little thought will convince you that  $\hat{\mathbf{n}} = \hat{\mathbf{e}}_r$ , so that  $\hat{\mathbf{n}} \cdot \hat{\mathbf{e}}_r = 1$  and we get

$$\iint_S E(r) dS = q/\epsilon_0.$$

This integral is trivial to perform if we recognize that  $r$  is a constant over the spherical surface  $S$ . This means that  $E(r)$  is also a constant on  $S$  and we get<sup>4</sup>

$$\iint_S E(r) dS = E(r) \iint_S dS = 4\pi r^2 E(r) = q/\epsilon_0,$$

whence

$$E(r) = \frac{1}{4\pi\epsilon_0} \frac{q}{r^2}$$

and

$$\mathbf{E}(\mathbf{r}) = \hat{\mathbf{e}}_r E(r) = \frac{\hat{\mathbf{e}}_r}{4\pi\epsilon_0} \frac{q}{r^2},$$

in agreement with Equation (I-2).

We can see from this example how heavily we depend on symmetry when using Gauss' law to obtain the field. In fact, to use Gauss' law in the form given in Equation (II-1) requires even more symmetry and simplicity than Equations (I-4) and (I-7). The blunt truth is that this form of the law yields the electric field in a grand total of three situations (and combinations thereof): (1) a spherically symmetric distribution of charge (of which the point charge considered above is a special case), (2) an infinitely long cylindrically symmetric distribution (including the case of an infinitely long uniformly distributed line of charge), and (3) an infinite slab of charge (including as a special case an infinite uniformly charged plane).<sup>5</sup> The real value of Equation (II-1) is that it can be twisted and beaten into a more useful form.

<sup>4</sup> Shortcuts like this often make it possible to evaluate surface integrals without using all the paraphernalia we discussed above. Further examples are given in Problem II-10.

<sup>5</sup> Examples of these are given in Problems II-11, II-12, and II-13.

What is it about Equation (II-1) that makes it difficult to find  $\mathbf{E}$ ? To answer this question, suppose we are doing a numerical calculation on a computer and wish to evaluate  $\iint_S \mathbf{E} \cdot \hat{\mathbf{n}} dS$ . The standard procedure for dealing with integrals numerically is to approximate them as sums, a rather obvious thing to do since an integral, after all, is the *limit* of a sum. Thus, suppose we divide the surface  $S$  into, say, 10 patches. We then have as an approximation to Equation (II-1)

$$\sum_{i=1}^{10} \mathbf{E}_i \cdot \hat{\mathbf{n}}_i \Delta S_i \simeq q/\epsilon_0,$$

where  $\mathbf{E}_i$  is the value of  $\mathbf{E}$ , and  $\hat{\mathbf{n}}_i$  is the unit normal, somewhere on the  $i$ th patch. There is little or no hope of finding  $\mathbf{E}$  from this: it is one equation in the 10 unknowns  $\mathbf{E}_1, \mathbf{E}_2, \dots, \mathbf{E}_{10}$ . Furthermore, it is probably not very accurate. To improve the accuracy, we might make 100 subdivisions rather than just 10 to get

$$\sum_{i=1}^{100} \mathbf{E}_i \cdot \hat{\mathbf{n}}_i \Delta S_i \simeq q/\epsilon_0.$$

*Much* more accurate! And much more hopeless too, because this is one equation in 100 unknowns. Even more accurate (and more hopeless) is

$$\iint_S \mathbf{E} \cdot \hat{\mathbf{n}} dS = q/\epsilon_0,$$

which is one equation in *infinitely many* unknowns. These unknowns are, of course, the values of  $\mathbf{E} \cdot \hat{\mathbf{n}}$  at every one of the infinitely many points of the surface  $S$ .<sup>6</sup>

We have now isolated the trouble with Equation (II-1): it involves an entire surface and therefore the value of  $\mathbf{E} \cdot \hat{\mathbf{n}}$  at infinitely many points. If, somehow, we could deal with the “flux at a single point” (whatever *that* may mean!) rather than the flux through a surface, perhaps then Gauss’ law might yield something tractable. How might we arrange this? For simplicity let us surround some point  $P$  by a set of concentric spherical shells  $S_1, S_2, S_3$ , and so on (Figure II-21), and calculate the flux  $\Phi_1, \Phi_2, \Phi_3$ ,

<sup>6</sup> The reason Gauss’ law yields the expression for the field of a point charge examined above is that symmetry in that case shows that the infinitely many unknowns are all equal. This turns Gauss’ law into one equation in *one* unknown.



and so on, through each shell. We might then attempt to define the “flux at the point  $P$ ” as the limiting value approached by the sequence of fluxes calculated this way over smaller and smaller shells centered at  $P$ .

This sounds good; it has a heartening “mathematical” ring to it. Unfortunately, it does not work because (assuming the charge density is finite everywhere) the sequence of fluxes, calculated as described above, approaches zero for *any* point  $P$ . This is fairly obvious since it is merely the statement that the flux through a surface tends to zero as the surface shrinks to a point. Since our objective was to find a way to determine the flux at a point, and thereby learn something about the field at that point, and since we get zero at *any* point no matter what the field there may be, we have obviously not obtained what we want.

It is useful to give a physicist’s rough-and-ready proof of the fact that the flux goes to zero as the surface shrinks down to a point, for even though this fact may be obvious, the proof will suggest how to pull this chestnut out of the fire. For this purpose we note that if  $\bar{\rho}_{\Delta V}$  denotes the average density of electric charge [Equation I-5] in some region of volume  $\Delta V$ , then the total charge in  $\Delta V$  is  $\bar{\rho}_{\Delta V} \Delta V$ . Thus Gauss’ law [Equation (II-1)] may be written

$$\iint_S \mathbf{E} \cdot \hat{\mathbf{n}} \, dS = \bar{\rho}_{\Delta V} \Delta V / \epsilon_0, \quad (\text{II-15})$$

where, as indicated in Figure II-22, the surface integral is taken over the surface  $S$  that encloses the volume  $\Delta V$ . From this expression [Equation (II-15)] we can see the validity of our assertion: As  $S \rightarrow 0$ , the enclosed volume  $\Delta V$  must, of course, also approach



zero. Thus, the flux also tends to zero and the assertion is proved.<sup>7</sup> Not only have we given a proof, but (and this is the point) we can now isolate a quantity that does *not* vanish as  $S \rightarrow 0$ . Dividing Equation (II-15) by  $\Delta V$ , we get

$$\frac{1}{\Delta V} \iint_S \mathbf{E} \cdot \hat{\mathbf{n}} \, dS = \bar{\rho}_{\Delta V}/\epsilon_0.$$

This expression, awkward and unappealing though it may be, is nonetheless close to what we are after, even though it still involves an integral of  $\mathbf{E}$  over an entire surface. For if we *now* take the limit as  $S$  shrinks to zero about some point in  $\Delta V$  whose coordinates are  $(x, y, z)$ , then, as we see from Equation (I-6), the average density  $\bar{\rho}_{\Delta V}$  approaches  $\rho(x, y, z)$ , the density at  $(x, y, z)$ , and we get

$$\lim_{\substack{\Delta V \rightarrow 0 \\ \text{about } (x, y, z)}} \frac{1}{\Delta V} \iint_S \mathbf{E} \cdot \hat{\mathbf{n}} \, dS = \rho(x, y, z)/\epsilon_0. \quad (\text{II-16})$$

This expression is admittedly downright hideous, and whether it will be of any practical use whatever depends on our being able to pound the left-hand side into a form that looks and acts at least half-civilized. We turn to this task now.

## *The Divergence*

Let us consider the surface integral of some arbitrary vector function  $\mathbf{F}(x, y, z)$ :

$$\iint_S \mathbf{F} \cdot \hat{\mathbf{n}} \, dS.$$

<sup>7</sup> This line of reasoning and the conclusion must be altered if the system contains point charges.

We shall be interested in the ratio of this integral to the volume enclosed by the surface  $S$  as the volume shrinks to zero about some point, for that is exactly the type of quantity that appears in Equation (II-16). This limit is important enough to warrant a special name and notation. It is called the *divergence of  $\mathbf{F}$*  and is designated  $\text{div } \mathbf{F}$ . Thus,

$$\text{div } \mathbf{F} \equiv \lim_{\substack{\Delta V \rightarrow 0 \\ \text{about } (x,y,z)}} \frac{1}{\Delta V} \iint_S \mathbf{F} \cdot \hat{\mathbf{n}} \, dS. \quad (\text{II-17})$$

This quantity is clearly a scalar. Furthermore, it will, in general, have different values at different points  $(x, y, z)$ . Thus the divergence of a vector function is a *scalar function* of position.

Equation (II-16) can now be written

$$\text{div } \mathbf{E} = \rho/\epsilon_0. \quad (\text{II-18})$$

At this stage, however, our fancy new notation has only a cosmetic value, helping to beautify an ugly equation. Whether it has any practical value as well is the matter taken up in the following discussion in which we actually calculate the limit of the ratio of flux to enclosed volume and find that it can be expressed reasonably simply in terms of certain partial derivatives. Before turning to this calculation, however, it's worth mentioning that if we take our new terminology literally, we can interpret Equation (II-18) to mean that the field "diverges" from a point, and how much it diverges, so to speak, depends on how much charge there is at that point as represented by the density there.

Our next order of business is to find the reasonably simple expression for the divergence of a vector function promised above. Thus, consider a small rectangular parallelepiped<sup>8</sup> with edges of length  $\Delta x$ ,  $\Delta y$ , and  $\Delta z$  parallel to the coordinate axes (Figure II-23). Let the point at the center of the little cuboid have coordinates  $(x, y, z)$ . We calculate the surface integral of  $\mathbf{F}$  over the surface of the cuboid by regarding the integral as a sum of six terms, one for each cuboid face. We begin by considering the face marked  $S_1$  in the figure. We want

$$\iint_{S_1} \mathbf{F} \cdot \hat{\mathbf{n}} \, dS.$$

<sup>8</sup> Henceforth we'll refer to this as a "cuboid," a made-up term that takes less time and space than the sesquipedalian "rectangular parallelepiped."



Now it is clear the unit vector normal to this face and pointing outward from the enclosed volume is  $\mathbf{i}$ . Thus, since  $\mathbf{F} \cdot \mathbf{i} = F_x$ , the preceding integral is

$$\iint_{S_1} F_x(x, y, z) dS.$$

By assumption the cuboid is small (eventually we shall take the limit as it shrinks to zero). We can therefore calculate this integral approximately as  $F_x$  evaluated at the center of the face  $S_1$  multiplied by the area of the face.<sup>9</sup> The coordinates of the center of  $S_1$  are  $(x + \Delta x/2, y, z)$ . Thus,

$$\iint_{S_1} F_x(x, y, z) dS \approx F_x\left(x + \frac{\Delta x}{2}, y, z\right) \Delta y \Delta z. \quad (\text{II-19})$$

<sup>9</sup> The rationale behind this is as follows: There is a mean value theorem, which tells us that the integral of  $F_x$  over  $S_1$  is equal to the area of  $S_1$  multiplied by the function evaluated *somewhere* on  $S_1$ . Since  $S_1$  is small, the point where we *should* evaluate  $F_x$  and the point where we *do* evaluate it (that is, the center) must be close together, and  $F_x$  must have nearly the same value at the two points. Hence what our procedure gives us is a good approximation to the value of the integral. Furthermore, as the cuboid shrinks to zero, the two points get closer and closer so that in the limit our result [Equation (II-22)] will be exact.

The same kind of reasoning applied to the opposite face  $S_2$  [whose outward normal is  $-\mathbf{i}$  and whose center is at  $(x - \Delta x/2, y, z)$ ] leads to

$$\begin{aligned} \iint_{S_2} \mathbf{F} \cdot \hat{\mathbf{n}} \, dS &= - \iint_{S_2} F_x \, dS \\ &\simeq -F_x \left( x - \frac{\Delta x}{2}, y, z \right) \Delta y \Delta z. \quad (\text{II-20}) \end{aligned}$$

Adding together the contributions of these two faces [Equations (II-19) and (II-20)], we get

$$\begin{aligned} \iint_{S_1 + S_2} \mathbf{F} \cdot \hat{\mathbf{n}} \, dS &= \left[ F_x \left( x + \frac{\Delta x}{2}, y, z \right) - F_x \left( x - \frac{\Delta x}{2}, y, z \right) \right] \Delta y \Delta z \\ &= \frac{F_x \left( x + \frac{\Delta x}{2}, y, z \right) - F_x \left( x - \frac{\Delta x}{2}, y, z \right)}{\Delta x} \Delta x \Delta y \Delta z. \end{aligned}$$

Recognizing that  $\Delta x \Delta y \Delta z = \Delta V$ , the volume of the cuboid, we have

$$\begin{aligned} \frac{1}{\Delta V} \iint_{S_1 + S_2} \mathbf{F} \cdot \hat{\mathbf{n}} \, dS &\simeq \frac{F_x \left( x + \frac{\Delta x}{2}, y, z \right) - F_x \left( x - \frac{\Delta x}{2}, y, z \right)}{\Delta x}. \quad (\text{II-21}) \end{aligned}$$

We now must take the limit of this as  $\Delta V$  approaches zero.<sup>10</sup> But, of course, as  $\Delta V$  goes to zero, so do each of the sides of the cuboid. Thus, on the right-hand side of Equation (II-21) we can write  $\lim_{\Delta x \rightarrow 0}$  in place of  $\lim_{\Delta V \rightarrow 0}$ , and we find

$$\begin{aligned} \lim_{\Delta V \rightarrow 0} \frac{1}{\Delta V} \iint_{S_1 + S_2} \mathbf{F} \cdot \hat{\mathbf{n}} \, dS &= \lim_{\Delta x \rightarrow 0} \frac{F_x \left( x + \frac{\Delta x}{2}, y, z \right) - F_x \left( x - \frac{\Delta x}{2}, y, z \right)}{\Delta x} = \frac{\partial F_x}{\partial x} \end{aligned}$$

<sup>10</sup> Note that we have postponed calculating the contributions from the other four faces of the cuboid.

evaluated at  $(x, y, z)$ . This last equality follows from the definition of the partial derivative. It should come as no surprise that the other two pairs of faces of the cuboid contribute  $\partial F_y / \partial y$  and  $\partial F_z / \partial z$ . Thus,

$$\lim_{\Delta V \rightarrow 0} \frac{1}{\Delta V} \iint_S \mathbf{F} \cdot \hat{\mathbf{n}} \, dS = \frac{\partial F_x}{\partial x} + \frac{\partial F_y}{\partial y} + \frac{\partial F_z}{\partial z}.$$

The limit on the left-hand side of this last equation, as we have already remarked, is the divergence of  $\mathbf{F}$  [Equation (II-17)]. Thus we have just demonstrated that

$$\operatorname{div} \mathbf{F} = \frac{\partial F_x}{\partial x} + \frac{\partial F_y}{\partial y} + \frac{\partial F_z}{\partial z}. \quad (\text{II-22})$$

It can be shown that this result is independent of the shape of the volume used to obtain it (see Problem II-17).

Using Equation (II-22) to find the divergence of a vector function is a straightforward matter, but we'll give an example just for the record. Consider the function

$$\mathbf{F}(x, y, z) = \mathbf{i}x^2 + \mathbf{j}xy + \mathbf{k}yz.$$

We have

$$\frac{\partial F_x}{\partial x} = 2x, \quad \frac{\partial F_y}{\partial y} = x, \quad \text{and} \quad \frac{\partial F_z}{\partial z} = y.$$

Thus,

$$\operatorname{div} \mathbf{F} = 2x + x + y = 3x + y.$$

Returning now to the electrostatic field, we combine Equations (II-18) and (II-22) to get

$$\frac{\partial E_x}{\partial x} + \frac{\partial E_y}{\partial y} + \frac{\partial E_z}{\partial z} = \rho/\epsilon_0. \quad (\text{II-23})$$

This equation, which is much more general than our derivation of it suggests, is one of Maxwell's equations and is completely equivalent to Gauss' law [Equation (II-1)]. It is sometimes called the "differential form" of Gauss' law.

We have now arrived at our goal (almost!), for we have related a property of the electrostatic field at a point (that is, its divergence) to a known quantity (the charge density) at that point. In all fairness it

should be said that Equation (II-23) can in a sense be regarded as a single (differential) equation in *three* unknowns ( $E_x$ ,  $E_y$ ,  $E_z$ ) and for this reason is not often used in this form to find the field. It turns out, however, that the three components of  $\mathbf{E}$  can be related to each other very elegantly; when we develop that relationship, we shall return to this question of finding a convenient means of calculating  $\mathbf{E}$ .

## *The Divergence in Cylindrical and Spherical Coordinates*

One often sees Equation (II-22) given as the definition of the divergence of the vector function  $\mathbf{F}$ . While this is certainly acceptable, we much prefer to define the divergence as the limit of flux to volume as stated in Equation (II-16). Equation (II-22) is then merely the form the divergence takes in Cartesian coordinates. In other coordinate systems it looks quite different. For example, in cylindrical coordinates the function  $\mathbf{F}$  has three components, which you will not be shocked to learn are designated  $F_r$ ,  $F_\theta$ , and  $F_z$  [see Figure II-24(a)]. To obtain the divergence of  $\mathbf{F}$  in cylind-



drical coordinates, we consider the “cylindrical cuboid” shown in Figure II-24(b) with volume  $\Delta V = r \Delta r \Delta \theta \Delta z$  and center at the point  $(r, \theta, z)$ .<sup>11</sup> The flux of  $\mathbf{F}$  through the face marked 1 is

$$\begin{aligned} \iint_{S_1} \mathbf{F} \cdot \hat{\mathbf{n}} \, dS &= \iint_{S_1} F_r \, dS \\ &\simeq F_r \left( r + \frac{\Delta r}{2}, \theta, z \right) \left( r + \frac{\Delta r}{2} \right) \Delta \theta \Delta z, \end{aligned}$$

<sup>11</sup> Note that in the Cartesian case (Figure II-23) each face of the cuboid is given by an equation of the form  $x = \text{constant}$ ,  $y = \text{constant}$ , or  $z = \text{constant}$ . In the same way each face of the surface in Figure II-24(b) is given by an equation of the form  $r = \text{constant}$ ,  $\theta = \text{constant}$ , or  $z = \text{constant}$ .



while through the face marked 2 it is

$$\begin{aligned} \iint_{S_2} \mathbf{F} \cdot \hat{\mathbf{n}} \, dS &= - \iint_{S_2} F_r \, dS \\ &\simeq -F_r \left( r - \frac{\Delta r}{2}, \theta, z \right) \left( r - \frac{\Delta r}{2} \right) \Delta \theta \Delta z. \end{aligned}$$

Adding these two results and dividing by the volume  $\Delta V$  of the cuboid, we find

$$\begin{aligned} \frac{1}{\Delta V} \iint_{S_1+S_2} \mathbf{F} \cdot \hat{\mathbf{n}} \, dS \\ &\simeq \frac{1}{r \Delta r} \left[ \left( r + \frac{\Delta r}{2} \right) F_r \left( r + \frac{\Delta r}{2}, \theta, z \right) \right. \\ &\quad \left. - \left( r - \frac{\Delta r}{2} \right) F_r \left( r - \frac{\Delta r}{2}, \theta, z \right) \right], \end{aligned}$$

which in the limit as  $\Delta r$  (and therefore  $\Delta V$ ) approaches zero becomes

$$\frac{1}{r} \frac{\partial}{\partial r} (r F_r).$$

Arguing in an analogous way for the other four faces (see Problem II-18), we arrive finally at the expression for the divergence in cylindrical coordinates:

$$\operatorname{div} \mathbf{F} = \frac{1}{r} \frac{\partial}{\partial r} (r F_r) + \frac{1}{r} \frac{\partial F_\theta}{\partial \theta} + \frac{\partial F_z}{\partial z}. \quad (\text{II-24})$$



In spherical coordinates where the components of  $\mathbf{F}$  are  $F_r$ ,  $F_\theta$ , and  $F_\phi$  (see Figure II-25), similar reasoning (see Problem II-21) leads to the expression

$$\operatorname{div} \mathbf{F} = \frac{1}{r^2} \frac{\partial}{\partial r} (r^2 F_r) + \frac{1}{r \sin \phi} \frac{\partial}{\partial \phi} (\sin \phi F_\phi) + \frac{1}{r \sin \phi} \frac{\partial F_\theta}{\partial \theta}. \quad (\text{II-25})$$

## The Del Notation

There is a special notation in terms of which the divergence may be written. There would be little or no reason for introducing it if it served only to provide another way of writing “div,” but as we shall soon see, it has considerable usefulness in vector calculus.

Let us define a quantity designated  $\nabla$  (read “del”) by the following rather peculiar-looking equation:

$$\nabla = \mathbf{i} \frac{\partial}{\partial x} + \mathbf{j} \frac{\partial}{\partial y} + \mathbf{k} \frac{\partial}{\partial z}.$$

If we take the dot product of  $\nabla$  and some vector function  $\mathbf{F} = \mathbf{i}F_x + \mathbf{j}F_y + \mathbf{k}F_z$ , we get

$$\begin{aligned} \nabla \cdot \mathbf{F} &= \left( \mathbf{i} \frac{\partial}{\partial x} + \mathbf{j} \frac{\partial}{\partial y} + \mathbf{k} \frac{\partial}{\partial z} \right) \cdot (\mathbf{i}F_x + \mathbf{j}F_y + \mathbf{k}F_z) \\ &= \frac{\partial}{\partial x} F_x + \frac{\partial}{\partial y} F_y + \frac{\partial}{\partial z} F_z. \end{aligned}$$

Now we interpret the “product” of  $\partial/\partial x$  and  $F_x$  as a partial derivative; that is,

$$\frac{\partial}{\partial x} F_x \equiv \frac{\partial F_x}{\partial x}.$$

### The Divergence Theorem

There are similar equations for the two other “products”  $(\partial/\partial y)F_y$  and  $(\partial/\partial z)F_z$ . With this convention we recognize  $\nabla \cdot \mathbf{F}$  (“del dot  $\mathbf{F}$ ”) as the same as  $\text{div } \mathbf{F}$ , and henceforth, to conform with modern notational practice, we shall always use  $\nabla \cdot \mathbf{F}$  to indicate the divergence. Thus, Equations (II–18) and (II–23) will be written


$$\nabla \cdot \mathbf{E} = \rho/\epsilon_0.$$

Mathematicians call a symbol like  $\nabla$  an operator. When we “operate” with  $\nabla$  by dotting it into a vector function, we get the divergence of that function, as we have just seen. In subsequent discussions we shall introduce three other quantities (gradient, curl, and Laplacian), all of which are operators and all of which can be written in terms of  $\nabla$ .

### The Divergence Theorem

For the remainder of this chapter we digress from the mainstream of our narrative to discuss a famous theorem that asserts a remarkable connection between surface integrals and volume integrals. Although this relation may be suggested by the work we have done in electrostatics, the theorem is a mathematical statement holding under quite general circumstances. It is independent of any physics and is applicable in many different places. It is called the divergence theorem and sometimes Gauss’ theorem (not to be confused with Gauss’ law).

We shall not give a mathematically rigorous proof of the divergence theorem; such a proof is given in many texts in advanced calculus. Instead we present here another physicist’s rough-and-ready proof. Thus, consider a closed surface  $S$ . Subdivide the volume  $V$  enclosed by  $S$  arbitrarily into  $N$  subvolumes, one of which is shown in Figure II–26 (drawn as a cube for convenience). We



begin our proof by asserting that the flux of an arbitrary vector function  $\mathbf{F}(x, y, z)$  through the surface  $S$  equals the sum of the fluxes through the surfaces of each of the subvolumes:

$$\iint_S \mathbf{F} \cdot \hat{\mathbf{n}} \, dS = \sum_{l=1}^N \iint_{S_l} \mathbf{F} \cdot \hat{\mathbf{n}} \, dS. \quad (\text{II-26})$$

Here  $S_l$  is the surface that encloses the subvolume  $\Delta V_l$ . To establish Equation (II-26), consider two adjacent subvolumes (Figure II-27). Let their common face be denoted  $S_0$ . The flux through the



subvolume marked 1 in Figure II-27 includes, of course, a contribution from  $S_0$ , which is

$$\iint_{S_0} \mathbf{F} \cdot \hat{\mathbf{n}}_1 \, dS.$$

Here  $\hat{\mathbf{n}}_1$  is a unit vector normal to the face  $S_0$ , and by our usual convention, it points outward from subvolume 1. The flux through the subvolume marked 2 also includes a contribution from  $S_0$ :

$$\iint_{S_0} \mathbf{F} \cdot \hat{\mathbf{n}}_2 \, dS.$$

The vector  $\hat{\mathbf{n}}_2$  is a unit normal that points outward from subvolume 2. Clearly  $\hat{\mathbf{n}}_1 = -\hat{\mathbf{n}}_2$ . Thus, in forming the sum in Equation (II-26), we shall include, among other things, the pair of terms

$$\begin{aligned} \iint_{S_0} \mathbf{F} \cdot \hat{\mathbf{n}}_1 \, dS + \iint_{S_0} \mathbf{F} \cdot \hat{\mathbf{n}}_2 \, dS = \\ \iint_{S_0} \mathbf{F} \cdot \hat{\mathbf{n}}_1 \, dS - \iint_{S_0} \mathbf{F} \cdot \hat{\mathbf{n}}_1 \, dS = 0. \end{aligned}$$

## The Divergence Theorem

We see that these terms cancel each other and there is no net contribution to the sum in Equation (II-26) due to the face  $S_0$ . In fact, this sort of cancellation will obviously occur for any subvolume surface that is common to two adjacent subvolumes. But *all* subvolume surfaces are common to two adjacent subvolumes except those that are part of the original (“outer”) surface  $S$ . Hence the only terms in the sum in Equation (II-26) that survive come from those subvolume surfaces that, taken together, constitute the surface  $S$ . This establishes the validity of Equation (II-26).

We now rewrite Equation (II-26) in the following curious fashion:

$$\iint_S \mathbf{F} \cdot \hat{\mathbf{n}} \, dS = \sum_{l=1}^N \left[ \frac{1}{\Delta V_l} \iint_{S_l} \mathbf{F} \cdot \hat{\mathbf{n}} \, dS \right] \Delta V_l. \quad (\text{II-27})$$

This clearly alters nothing since we have just multiplied and divided each term of the sum by  $\Delta V_l$ , the subvolume enclosed by the surface  $S_l$ . We can now imagine partitioning the original volume  $V$  into an ever larger number of smaller and smaller subvolumes. In other words, we take the limit of the sum in Equation (II-27) as the number of subdivisions tends to infinity and each  $\Delta V_l$  tends to zero. We recognize that the limit of the quantity in square brackets in Equation (II-27) is, by definition,  $(\nabla \cdot \mathbf{F})_l$ , that is, the divergence of  $\mathbf{F}$  evaluated at the point about which  $\Delta V_l$  is shrinking. Thus, for each  $\Delta V_l$  very small, Equation (II-27) becomes

$$\iint_S \mathbf{F} \cdot \hat{\mathbf{n}} \, dS \simeq \sum_{l=1}^N (\nabla \cdot \mathbf{F})_l \Delta V_l. \quad (\text{II-28})$$

Further, in the limit, this sum is, again by definition, the triple integral of  $\nabla \cdot \mathbf{F}$  over the volume enclosed by  $S$ :

$$\lim_{\substack{N \rightarrow \infty \\ \text{each } \Delta V_l \rightarrow 0}} \sum_{l=1}^N (\nabla \cdot \mathbf{F})_l \Delta V_l \equiv \iiint_V \nabla \cdot \mathbf{F} \, dV. \quad (\text{II-29})$$

Putting together Equations (II-26) through (II-29), we arrive at our result:

$$\iint_S \mathbf{F} \cdot \hat{\mathbf{n}} \, dS = \iiint_V \nabla \cdot \mathbf{F} \, dV. \quad (\text{II-30})$$

This is the divergence theorem. In words, it says that the flux of a vector function through some closed surface equals the triple inte-

gral of the divergence of that function over the volume enclosed by the surface.

The major reason the proof given above is not rigorous is that a triple integral is defined as the limit of a sum of the form

$$\sum_l g(x_l, y_l, z_l) \Delta V_l,$$

where the function  $g$  is well defined. In Equation (II-27), however, the quantity multiplying the volume element  $\Delta V_l$  in each term of the sum is not a well-defined function in this sense. That is, as  $\Delta V_l$  tends to zero the quantity in the square brackets changes; it can be identified as the divergence of  $\mathbf{F}$  only in the limit. A careful, rigorous treatment would show that Equation (II-30) is valid if  $\mathbf{F}$  (that is,  $F_x$ ,  $F_y$ , and  $F_z$ ) is continuous and differentiable, and its first derivatives are continuous in  $V$  and on  $S$ .

Now let's illustrate the divergence theorem. Since endless pages of hideous integrals will not serve our purpose, we'll use a simple example. Let

$$\mathbf{F}(x, y, z) = \mathbf{i}x + \mathbf{j}y + \mathbf{k}z$$

and choose for  $S$  the surface shown in Figure II-28, consisting of the hemispherical shell of radius 1 and the region  $R$  of the



$xy$ -plane enclosed by the unit circle. On the hemisphere we have  $\hat{\mathbf{n}} = \mathbf{i}x + \mathbf{j}y + \mathbf{k}z$ , so that  $\hat{\mathbf{n}} \cdot \mathbf{F} = x^2 + y^2 + z^2 = 1$ . Thus, on the hemisphere,

$$\iint \mathbf{F} \cdot \hat{\mathbf{n}} \, dS = \iint dS = 2\pi,$$

where the last equality follows from the fact that the integral is merely the surface area of the unit hemisphere. On the region  $R$  we have  $\hat{\mathbf{n}} = -\mathbf{k}$  so that  $\hat{\mathbf{n}} \cdot \mathbf{F} = -z$ . Hence, on  $R$ ,

$$\iint_S \mathbf{F} \cdot \hat{\mathbf{n}} \, dS = - \iint_R z \, dx \, dy = 0$$

because  $z = 0$  everywhere on  $R$ . Thus, there is no contribution to the surface integral from the circular region  $R$  and

$$\iint_S \mathbf{F} \cdot \hat{\mathbf{n}} \, dS = 2\pi.$$

Next we find by a trivial calculation that  $\nabla \cdot \mathbf{F} = 3$ . It follows then that

$$\iiint_V \nabla \cdot \mathbf{F} \, dV = 3 \iiint_V \, dV = 3 \frac{2\pi}{3} = 2\pi,$$

where we use the fact that the volume of the unit hemisphere is  $2\pi/3$ . Since the surface and volume integrals are equal, this illustrates Equation (II-30).

## Two Simple Applications of the Divergence Theorem

As one example of the use of the divergence theorem we give an alternative derivation of Equation (II-18), the analysis of which led us to the divergence theorem itself. In other words, this is how easy it would have been if we had known the divergence theorem to begin with!

We start with Gauss' law in the form

$$\iint_S \mathbf{E} \cdot \hat{\mathbf{n}} \, dS = \frac{1}{\epsilon_0} \iiint_V \rho \, dV. \quad (\text{II-31})$$

Next we apply the divergence theorem to the surface integral in the above equation to get

$$\iint_S \mathbf{E} \cdot \hat{\mathbf{n}} \, dS = \iiint_V \nabla \cdot \mathbf{E} \, dV. \quad (\text{II-32})$$

Thus, combining Equations (II-31) and (II-32), we find

$$\iiint_V \nabla \cdot \mathbf{E} \, dV = \frac{1}{\epsilon_0} \iiint_V \rho \, dV.$$

In general, if two volume integrals are equal, it is not necessarily true that their integrands are equal. It might be that the integrals are equal only over the particular volume of integration  $V$ , and by integrating over a different volume, we would wreck the equality. In the present case, however, this is not true because Gauss' law holds for any arbitrary volume  $V$ , and we cannot upset the equality by changing the volume. But this can be so only if the integrands are equal. Hence,

$$\nabla \cdot \mathbf{E} = \rho/\epsilon_0,$$

which should look familiar!

Another example of the use of the divergence theorem is the following. Suppose that in some region of space “stuff” (matter, electric charge, anything) is moving (Figure II-29). Let the den-



sity of this stuff at any point  $(x, y, z)$  and any time  $t$  be  $\rho(x, y, z, t)$  and let its velocity be  $\mathbf{v}(x, y, z, t)$ . Further, suppose this stuff is *conserved*; that is, it is neither created nor destroyed. Concentrating on some arbitrary volume  $V$  in space, we ask: What is the rate at which the amount of stuff in this volume is changing? At any time  $t$  the amount of stuff in  $V$  is

$$\iiint_V \rho(x, y, z, t) dV$$

and the rate at which it is changing is

$$\frac{d}{dt} \iiint_V \rho(x, y, z, t) dV = \iiint_V \frac{\partial \rho}{\partial t} dV.$$

(To be able to move the derivative under the integral sign this way requires that  $\partial\rho/\partial t$  be continuous.)

Next we recall from an earlier discussion that the rate at which stuff flows through a surface  $S$  is

$$\iint_S \rho \mathbf{v} \cdot \hat{\mathbf{n}} \, dS.$$

We then assert that the rate at which the amount of stuff in  $V$  is changing is equal to the rate at which it is flowing through the enclosing surface  $S$ ; in equation form this statement reads

$$\iiint_V \frac{\partial \rho}{\partial t} \, dV = - \iint_S \rho \mathbf{v} \cdot \hat{\mathbf{n}} \, dS.$$

There are two features about this equation that require discussion:

1. The negative sign must be included because the surface integral as defined is positive for a net flow *out* of the volume, but a net flow out means the amount of stuff in the volume is decreasing.
2. This equation states that the amount of stuff in  $V$  can change only as a result of stuff flowing across the boundary  $S$ . If stuff were being created or destroyed in  $V$ , terms would have to be included in the equation to reflect that fact. The absence of any such terms is thus an expression of the conservation of the stuff.

Now, finally, let us apply the divergence theorem. We find

$$\iint_S \rho \mathbf{v} \cdot \hat{\mathbf{n}} \, dS = \iiint_V \nabla \cdot (\rho \mathbf{v}) \, dV.$$

Hence,

$$\iiint_V \frac{\partial \rho}{\partial t} \, dV = - \iiint_V \nabla \cdot (\rho \mathbf{v}) \, dV.$$

Arguing as we did above that  $V$  is an arbitrary volume, we can then say

$$\frac{\partial \rho}{\partial t} = -\nabla \cdot (\rho \mathbf{v}). \quad (\text{II-33})$$

## Surface Integrals and the Divergence

Usually we define the *current density*  $\mathbf{J} = \rho \mathbf{v}$  and write Equation (II-31) as

$$\frac{\partial \rho}{\partial t} + \nabla \cdot \mathbf{J} = 0.$$

An equation of this type is referred to as a *continuity equation* and is, as we have seen, an expression of a conservation law (see Problems III-20, III-21, and IV-21). Besides playing an important role in electromagnetic theory, it is a basic equation both in hydrodynamics and diffusion theory. Finally, considerations similar to those that led to the continuity equation are involved in the analysis of heat flow.

II-1 Find a unit vector  $\hat{\mathbf{n}}$  normal to each of the following surfaces.

- (a)  $z = 2 - x - y$ .      (c)  $z = (1 - x^2)^{1/2}$ .
- (b)  $z = (x^2 + y^2)^{1/2}$ .      (d)  $z = x^2 + y^2$ .
- (e)  $z = (1 - x^2/a^2 - y^2/a^2)^{1/2}$ .

II-2 (a) Show that the unit vector normal to the plane

$$ax + by + cz = d$$

is given by

$$\hat{\mathbf{n}} = \pm(\mathbf{i}a + \mathbf{j}b + \mathbf{k}c)/(a^2 + b^2 + c^2)^{1/2}.$$

(b) Explain in geometric terms why this expression for  $\hat{\mathbf{n}}$  is independent of the constant  $d$ .

II-3 Derive expressions for the unit normal vector for surfaces given by  $y = g(x, z)$  and by  $x = h(y, z)$ . Use each to rederive the expression for the normal to the plane given in Problem II-2.

II-4 In each of the following use Equation II-12 to evaluate the surface integral  $\iint_S G(x, y, z) dS$ .

- (a)  $G(x, y, z) = z$ ,

where  $S$  is the portion of the plane  $x + y + z = 1$  in the first octant.

$$(b) G(x, y, z) = \frac{1}{1 + 4(x^2 + y^2)},$$

where  $S$  is the portion of the paraboloid  $z = x^2 + y^2$  between  $z = 0$  and  $z = 1$ .

$$(c) G(x, y, z) = (1 - x^2 - y^2)^{3/2},$$

where  $S$  is the hemisphere  $z = (1 - x^2 - y^2)^{1/2}$ .

**II-5** In each of the following use Equation II-13 to evaluate the surface integral  $\iint_S \mathbf{F} \cdot \mathbf{n} dS$ .

(a)  $\mathbf{F}(x, y, z) = \mathbf{i}x - \mathbf{k}z$ ,

where  $S$  is the portion of the plane  $x + y + 2z = 2$  in the first octant.

(b)  $\mathbf{F}(x, y, z) = \mathbf{i}x + \mathbf{j}y + \mathbf{k}z$ ,

where  $S$  is the hemisphere  $z = \sqrt{a^2 - x^2 - y^2}$ .

(c)  $\mathbf{F}(x, y, z) = \mathbf{j}y + \mathbf{k}$ ,

where  $S$  is the portion of the paraboloid  $z = 1 - x^2 - y^2$  above the  $xy$ -plane.

**II-6** The distribution of mass on the hemispherical shell

$$z = (R^2 - x^2 - y^2)^{1/2}$$

is given by

$$\sigma(x, y, z) = (\sigma_0/R^2)(x^2 + y^2)$$

where  $\sigma_0$  is a constant. Find an expression in terms of  $\sigma_0$  and  $R$  for the total mass of the shell.

**II-7** Find the moment of inertia about the  $z$ -axis of the hemispherical shell of Problem II-6.



$$\mathbf{E} = \lambda(\mathbf{i}yz + \mathbf{j}xz + \mathbf{k}xy),$$


$$z = (R^2 - x^2 - y^2)^{1/2},$$



## *Chapter III*

# Line Integrals and the Curl

*To err from the right path is common to Mankind.*

*Sophocles*

## *Work and Line Integrals*

We remarked above that the differential form of Gauss' law, Equations (II-18) and (II-23), although it fulfills our goal of relating a property of the electric field (its divergence) at a point to a known quantity (the charge density) at the same point, nonetheless falls short of providing a convenient way to find  $\mathbf{E}$ . The reason is that  $\nabla \cdot \mathbf{E} = \rho/\epsilon_0$  is (or seems to be) a single differential equation in three unknowns ( $E_x, E_y, E_z$ ). But there is another feature of electrostatic fields that has not yet played an explicit role in our discussion and that will yield a relationship among the components of  $\mathbf{E}$ . It will thus provide us with the crucial last step in obtaining a useful way to calculate fields. In the process of ex-

amining this question, we shall encounter some of the most important topics in vector calculus.

The property of electrostatic fields that we shall now begin to discuss is intimately bound up with the question of work and energy. You no doubt recall the elementary definition of work as force times distance. Thus, in one dimension, if a force  $F(x)$  acts from  $x = a$  to  $x = b$ , the work done is, by definition,

$$\int_a^b F(x) \, dx.$$

To be able to handle more general situations, we must now introduce the concept of the *line integral*.



Suppose we have a curve  $C$  in three dimensions (Figure III-1) and suppose the curve is *directed*. By this we mean that we put an arrow on the curve and say “This is the positive direction.” Let  $s$  be the arc length measured along the curve from some arbitrary point on it with  $s = s_1$  at a point  $P_1$  and  $s = s_2$  at  $P_2$ . Suppose further that we have a function  $f(x, y, z)$  defined everywhere on  $C$ . Now let us subdivide the portion of  $C$  between  $P_1$  and  $P_2$  arbitrarily into  $N$  sections. Figure III-1 shows an example of such a subdivision for  $N = 4$ . Next, join successive subdivision points by chords, a typical one of which, say the  $l$ th, has length  $\Delta s_l$ . Now evaluate  $f(x, y, z)$  at  $(x_l, y_l, z_l)$ , which is any point on the  $l$ th subdivision of the curve, and form the product  $f(x_l, y_l, z_l) \Delta s_l$ . Doing this for each of the  $N$  segments of  $C$ , we form the sum

$$\sum_{l=1}^N f(x_l, y_l, z_l) \Delta s_l.$$

## Work and Line Integrals

By definition, the line integral of  $f(x, y, z)$  along the curve  $C$  is the limit of this sum as the number of subdivisions  $N$  approaches infinity and the length of each chord approaches zero:

$$\int_C f(x, y, z) \, ds = \lim_{\substack{N \rightarrow \infty \\ \text{each } \Delta s_l \rightarrow 0}} \sum_{l=1}^N f(x_l, y_l, z_l) \Delta s_l.$$

To evaluate the line integral, we need to know the path  $C$ . Usually the most convenient way to specify this path is parametrically in terms of the arc length parameter  $s$ . Thus, we write  $x = x(s)$ ,  $y = y(s)$ , and  $z = z(s)$ . In such a situation the line integral can be reduced to an ordinary definite integral:

$$\int_C f(x, y, z) \, ds = \int_{s_1}^{s_2} f[x(s), y(s), z(s)] \, ds.$$

An example of a line integral will be helpful here. For simplicity let us work in two dimensions and evaluate

$$\int_C (x + y) \, ds,$$

where  $C$  is the straight line from the origin to the point whose coordinates are  $(1, 1)$  (Figure III-2). If  $(x, y)$  are the coordinates of



any point  $P$  on  $C$  and if  $s$  is the arc length measured from the origin, then  $x = s/\sqrt{2}$  and  $y = s/\sqrt{2}$ . Hence,  $x + y = 2s/\sqrt{2} = \sqrt{2}s$ . Thus,

$$\int_C (x + y) \, ds = \sqrt{2} \int_0^{\sqrt{2}} s \, ds = \sqrt{2}.$$



Let us integrate this same function ( $x + y$ ) from  $(0, 0)$  to  $(1, 1)$  along another path as shown in Figure III-3. Here we break the integration into two parts, one along  $C_1$  and the second along  $C_2$ . On  $C_1$  we have  $x = s$  and  $y = 0$ . Thus, on  $C_1$ ,  $x + y = s$ , and so

$$\int_{C_1} (x + y) \, ds = \int_0^1 s \, ds = \frac{1}{2}.$$

Along  $C_2$ ,  $x = 1$  and  $y = s$  [note that the arc length on this segment of the path is measured from the point  $(1, 0)$ ]. It follows then that

$$\int_{C_2} (x + y) \, ds = \int_0^1 (1 + s) \, ds = \frac{3}{2}.$$

Adding the results for the two segments, we find

$$\int_C (x + y) \, ds = \int_{C_1} (x + y) \, ds + \int_{C_2} (x + y) \, ds = \frac{1}{2} + \frac{3}{2} = 2.$$

The lesson to be learned is this: the value of a line integral can (indeed, usually does) depend on the path of integration.

## *Line Integrals Involving Vector Functions*

Although the preceding discussion tells us what a line integral is, the kind of line integral we must deal with here has a feature not yet mentioned. You will recall that we introduced our discussion of line integrals with the concept of work. Work, in the most ele-

mentary sense, is force times displacement. That this needs elaboration becomes clear when we recognize that both force and displacement are vectors.

Thus, consider some path  $C$  in three dimensions (Figure III-4). Let us suppose that under the action of a force an object moves on this path from  $s_1$  to  $s_2$ . At any point  $P$  on the curve let the force



acting be designated  $\mathbf{f}(x, y, z)$ . The component of  $\mathbf{f}$  that does work is, by definition, only that one which acts *along* the curve, that is, the tangential component. Let  $\hat{\mathbf{t}}$  denote a unit vector that is tangent to the curve at  $P$ .<sup>1</sup> Then the work done by the force in moving the object from  $s_1$  to  $s_2$  along the curve  $C$  is

$$W = \int_C \mathbf{f}(x, y, z) \cdot \hat{\mathbf{t}} \, ds,$$

where it is understood, of course, that the integration begins at  $s = s_1$  and ends at  $s = s_2$ . The new feature of this integral is that the integrand is the dot product of two vector functions. To be able to handle such a line integral, we must know how to find  $\hat{\mathbf{t}}$ , and it is to this problem that we now turn.

Consider an arbitrary curve  $C$  (Figure III-5) parametrized by its arc length. At some point  $s$  on the curve we have  $x = x(s)$ ,  $y = y(s)$ , and  $z = z(s)$ . At another point  $s + \Delta s$  we have  $x + \Delta x = x(s + \Delta s)$ ,  $y + \Delta y = y(s + \Delta s)$ , and  $z + \Delta z = z(s + \Delta s)$ . Thus,

<sup>1</sup>  $\hat{\mathbf{t}}$  is a function of  $x$ ,  $y$ , and  $z$  and should really be written  $\hat{\mathbf{t}}(x, y, z)$ . We write simply  $\hat{\mathbf{t}}$  to avoid complicating the notation.



the chord joining the two points on the curve directed from the first to the second is the vector  $\Delta \mathbf{r} \equiv \mathbf{i}\Delta x + \mathbf{j}\Delta y + \mathbf{k}\Delta z$ , where

$$\begin{aligned}\Delta x &= x(s + \Delta s) - x(s), \\ \Delta y &= y(s + \Delta s) - y(s), \\ \Delta z &= z(s + \Delta s) - z(s).\end{aligned}$$

If we now divide this vector by  $\Delta s$ , we get

$$\frac{\Delta \mathbf{r}}{\Delta s} = \mathbf{i} \frac{\Delta x}{\Delta s} + \mathbf{j} \frac{\Delta y}{\Delta s} + \mathbf{k} \frac{\Delta z}{\Delta s}.$$

Taking the limit of this as  $\Delta s$  approaches zero yields

$$\mathbf{i} \frac{dx}{ds} + \mathbf{j} \frac{dy}{ds} + \mathbf{k} \frac{dz}{ds},$$

and we assert that this is  $\hat{\mathbf{t}}$ . To begin with, it's clear that as  $\Delta s \rightarrow 0$ , the vector  $\Delta \mathbf{r}$  becomes tangent to the curve at  $s$ . Further, in the limit  $\Delta s \rightarrow 0$ , we see that  $|\Delta \mathbf{r}| \rightarrow \Delta s$ . Hence, in the limit the magnitude of this quantity is 1. It follows then that we can make the identification

$$\hat{\mathbf{t}}(s) = \mathbf{i} \frac{dx}{ds} + \mathbf{j} \frac{dy}{ds} + \mathbf{k} \frac{dz}{ds}.$$

If we return now to the expression for work  $W$  and use this formula for  $\hat{\mathbf{t}}$ , we find

$$W = \int_C \mathbf{f}(x, y, z) \cdot \left[ \mathbf{i} \frac{dx}{ds} + \mathbf{j} \frac{dy}{ds} + \mathbf{k} \frac{dz}{ds} \right] ds$$

$$= \int_C (f_x dx + f_y dy + f_z dz).$$

## Line Integrals Involving Vector Functions

This is a formal expression; often, to carry out the integration, it is useful to restore the  $ds$  as the following example illustrates. Consider

$$\mathbf{f}(x, y, z) = \mathbf{i}y - \mathbf{j}x$$

and the path shown in Figure III-6(a). To calculate  $\int_C (\mathbf{f} \cdot \hat{\mathbf{t}}) ds$  in



in this case, we break the path  $C$  into three parts,  $C_1$ ,  $C_2$ , and  $C_3$  as shown. Since  $f_z = 0$ , we have

$$\begin{aligned} \int_C \mathbf{f} \cdot \hat{\mathbf{t}} ds &= \int_C f_x dx + f_y dy \\ &= \int_C y dx - x dy. \end{aligned}$$

Now, on  $C_1$ ,  $y = 0$  and  $dy = 0$ , so there is no contribution to the integral. Similarly, on  $C_3$  we have  $x = 0$  and  $dx = 0$ , and again the result is zero. Thus, the only contribution to the integral over  $C$  can come from  $C_2$ . Restoring the  $ds$ , we have

$$\int_C \left( y \frac{dx}{ds} - x \frac{dy}{ds} \right) ds.$$



But  $(1 - x)/s = \cos 45^\circ = 1/\sqrt{2}$  and  $y/s = \sin 45^\circ = 1/\sqrt{2}$  [Figure III-6(b)]. Thus,

$$\left. \begin{aligned} x &= 1 - \frac{s}{\sqrt{2}} \Rightarrow \frac{dx}{ds} = -\frac{1}{\sqrt{2}} \\ y &= \frac{s}{\sqrt{2}} \Rightarrow \frac{dy}{ds} = \frac{1}{\sqrt{2}} \end{aligned} \right\} \quad 0 \leq s \leq \sqrt{2}.$$

Hence, the integral is

$$\begin{aligned} \int_0^{\sqrt{2}} \left[ \frac{s}{\sqrt{2}} \left( -\frac{1}{\sqrt{2}} \right) - \left( 1 - \frac{s}{\sqrt{2}} \right) \frac{1}{\sqrt{2}} \right] ds \\ = -\frac{1}{\sqrt{2}} \int_0^{\sqrt{2}} ds = -1. \end{aligned}$$

As a second example of a line integral involving a vector function, let

$$\mathbf{f}(x, y, z) = \mathbf{i}x^2 - \mathbf{j}xy,$$

and take  $C$  to be the quarter circle of radius  $R$  oriented as shown in Figure III-6(c). We then have

$$\int_C \mathbf{f} \cdot \mathbf{t} \, ds = \int_C x^2 \, dx - xy \, dy.$$



Letting  $x = R \cos \theta$ ,  $y = R \sin \theta$ , we find this integral becomes

$$\begin{aligned} & \int_0^{\pi/2} [R^2 \cos^2 \theta (-R \sin \theta) - R^2 \sin \theta \cos \theta (R \cos \theta)] d\theta \\ &= -2R^3 \int_0^{\pi/2} \cos^2 \theta \sin \theta d\theta = -2R^3/3. \end{aligned}$$

## *Path Independence*

In a line integral the path of integration is one of the ingredients which determines the very function we integrate. It isn't remarkable, then, that the value of the integral can depend on the path of integration. What is remarkable is that, under some conditions, the value of the integral does *not* depend on the path!

We show how this path independence comes about in the case of the Coulomb force. Let a charge  $q_0$  be fixed at the origin and let another charge  $q$  be situated at  $(x, y, z)$  (Figure III-7). The Coulomb force on  $q$  is

$$\mathbf{F} = \frac{1}{4\pi\epsilon_0} \frac{qq_0}{r^2} \hat{\mathbf{u}}, \quad (\text{III-1})$$

where  $r = (x^2 + y^2 + z^2)^{1/2}$  is the distance between the two charges and  $\hat{\mathbf{u}}$  is a unit vector pointing from  $q_0$  to  $q$ . With this arrangement  $\hat{\mathbf{u}}$  is clearly in the radial direction. Even more



clearly, the radial vector  $\mathbf{r}$  is in the radial direction. Thus, we have  $\hat{\mathbf{u}} = \mathbf{r}/r = (\mathbf{i}x + \mathbf{j}y + \mathbf{k}z)/r$ , and so

$$\mathbf{F} = \frac{qq_0}{4\pi\epsilon_0} \frac{\mathbf{i}x + \mathbf{j}y + \mathbf{k}z}{r^3}.$$

Thus,

$$\mathbf{F} \cdot \hat{\mathbf{t}} \, ds = F_x \, dx + F_y \, dy + F_z \, dz = \frac{qq_0}{4\pi\epsilon_0} \frac{x \, dx + y \, dy + z \, dz}{r^3}$$

The trick now is to use the relationship

$$r^2 = x^2 + y^2 + z^2.$$

Taking differentials in this equation and dividing by a factor of 2 yields

$$x \, dx + y \, dy + z \, dz = r \, dr,$$

so that

$$\mathbf{F} \cdot \hat{\mathbf{t}} \, ds = \frac{qq_0}{4\pi\epsilon_0} \frac{r \, dr}{r^3} = \frac{qq_0}{4\pi\epsilon_0} \frac{dr}{r^2}.$$

Suppose now that the charge  $q$  moves from a point  $P_1$  at a distance  $r_1$  from the origin to a point  $P_2$  at a distance  $r_2$ , over some path  $C$  connecting the two points (Figure III-8). Then

$$\int_C \mathbf{F} \cdot \hat{\mathbf{t}} \, ds = \frac{qq_0}{4\pi\epsilon_0} \int_{r_1}^{r_2} \frac{dr}{r^2} = \frac{qq_0}{4\pi\epsilon_0} \left( \frac{1}{r_1} - \frac{1}{r_2} \right).$$



Notice that to get this result, we haven't had to specify  $C$  in any way whatever; we'd get the same answer for *any* path connecting  $P_1$  and  $P_2$ . This, of course, proves that the line integral

$$\int_C \mathbf{F} \cdot \hat{\mathbf{t}} \, ds$$

with  $\mathbf{F}$  given by Equation (III-1) is path-independent, but the result, so far, has been established only for the Coulomb force on  $q$  due to a single charge  $q_0$  [Equation (III-1)]. If there are many charges  $q_1, q_2, \dots, q_N$ , then the total force on  $q$  is  $\mathbf{F}_1 + \mathbf{F}_2 + \dots + \mathbf{F}_N$ , where  $\mathbf{F}_l$  is the Coulomb force on  $q$  due to the  $l$ th charge  $q_l$ . Hence,

$$\int_C \mathbf{F} \cdot \hat{\mathbf{t}} \, ds = \int_C \mathbf{F}_1 \cdot \hat{\mathbf{t}} \, ds + \dots + \int_C \mathbf{F}_N \cdot \hat{\mathbf{t}} \, ds.$$

Now the discussion given above shows that each term of this sum is path independent; hence, so is the sum itself. (All this, of course, is merely an application of the superposition principle.) To phrase this result in terms of the field requires one last trivial step: Since  $\mathbf{F} = q\mathbf{E}$ , it follows that  $q \int_C \mathbf{E} \cdot \hat{\mathbf{t}} \, ds$  is path independent, whence  $\int_C \mathbf{E} \cdot \hat{\mathbf{t}} \, ds$  is also. Strange to say, it is this fact that will enable us eventually to convert  $\nabla \cdot \mathbf{E} = \rho/\epsilon_0$  into a more useful equation.

If you examine the foregoing discussion carefully, you'll see that the fact that the Coulomb force varies inversely as the square of  $r$  has nothing whatever to do with the path independence of the line integral. The path independence rests solely on two properties of the Coulomb force: (1) It depends only on the distance between the two particles, and (2) it acts along the line joining them.

Any force  $\mathbf{F}$  with these two properties is called a *central force*, and  $\int_C \mathbf{F} \cdot \hat{\mathbf{t}} \, ds$  is independent of path for *any* central force.<sup>2</sup>

One further step pertaining to path independence can be taken here. If

$$\int_C \mathbf{F} \cdot \hat{\mathbf{t}} \, ds$$

is independent of path, then

$$\int_{C_1} \mathbf{F} \cdot \hat{\mathbf{t}} \, ds = \int_{C_2} \mathbf{F} \cdot \hat{\mathbf{t}} \, ds,$$

where, as indicated in Figure III-9,  $C_1$  and  $C_2$  are two different arbitrary paths connecting the two points  $P_1$  and  $P_2$  and directed as shown in the figure. Now if instead of integrating along  $C_1$  from  $P_1$  to  $P_2$ , we go the other way, we simply change the sign of the line integral; that is,

$$\int_{-C_1} \mathbf{F} \cdot \hat{\mathbf{t}} \, ds = - \int_{C_1} \mathbf{F} \cdot \hat{\mathbf{t}} \, ds,$$



where  $-C_1$  merely indicates that the integration is to be carried out along  $C_1$  from  $P_2$  to  $P_1$ . Thus,

$$\int_{C_2} \mathbf{F} \cdot \hat{\mathbf{t}} \, ds = - \int_{-C_1} \mathbf{F} \cdot \hat{\mathbf{t}} \, ds$$

<sup>2</sup> Our having illustrated path independence with a central force may give the erroneous impression that *only* central forces have path-independent line integrals. That is certainly *not* true; many functions which are not central forces have path-independent line integrals. Later we'll develop a simple criterion for identifying such functions.

$$\int_{-C_1+C_2} \mathbf{F} \cdot \hat{\mathbf{t}} \, ds = 0.$$

But  $-C_1 + C_2$  is just the closed loop from  $P_1$  to  $P_2$  and back, as shown in Figure III-10. Thus, if  $\oint \mathbf{F} \cdot \hat{\mathbf{t}} \, ds$  is independent of path, then

$$\oint \mathbf{F} \cdot \hat{\mathbf{t}} \, ds = 0,$$



where  $\oint$  is the standard notation for a line integral around a closed path. It follows that if  $\mathbf{E}$  is an electrostatic field, we can write

$$\oint \mathbf{E} \cdot \hat{\mathbf{t}} \, ds = 0. \quad (\text{III-2})$$

The term “circulation” is often given to the path integral around a closed curve of the tangential component of a vector function. Thus we have demonstrated that the circulation of the electrostatic field is zero. In what follows we’ll call this the circulation law.

## The Curl

If we are given some vector function  $\mathbf{F}(x, y, z)$  and asked, “Could this be an electrostatic field?” we can, in principle, provide an answer. If

$$\oint \mathbf{F} \cdot \hat{\mathbf{t}} \, ds \neq 0$$

over even *one* path, then  $\mathbf{F}$  cannot be an electrostatic field. If

$$\oint \mathbf{F} \cdot \hat{\mathbf{t}} \, ds = 0$$

over *every* closed path, then  $\mathbf{F}$  can (but does not have to) be an electrostatic field.

Clearly, this criterion is not easy to apply since we must be sure the circulation of  $\mathbf{F}$  is zero over all possible paths. To develop a more useful criterion, we proceed much as we did in dealing with Gauss' law, which, like the circulation law, is an expression involving an integral over the electric field. Gauss' law is more useful in the differential form [Equations (II-18) and (II-23)] obtained by considering the ratio of flux to volume for ever-decreasing surfaces. We now treat the circulation law in the same spirit and attempt to find the differential form of Equation (III-2). To stress the generality of our analysis and results, we deal with an arbitrary function  $\mathbf{F}(x, y, z)$  and specialize to  $\mathbf{E}(x, y, z)$  at a later stage in the development.

Let us consider the circulation of  $\mathbf{F}$  over a small rectangle parallel to the  $xy$ -plane, with sides  $\Delta x$  and  $\Delta y$  and with the point  $(x, y, z)$  at the center [Figure III-11(a)]. As shown in Figure III-11(b), we carry out the path integration in a counterclockwise direction looking down at the  $xy$ -plane. The line integral is broken up into four parts:  $C_B$  (bottom),  $C_R$  (right),  $C_T$  (top), and  $C_L$  (left). Since the rectangle is small (eventually we shall take the limit as it shrinks down to zero), we'll approximate the integral over each segment by  $\mathbf{F} \cdot \hat{\mathbf{t}}$  evaluated at the center of the segment, multiplied by the length of the segment.<sup>3</sup>





Taking  $C_B$  first, we have

$$\int_{C_B} \mathbf{F} \cdot \hat{\mathbf{t}} \, ds = \int_{C_B} F_x \, dx \simeq F_x \left( x, y - \frac{\Delta y}{2}, z \right) \Delta x. \quad (\text{III-3a})$$

Over  $C_T$  we find

$$\int_{C_T} \mathbf{F} \cdot \hat{\mathbf{t}} \, ds = \int_{C_T} F_x \, dx \simeq -F_x \left( x, y + \frac{\Delta y}{2}, z \right) \Delta x. \quad (\text{III-3b})$$

The negative sign here is required by the fact that

$$\int_{C_T} F_x \, dx = \int_{C_T} F_x \frac{dx}{ds} \, ds$$

and  $dx/ds = -1$  over  $C_T$ . Adding Equation (III-3a) and (III-3b), we find

$$\int_{C_T + C_B} (\mathbf{F} \cdot \hat{\mathbf{t}}) \, ds$$

$$\simeq - \left[ F_x \left( x, y + \frac{\Delta y}{2}, z \right) - F_x \left( x, y - \frac{\Delta y}{2}, z \right) \right] \Delta x$$

$$\simeq - \frac{F_x \left( x, y + \frac{\Delta y}{2}, z \right) - F_x \left( x, y - \frac{\Delta y}{2}, z \right)}{\Delta y} \Delta x \Delta y.$$

The factor  $\Delta x \Delta y$  is clearly the area  $\Delta S$  of the rectangle. Thus,

$$\frac{1}{\Delta S} \int_{C_r+C_b} (\mathbf{F} \cdot \hat{\mathbf{t}}) ds \quad (\text{III-4})$$

$$\approx - \frac{F_x\left(x, y + \frac{\Delta y}{2}, z\right) - F_x\left(x, y - \frac{\Delta y}{2}, z\right)}{\Delta y}.$$

Exactly the same sort of analysis applied to the left and right sides of the rectangle ( $C_L$  and  $C_R$ ) results in

$$\frac{1}{\Delta S} \int_{C_L+C_R} (\mathbf{F} \cdot \hat{\mathbf{t}}) ds \quad (\text{III-5})$$

$$\approx \frac{F_y\left(x + \frac{\Delta x}{2}, y, z\right) - F_y\left(x - \frac{\Delta x}{2}, y, z\right)}{\Delta x}.$$

Adding Equations (III-4) and (III-5) and taking the limit as  $\Delta S$  shrinks down about a point  $(x, y, z)$  (in which case  $\Delta x$  and  $\Delta y \rightarrow 0$  as well), we get

$$\lim_{\substack{\Delta S \rightarrow 0 \\ \text{about } (x, y, z)}} \frac{1}{\Delta S} \oint \mathbf{F} \cdot \hat{\mathbf{t}} ds = \frac{\partial F_y}{\partial x} - \frac{\partial F_x}{\partial y}, \quad (\text{III-6})$$

where  $\oint$  is our semicomical notation meaning the circulation around the little rectangle.

You may wonder about the generality and uniqueness of this result since it is obtained using a path of integration that is special in two ways: first, it is a rectangle, and second, it is parallel to the  $xy$ -plane. If the path were not a rectangle, but a plane curve of arbitrary shape, it would not affect our result (see Problems III-2 and III-30). But our result definitely *does* depend on the special orientation of the path of integration. The choice of orientation made above clearly suggests two others, and they are shown in Figure III-12(a) and (b) along with the result of calculating

$$\lim_{\substack{\Delta S \rightarrow 0 \\ \text{about } (x, y, z)}} \frac{1}{\Delta S} \oint \mathbf{F} \cdot \hat{\mathbf{t}} ds$$





Each of these three paths is named in honor of the vector normal to the enclosed area. The convention we use is this: Trace the curve  $C$  so that the enclosed area is always to the left [Figure III-13(a)]. Then choose the normal so that it points “up” in the di-





rection shown in the picture. This convention is sometimes called the right-hand rule, for if the right hand is oriented so that the fingers curl in the direction in which the curve is traced, the thumb, extended, points in the direction of the normal [Figure III-13(b)]. Using the right-hand rule, we have the following:

Calculating  $\lim_{\Delta S \rightarrow 0} \oint \mathbf{F} \cdot \hat{\mathbf{t}} \, ds / \Delta S$

$$\left. \begin{aligned}
 & \text{for a path whose normal is } \mathbf{i}, \text{ we get } \frac{\partial F_z}{\partial y} - \frac{\partial F_y}{\partial z}, \\
 & \text{for a path whose normal is } \mathbf{j}, \text{ we get } \frac{\partial F_x}{\partial z} - \frac{\partial F_z}{\partial x}, \\
 & \text{for a path whose normal is } \mathbf{k}, \text{ we get } \frac{\partial F_y}{\partial x} - \frac{\partial F_x}{\partial y}.
 \end{aligned} \right\} \quad (\text{III-7a})$$

It turns out that these three quantities are the Cartesian components of a vector. To this vector we give the name “curl of  $\mathbf{F}$ ,” which we write  $\text{curl } \mathbf{F}$ . Thus, we have

$$\begin{aligned}
 \text{curl } \mathbf{F} = & \mathbf{i} \left( \frac{\partial F_z}{\partial y} - \frac{\partial F_y}{\partial z} \right) + \mathbf{j} \left( \frac{\partial F_x}{\partial z} - \frac{\partial F_z}{\partial x} \right) \\
 & + \mathbf{k} \left( \frac{\partial F_y}{\partial x} - \frac{\partial F_x}{\partial y} \right).
 \end{aligned} \quad (\text{III-7b})$$

This expression is often (indeed, usually) given as the definition of the curl, but we prefer to regard it as merely the form of the curl in Cartesian coordinates. We shall define the curl as the limit



of circulation to area as the area tends to zero. To be precise, let  $\oint_{C_n} \mathbf{F} \cdot \hat{\mathbf{t}} \, ds$  be the circulation of  $\mathbf{F}$  about some path whose normal is  $\hat{\mathbf{n}}$  as shown in Figure III-14. Then by definition

$$\hat{\mathbf{n}} \cdot \operatorname{curl} \mathbf{F} = \lim_{\substack{\Delta S \rightarrow 0 \\ \text{about } (x, y, z)}} \frac{1}{\Delta S} \oint_{C_n} \mathbf{F} \cdot \hat{\mathbf{t}} \, ds. \quad (\text{III-8})$$

By taking  $\hat{\mathbf{n}}$  successively equal to  $\mathbf{i}$ ,  $\mathbf{j}$ , and  $\mathbf{k}$ , we get back the results given in Equation (III-7b). Since this limit will, in general, have different values for different points  $(x, y, z)$ , the curl of  $\mathbf{F}$  is a *vector function* of position.<sup>4</sup> Note incidentally that although in our work we always assumed that the area enclosed by the path of integration was a plane, this need not be the case. Since the curl is defined in terms of a limit in which the enclosed surface shrinks to zero about some point, in the final stages of this limiting process the enclosed surface is infinitesimally close to a plane, and all our considerations apply.

Since it is undoubtedly beyond the powers of a mere mortal to remember the expression given above for  $\operatorname{curl} \mathbf{F}$  in Cartesian coordinates [Equation (III-7b)], it is fortunate that there is a mnemonic device to fall back on. If the three-by-three determinant

$$\begin{vmatrix} \mathbf{i} & \mathbf{j} & \mathbf{k} \\ \partial/\partial x & \partial/\partial y & \partial/\partial z \\ F_x & F_y & F_z \end{vmatrix}$$

is expanded (most conveniently in minors of the first row) and if certain “products” are interpreted as partial derivatives [for example,

<sup>4</sup> The word *rotation* (abbreviated “rot,” amusingly enough) was once used for what we now call the *curl*. Though the term has long since dropped out of use, a related one survives: If  $\operatorname{curl} \mathbf{F} = 0$ , the function  $\mathbf{F}$  is said to be *irrotational*.

$(\partial/\partial x)F_y = \partial F_y/\partial x]$ , the result will be identical with the one given in Equation (III-7b).<sup>5</sup> Thus, the anguish of remembering the form of curl  $\mathbf{F}$  in Cartesian coordinates can be replaced by the pain of remembering how to expand a three-by-three determinant. *Chacun à son goût.*

As an example of calculating the curl, consider the vector function

$$\mathbf{F}(x, y, z) = \mathbf{i}xz + \mathbf{j}yz - \mathbf{k}y^2.$$

We have

$$\begin{aligned} \text{curl } \mathbf{F} &= \begin{vmatrix} \mathbf{i} & \mathbf{j} & \mathbf{k} \\ \partial/\partial x & \partial/\partial y & \partial/\partial z \\ xz & yz & -y^2 \end{vmatrix} \\ &= \mathbf{i}(-2y - y) + \mathbf{j}(x - 0) + \mathbf{k}(0 - 0) \\ &= -3\mathbf{i}y + \mathbf{j}x. \end{aligned}$$

You may have noticed that the curl operator can be written in terms of the del notation we introduced earlier. You can verify for yourself that

$$\text{curl } \mathbf{F} = \nabla \times \mathbf{F},$$

which is read “del cross  $\mathbf{F}$ .” Henceforth, we shall always use  $\nabla \times \mathbf{F}$  to indicate the curl.

## *The Curl in Cylindrical and Spherical Coordinates*

To obtain the form of  $\nabla \times \mathbf{F}$  in other coordinate systems, we proceed as we did above in finding the Cartesian form, merely modifying the paths of integration appropriately. As an example, using the path shown in Figure III-15(a) will yield the  $z$ -component of  $\nabla \times \mathbf{F}$  in cylindrical coordinates.<sup>6</sup> Note that we trace the curve in

<sup>5</sup> A mathematician would object to this since, strictly speaking, a determinant cannot contain either vectors or operators. We aren't doing any serious damage, however, because our “determinant” is merely a memory aid.

<sup>6</sup> In deriving the Cartesian form of  $\nabla \times \mathbf{F}$ , each segment of each path of integration (see Figures III-11 and III-12) was of the form  $x = \text{constant}$ ,  $y = \text{constant}$ , or  $z = \text{constant}$ . Similarly, in deriving the cylindrical form, each segment of each path is of the form  $r = \text{constant}$ ,  $\theta = \text{constant}$ , or  $z = \text{constant}$ .





accordance with the right-hand rule given in the previous section. Viewing the path from above [as we do in Figure III-15(b)], the line integral of  $\mathbf{F}(r, \theta, z) \cdot \hat{\mathbf{t}}$  along the segment of path marked 1 is

$$\int_{C_1} \mathbf{F} \cdot \hat{\mathbf{t}} \, ds \approx F_r \left( r, \theta - \frac{\Delta\theta}{2}, z \right) \Delta r,$$

while along segment 3 it is

$$\int_{C_3} \mathbf{F} \cdot \hat{\mathbf{t}} \, ds \approx -F_r \left( r, \theta + \frac{\Delta\theta}{2}, z \right) \Delta r.$$

The area enclosed by the path is  $r \Delta r \Delta\theta$ , so

$$\frac{1}{\Delta S} \int_{C_1+C_3} \mathbf{F} \cdot \hat{\mathbf{t}} \, ds$$

$$\approx -\frac{\Delta r}{r \Delta r \Delta\theta} \left[ F_r \left( r, \theta + \frac{\Delta\theta}{2}, z \right) - F_r \left( r, \theta - \frac{\Delta\theta}{2}, z \right) \right].$$

In the limit as  $\Delta r$  and  $\Delta\theta$  tend to zero, this becomes

$$-\frac{1}{r} \frac{\partial F_r}{\partial \theta}$$

evaluated at the point  $(r, \theta, z)$ .

Along segment 2 we find

$$\int_{C_2} \mathbf{F} \cdot \hat{\mathbf{t}} \, ds \simeq F_\theta \left( r + \frac{\Delta r}{2}, \theta, z \right) \left( r + \frac{\Delta r}{2} \right) \Delta\theta,$$

and along segment 4

$$\int_{C_4} \mathbf{F} \cdot \hat{\mathbf{t}} \, ds \simeq -F_\theta \left( r - \frac{\Delta r}{2}, \theta, z \right) \left( r - \frac{\Delta r}{2} \right) \Delta\theta.$$

Thus,

$$\begin{aligned} \frac{1}{\Delta S} \int_{C_2+C_4} \mathbf{F} \cdot \hat{\mathbf{t}} \, ds &\simeq \frac{\Delta\theta}{r \Delta r \Delta\theta} \left[ \left( r + \frac{\Delta r}{2} \right) F_\theta \left( r + \frac{\Delta r}{2}, \theta, z \right) \right. \\ &\quad \left. - \left( r - \frac{\Delta r}{2} \right) F_\theta \left( r - \frac{\Delta r}{2}, \theta, z \right) \right]. \end{aligned}$$

In the limit this becomes  $(1/r)(\partial/\partial r)(rF_\theta)$  evaluated at  $(r, \theta, z)$ . Hence,

$$(\nabla \times \mathbf{F})_z \equiv \lim_{\Delta S \rightarrow 0} \frac{1}{\Delta S} \oint \mathbf{F} \cdot \hat{\mathbf{t}} \, ds = \frac{1}{r} \frac{\partial}{\partial r} (rF_\theta) - \frac{1}{r} \frac{\partial F_r}{\partial \theta}.$$

Paths for finding the  $r$ - and  $\theta$ -components of  $\nabla \times \mathbf{F}$  are shown in Figures III-15(c) and (d), respectively. You are asked to obtain these two components yourself in Problem III-8. For completeness we give all three components of  $\nabla \times \mathbf{F}$  in cylindrical coordinates:

$$(\nabla \times \mathbf{F})_r = \frac{1}{r} \frac{\partial F_z}{\partial \theta} - \frac{\partial F_\theta}{\partial z},$$

$$(\nabla \times \mathbf{F})_\theta = \frac{\partial F_r}{\partial z} - \frac{\partial F_z}{\partial r},$$

$$(\nabla \times \mathbf{F})_z = \frac{1}{r} \frac{\partial}{\partial r} (rF_\theta) - \frac{1}{r} \frac{\partial F_r}{\partial \theta}.$$





As an example of calculating the curl in cylindrical coordinates consider the function

$$\mathbf{F}(r, \theta, z) = \hat{\mathbf{e}}_r r^2 z + \hat{\mathbf{e}}_\theta r z^2 \cos \theta + \hat{\mathbf{e}}_z r^3$$

Then

$$(\nabla \times \mathbf{F})_r = \frac{1}{r} \frac{\partial}{\partial \theta} (r^3) - \frac{\partial}{\partial z} (r z^2 \cos \theta) = -2r z \cos \theta$$

$$(\nabla \times \mathbf{F})_\theta = \frac{\partial}{\partial z} (r^2 z) - \frac{\partial}{\partial r} (r^3) = -2r^2$$

$$(\nabla \times \mathbf{F})_z = \frac{1}{r} \frac{\partial}{\partial r} (r^2 z^2 \cos \theta) - \frac{1}{r} \frac{\partial}{\partial \theta} (r^2 z) = 2z^2 \cos \theta$$

Hence

The three components of  $\operatorname{curl} \mathbf{F}$  in *spherical* coordinates (see Problem III-9) are as follows:

$$(\nabla \times \mathbf{F})_r = \frac{1}{r \sin \phi} \frac{\partial}{\partial \phi} (\sin \phi F_\theta) - \frac{1}{r \sin \phi} \frac{\partial F_\phi}{\partial \theta}$$

$$(\nabla \times \mathbf{F})_\phi = \frac{1}{r \sin \phi} \frac{\partial F_r}{\partial \theta} - \frac{1}{r} \frac{\partial}{\partial r} (r F_\theta)$$

$$(\nabla \times \mathbf{F})_\theta = \frac{1}{r} \frac{\partial}{\partial r} (r F_\phi) - \frac{1}{r} \frac{\partial F_r}{\partial \phi}$$

As an example of calculating the curl in spherical coordinates, consider the function

$$\mathbf{F}(r, \theta, \phi) = \frac{\hat{\mathbf{e}}_r}{r \theta} + \frac{\hat{\mathbf{e}}_\phi}{r} + \frac{\hat{\mathbf{e}}_\theta}{r \cos \phi}$$

Then

$$(\nabla \times \mathbf{F})_r = \frac{1}{r \sin \phi} \frac{\partial}{\partial \phi} \left( \sin \phi \frac{1}{r \cos \phi} \right) - \frac{1}{r \sin \phi} \cdot 0 = \frac{\sec^2 \phi}{r^2 \sin \phi}$$

$$(\nabla \times \mathbf{F})_\phi = \frac{1}{r \sin \phi} \frac{\partial}{\partial \theta} \left( \frac{1}{r \theta} \right) - \frac{1}{r} \frac{\partial}{\partial r} (\cos \phi) = -\frac{1}{r^2 \theta^2 \sin \phi}$$

$$(\nabla \times \mathbf{F})_\theta = \frac{1}{r} \frac{\partial}{\partial r} (1) - \frac{1}{r} \frac{\partial}{\partial \phi} \left( \frac{1}{r \theta} \right) = 0$$

Hence

$$\nabla \times \mathbf{F} = \frac{\sec^2 \phi}{r^2 \sin \phi} \hat{\mathbf{e}}_r - \frac{1}{r^2 \theta^2 \sin \phi} \hat{\mathbf{e}}_\phi$$

## *The Meaning of the Curl*

The preceding discussion may leave you with the feeling that knowing how to define and calculate the curl of some vector function is a far cry from knowing what it is. The fact that the curl has something to do with a line integral *around* a closed path (indeed, the word “curl” itself) may suggest to you that it somehow has to do with things rotating, swirling, or curling around. By means of a few examples taken from fluid motion, we’ll try to make these vague impressions a little clearer.



Suppose water is flowing in circular paths, something like the water draining from a bathtub. A small volume of the water at a point  $(x, y)$  at time  $t$  has coordinates  $x = r \cos \omega t$ ,  $y = r \sin \omega t$ , where  $\omega$  is the constant angular velocity of the water (Figure III-16).<sup>7</sup> Thus, its velocity at  $(x, y)$  is

$$\begin{aligned}\mathbf{v} &= \mathbf{i}(dx/dt) + \mathbf{j}(dy/dt) = r\omega[-\mathbf{i} \sin \omega t + \mathbf{j} \cos \omega t] \\ &= \omega(-\mathbf{i}y + \mathbf{j}x).\end{aligned}$$

This expression gives what is called the velocity field of the water; it tells us the velocity of the water at any point  $(x, y)$ . Your intuition probably tells you that, because the motion is circular, this velocity must have a nonzero curl. In fact, as you can show very easily,

$$\nabla \times \mathbf{v} = 2\mathbf{k}\omega.$$

This result should seem quite reasonable because it says that curl of the velocity is proportional to the angular velocity of the swirling water. We see that  $\nabla \times \mathbf{v}$  is a vector perpendicular to the plane of motion and in the positive  $z$ -direction [Figure III-17(a)]. If the water were rotating around in the other direction, the curl of  $\mathbf{v}$  would then be in the negative  $z$ -direction [Figure III-17(b)]. Note that this is consistent with the right-hand rule (see page 79–80). If

<sup>7</sup> This is not a realistic description of water draining from a tub since rotating water shears tangentially and its angular velocity will therefore vary with  $r$ . The crude description we use here is adequate for our purposes and has the virtue of being simple.





we were to put a small paddle wheel in the water, it would commence spinning because the impinging water would exert a net torque on the paddles (Figure III-18). Furthermore, the paddle wheel would rotate with its axis pointing in the direction of the curl.



Now consider a different velocity field, namely,



where  $v_0$  and  $\lambda$  are constants. Water with such a velocity field would have a flow pattern as indicated in Figure III-19. The velocity at all points is in the positive  $y$ -direction, and its magnitude (indicated by the length of the arrows) varies with  $y$ . Since you see only straight line flow here without any rotational motion, you would probably guess that  $\nabla \times \mathbf{v} = 0$  in this case, and you would be right, as a simple calculation shows. There would be no net torque on a paddle wheel placed anywhere in this flow pattern, and as a consequence, it would not spin.<sup>8</sup>

Our last example is trickier than the two given previously and shows that intuition can lead you astray if you're not careful. Let a velocity field be given by

$$\mathbf{v} = \mathbf{j}v_0 e^{-x^2/\lambda^2}.$$

As in the previous example, the velocity in this case is everywhere in the  $y$ -direction, but now it varies with  $x$ , not  $y$  (Figure III-20). Here, as in the preceding example, you see no evidence of rotational motion and you might guess that  $\nabla \times \mathbf{v} = 0$  once again. But as you should show for yourself,

$$\nabla \times \mathbf{v} = -\mathbf{k}v_0 \frac{2x}{\lambda^2} e^{-x^2/\lambda^2}.$$

A small paddle wheel placed in this flow pattern would spin, even though the water is everywhere moving in the same direction. The

<sup>8</sup> If  $\nabla \times \mathbf{v} = 0$ , the flow is said to be irrotational. Compare with footnote 4.



reason this happens is that the velocity of the water varies with  $x$ , so that it strikes one of the paddles ( $P$  in Figure III-21) with greater velocity than the other ( $P'$ ). Thus, there will be a net torque. In more mathematical terms, the line integral of  $\mathbf{v} \cdot \hat{\mathbf{t}}$  around a small rectangle (Figure III-22) will be different from zero, for while

$$\int_{\text{bottom}} \mathbf{v} \cdot \hat{\mathbf{t}} \, ds = \int_{\text{top}} \mathbf{v} \cdot \hat{\mathbf{t}} \, ds = 0,$$

the contributions from the other two sides are

$$\int_{\text{right}} \mathbf{v} \cdot \hat{\mathbf{t}} \, ds \approx v_y(x + \Delta x) \Delta y$$





and

$$\int_{\text{left}} \mathbf{v} \cdot \hat{\mathbf{t}} \, ds \simeq -v_y(x) \Delta y.$$

These do not cancel because  $v_y(x) \neq v_y(x + \Delta x)$ . Incidentally, you should try to explain to your own satisfaction why in this example  $\nabla \times \mathbf{v}$  is in the negative (positive)  $z$ -direction when  $x$  is positive (negative) and why  $\nabla \times \mathbf{v} = 0$  at  $x = 0$ .

## Differential Form of the Circulation Law

The curl is defined to be the limit of circulation to area. Thus,

$$\hat{\mathbf{n}} \cdot \nabla \times \mathbf{E} = \lim_{\Delta S \rightarrow 0} \frac{1}{\Delta S} \oint_C \mathbf{E} \cdot \hat{\mathbf{t}} \, ds,$$

where  $\hat{\mathbf{n}}$  is a unit vector normal to the surface enclosed by  $C$  at the point about which the curve shrinks to zero. But if  $\mathbf{E}$  is an electrostatic field, then

$$\oint_C \mathbf{E} \cdot \hat{\mathbf{t}} \, ds = 0$$

for any path  $C$ . It follows that

Since the curve  $C$  is arbitrary, we can arrange matters so that  $\hat{\mathbf{n}}$  is a unit vector pointing in any direction we choose. Thus,

- taking  $\hat{\mathbf{n}} = \mathbf{i}$ , we have  $(\nabla \times \mathbf{E})_x = 0$ ;
- taking  $\hat{\mathbf{n}} = \mathbf{j}$ , we have  $(\nabla \times \mathbf{E})_y = 0$ ;
- taking  $\hat{\mathbf{n}} = \mathbf{k}$ , we have  $(\nabla \times \mathbf{E})_z = 0$ .

Thus, all three Cartesian components of  $\nabla \times \mathbf{E}$  vanish, and we can conclude that for an electrostatic field,

$$\nabla \times \mathbf{E} = 0.$$

This is the long-sought-after differential form of the circulation law. We are now in a position to give an alternative and much more tractable answer to the question “Can a given vector function  $\mathbf{F}(x, y, z)$  be an electrostatic field?” The answer is

If  $\nabla \times \mathbf{F} = 0$ , then  $\mathbf{F}$  can be an electrostatic field, and  
if  $\nabla \times \mathbf{F} \neq 0$ , then  $\mathbf{F}$  cannot be an electrostatic field.

This is clearly a much more convenient criterion to apply than our earlier one (page 77), which required us to determine the line integral of  $\mathbf{F}$  over *all* closed paths! To see how it works, let us do several examples.

*Example 1.* Could  $\mathbf{F} = K(\mathbf{i}y + \mathbf{j}x)$  be an electrostatic field? ( $K$  is a constant.) Here we have

$$\begin{aligned} \frac{1}{K} \nabla \times \mathbf{F} &= \mathbf{i} \left( \frac{\partial}{\partial y} 0 - \frac{\partial x}{\partial z} \right) + \mathbf{j} \left( \frac{\partial y}{\partial z} - \frac{\partial}{\partial x} 0 \right) + \mathbf{k} \left( \frac{\partial x}{\partial z} - \frac{\partial y}{\partial x} \right) \\ &= 0 \Rightarrow \nabla \times \mathbf{F} = 0. \end{aligned}$$

*Answer:* Yes.

*Example 2.* Could  $\mathbf{F} = K(\mathbf{i}y - \mathbf{j}x)$  be an electrostatic field? In this case

$$\frac{1}{K} \nabla \times \mathbf{F} = \mathbf{k} \left( -\frac{\partial x}{\partial z} - \frac{\partial y}{\partial x} \right) = -2\mathbf{k} \Rightarrow \nabla \times \mathbf{F} = -2\mathbf{k}K.$$

From these examples we can see how easy this criterion is to apply.

## **Stokes' Theorem**

For the remainder of this chapter we digress from our presentation to discuss another famous theorem, one strongly reminiscent of the divergence theorem and yet, as we'll see, quite different from it. This theorem, named for the mathematician Stokes, relates a line integral around a closed path to a surface integral over what is called a *capping surface* of the path, so the first item on our agenda is to define this term. Suppose we have a closed curve  $C$ , as shown in Figure III-23(a), and imagine that it is made of

wire. Now let us suppose we attach an elastic membrane to the wire as indicated in Figure III-23(b). This membrane is a capping




surface of the curve  $C$ . Any other surface which can be formed by stretching the membrane is also a capping surface; an example is shown in Figure III-23(c). Figure III-24 shows four different capping surfaces of a plane circular path: (a) the region of the





plane enclosed by the circle, (b) a hemisphere with the circle as its rim, (c) the curved surface of a dunce cap (a right circular cone), and (d) the upper and lateral surfaces of a tuna fish can.

With these preliminary remarks in mind, you won't be surprised to see us begin this discussion of Stokes' theorem by considering some closed curve  $C$  and a capping surface  $S$  [Figure III-25(a)]. As we have done before, we approximate this capping



surface by a polyhedron of  $N$  faces, each of which is tangent to  $S$  at some point [Figure III-25(b)]. Note that this will automatically create a polygon [marked  $P$  in Figure III-25(b)] that is an approx-



imation to the curve  $C$ . Let  $\mathbf{F}(x, y, z)$  be a well-behaved vector function defined throughout the region of space occupied by the curve  $C$  and its capping surface  $S$ . Let us form the circulation of  $\mathbf{F}$  around  $C_l$ , the boundary of the  $l$ th face of the polyhedron:

$$\oint_{C_l} \mathbf{F} \cdot \hat{\mathbf{t}} \, ds.$$

If we do this for each of the faces of the polyhedron and then add together all the circulations, we assert that this sum will be equal to the circulation of  $\mathbf{F}$  around the polygon  $P$ :

$$\sum_{l=1}^N \oint_{C_l} \mathbf{F} \cdot \hat{\mathbf{t}} \, ds = \oint_P \mathbf{F} \cdot \hat{\mathbf{t}} \, ds. \quad (\text{III-9})$$

This is easy to prove. Consider two adjacent faces as shown in Figure III-26. The circulation about the face on the left [Figure III-26(a)] includes a term from the segment  $AB$ , which is  $\int_A^B \mathbf{F} \cdot \hat{\mathbf{t}} \, ds$ . But the segment  $AB$  is common to both faces, and its contribution to the circulation around the *right*-hand face [Figure III-26(b)] is

$$\int_B^A \mathbf{F} \cdot \hat{\mathbf{t}} \, ds = - \int_A^B \mathbf{F} \cdot \hat{\mathbf{t}} \, ds.$$




We see that we traverse the common segment  $AB$  one way as part of the boundary of the left-hand face, and the other way as part of the boundary of the right-hand face. Thus, when we add the circulations of  $\mathbf{F}$  over the two faces, the segment  $AB$  contributes

$$\int_A^B \mathbf{F} \cdot \hat{\mathbf{t}} \, ds + \int_B^A \mathbf{F} \cdot \hat{\mathbf{t}} \, ds = 0.$$

It is clear that any segment common to two adjacent faces contributes nothing to the sum in Equation (III-9) because such segments always give rise to pairs of canceling terms. But *all* segments are common to pairs of adjacent faces except those that, taken together, constitute the polygon  $P$ . This establishes Equation (III-9).

Now we go through an analysis very similar to that which yielded the divergence theorem. We write

$$\begin{aligned} \oint_P \mathbf{F} \cdot \hat{\mathbf{t}} \, ds &= \sum_{l=1}^N \oint_{C_l} \mathbf{F} \cdot \hat{\mathbf{t}} \, ds \\ &= \sum_{l=1}^N \left[ \frac{1}{\Delta S_l} \oint_{C_l} \mathbf{F} \cdot \hat{\mathbf{t}} \, ds \right] \Delta S_l, \end{aligned} \quad (\text{III-10})$$

where  $\Delta S_l$  is the area of the  $l$ th face. The quantity in the square brackets is, approximately, equal to  $\hat{\mathbf{n}}_l \cdot (\nabla \times \mathbf{F})_l$  where  $\hat{\mathbf{n}}_l$  is the unit positive normal on the  $l$ th face and  $(\nabla \times \mathbf{F})_l$  is the curl of the vector function  $\mathbf{F}$  evaluated at the point on the  $l$ th face at which it is tangent to  $S$ . We say “approximately” because it is actually the *limit* as  $\Delta S_l$  tends to zero of the bracketed quantity in Equation (III-10), which is to be identified as  $\hat{\mathbf{n}}_l \cdot (\nabla \times \mathbf{F})_l$ . Ignoring this lack of rigor, we write

$$\begin{aligned} \lim_{\substack{N \rightarrow \infty \\ \text{each } \Delta S_l \rightarrow 0}} \sum_{l=1}^N \left[ \frac{1}{\Delta S_l} \oint_{C_l} \mathbf{F} \cdot \hat{\mathbf{t}} \, ds \right] \Delta S_l \\ = \lim_{\substack{N \rightarrow \infty \\ \text{each } \Delta S_l \rightarrow 0}} \sum_{l=1}^N \hat{\mathbf{n}}_l \cdot (\nabla \times \mathbf{F})_l \Delta S_l \\ = \iint_S \hat{\mathbf{n}} \cdot \nabla \times \mathbf{F} \, dS. \end{aligned} \quad (\text{III-11})$$

Since the curve  $C$  is the limiting shape of the polygon  $P$ , we also have

$$\lim_{\substack{N \rightarrow \infty \\ \text{each } \Delta S_l \rightarrow 0}} \oint_P \mathbf{F} \cdot \hat{\mathbf{t}} \, ds = \oint_C \mathbf{F} \cdot \hat{\mathbf{t}} \, ds. \quad (\text{III-12})$$

**Stokes' Theorem**

Combining Equations (III-10), (III-11), and (III-12), we arrive, finally, at Stokes' theorem:

$$\oint_C \mathbf{F} \cdot \hat{\mathbf{t}} \, ds = \iint_S \hat{\mathbf{n}} \cdot \nabla \times \mathbf{F} \, dS, \quad (\text{III-13})$$

where  $S$  is *any* surface capping the curve  $C$ . Thus, in words, Stokes' theorem says that the line integral of the tangential component of a vector function over some closed path equals the surface integral of the normal component of the curl of that function integrated over any capping surface of the path. Stokes' theorem holds for any vector function  $\mathbf{F}$  that is continuous and differentiable and has continuous derivatives on  $C$  and  $S$ .

Let's work an example. Take  $\mathbf{F}(x, y, z) = \mathbf{i}z + \mathbf{j}x - \mathbf{k}x$ , with  $C$  the circle of radius 1 centered at the origin and lying in the  $xy$ -plane, and  $S$  the part of the  $xy$ -plane enclosed by the circle [see Figure III-27(a)]. Now

$$\mathbf{F} \cdot \hat{\mathbf{t}} \, ds = z \, dx + x \, dy - x \, dz.$$



Thus,  $\oint_C \mathbf{F} \cdot \hat{\mathbf{t}} \, ds = \oint x \, dy$ . Heretofore we have always parametrized curves with the arc length  $s$ . In this situation, however, the path  $C$  is most easily parametrized in terms of the angle  $\theta$  shown in Figure III-27(b). Thus, we write

$$\oint x \, dy = \oint x \frac{dy}{d\theta} d\theta = \int_0^{2\pi} \cos^2 \theta \, d\theta = \pi, \quad (\text{III-14})$$



Next we calculate

$$\nabla \times \mathbf{F} = \begin{vmatrix} \mathbf{i} & \mathbf{j} & \mathbf{k} \\ \partial/\partial x & \partial/\partial y & \partial/\partial z \\ z & x & -x \end{vmatrix} = 2\mathbf{j} + \mathbf{k}$$

The capping surface here is a portion of the  $xy$ -plane, so that the unit normal in the positive direction is  $\hat{\mathbf{n}} = \mathbf{k}$ . Thus,

$$\hat{\mathbf{n}} \cdot \nabla \times \mathbf{F} = \mathbf{k} \cdot (2\mathbf{j} + \mathbf{k}) = 1$$

and

$$\iint_S \hat{\mathbf{n}} \cdot \nabla \times \mathbf{F} \, dS = \iint_S dS = \pi, \quad (\text{III-15})$$

where this last equality follows from the fact that the surface integral in this case is merely the area of the unit circle. Since this result [Equation (III-15)] is identical with the one obtained above [Equation (III-14)], we have illustrated Stokes' theorem [Equation (III-13)].

Let's redo this calculation, this time choosing the hemisphere shown in Figure III-27(c) as our capping surface  $S$ . Using Equation (II-13) with  $\mathbf{F}$  replaced by  $\nabla \times \mathbf{F}$ , we get

$$\begin{aligned} \iint_S \hat{\mathbf{n}} \cdot \nabla \times \mathbf{F} \, dS &= \iint_R \left[ -2\left(-\frac{y}{z}\right) + 1 \right] dx \, dy \\ &= 2 \iint_R \frac{y}{z} dx \, dy + \iint_R dx \, dy \end{aligned}$$




where  $R$  is the unit circle in the  $xy$ -plane shown in Figure III-27(a). The second integral in the right-most equality above is just the area of that circle, and so its value is  $\pi$ . The first integral can be handled by introducing polar coordinates. We find

$$\begin{aligned} 2 \iint_R \frac{y}{z} dx dy &= 2 \iint_R \frac{y dx dy}{\sqrt{1 - x^2 - y^2}} \\ &= 2 \int_0^{2\pi} \int_0^1 \frac{r \sin \theta \ r dr d\theta}{\sqrt{1 - r^2}} = 2 \int_0^{2\pi} \sin \theta \ d\theta \int_0^1 \frac{r^2 dr}{\sqrt{1 - r^2}}. \end{aligned}$$

It's easy to show that the integral over  $\theta$  is zero. Hence  $\iint_S \hat{\mathbf{n}} \cdot \nabla \times \mathbf{F} dS = \pi$ , consistent with our earlier result.

## An Application of Stokes' Theorem

An important application of Stokes' theorem is provided by Ampère's circuital law. Consider any closed loop  $C$  enclosing a current  $I$  as in Figure III-28. Note that the direction of  $C$  and that of  $I$  correspond to the same right-hand rule that relates the directions of  $C$  and the positive normal to a surface capping  $C$ . Ampère's



circuital law says that the line integral of the *magnetic field*  $\mathbf{B}$  is related to the current thus:

$$\oint_C \mathbf{B} \cdot \hat{\mathbf{t}} \, ds = \mu_0 I$$

where the constant  $\mu_0$ , called the permeability of free space, has the value  $1.257 \times 10^{-6}$  newtons per ampere<sup>2</sup>. This law, like Gauss' law and the circulation law, says something about the integral of a field (the magnetic field in this case), and just as in the two previous cases, it is convenient to re-express it so that it will tell us something about the field at a point. To this end, we first introduce the current density  $\mathbf{J}$  (see page 52). Thus, if current is flowing through an area  $\Delta S$  with normal  $\hat{\mathbf{n}}$  (Figure III-29), the current density  $\mathbf{J}$  is such that

$$\Delta I = \mathbf{J} \cdot \hat{\mathbf{n}} \, \Delta S,$$



where  $\Delta I$  is the total current. That is, current density is a vector function whose magnitude is the current per unit area and whose direction is that of the current flow. If  $\mathbf{J}(x, y, z)$  is the current density, then the total current flowing through a surface  $S$  is

$$\iint_S \mathbf{J} \cdot \hat{\mathbf{n}} \, dS.$$

Thus, Ampère's law can be written

$$\oint_C \mathbf{B} \cdot \hat{\mathbf{t}} \, ds = \mu_0 \iint_S \mathbf{J} \cdot \hat{\mathbf{n}} \, dS.$$

$S$  can be any surface capping the curve  $C$ . If, as is usually the case, the current flows through a wire the cross section of which



does not include the entire capping surface, it does not matter; we can integrate over more than the wire cross section if we remember that  $\mathbf{J} \neq 0$  for that part of the surface  $S$  cut by the wire and  $\mathbf{J} = 0$  for the rest (Figure III-30). Thus,

$$\iint_{\text{cross section of wire}} \mathbf{J} \cdot \hat{\mathbf{n}} \, dS = \iint_{\text{entire capping surface } S} \mathbf{J} \cdot \hat{\mathbf{n}} \, dS.$$

Now using Stokes' theorem [Equation (III-13)], we have

$$\oint_C \mathbf{B} \cdot \hat{\mathbf{t}} \, dS = \iint_S \hat{\mathbf{n}} \cdot \nabla \times \mathbf{B} \, dS = \mu_0 \iint_S \hat{\mathbf{n}} \cdot \mathbf{J} \, dS.$$

Since  $C$  and  $S$  are arbitrary, we conclude that

$$\nabla \times \mathbf{B} = \mu_0 \mathbf{J}.$$

This is the differential form of Ampère's law. It is also a special case of one of Maxwell's equations, valid when the fields do not vary with time.

## *Stokes' Theorem and Simply Connected Regions*

For many purposes, including some important applications, we must be able to assert that Stokes' theorem holds throughout some region  $D$  in three-dimensional space. By this we mean that we want the theorem to hold for any closed curve  $C$  lying entirely in  $D$  and any capping surface of  $C$  also lying entirely in  $D$ . This, of course, means the function  $\mathbf{F}$  must be continuous and differentiable and have continuous first derivatives in  $D$ . But in addition we must impose a restriction on the region  $D$  itself. To understand

how this comes about, suppose first that  $D$  is the interior of a sphere. If  $\mathbf{F}$  is smooth<sup>9</sup> everywhere in  $D$ , then Stokes' theorem holds for any closed curve  $C$  lying entirely in  $D$ , and any capping surface of  $C$  also lying entirely in  $D$ . In other words, Stokes' theorem holds everywhere in  $D$ . A little thought should convince you that the same line of reasoning applies to the region between two concentric spheres, provided  $\mathbf{F}$  is smooth in that region. But for certain kinds of regions, troubles can arise. As an example, suppose  $D$  is the interior of a torus (roughly like a bagel or an inflated inner tube; see Figure III-31). The problem in this case is that it's



possible to construct a closed curve in  $D$  like the one shown in the figure with the property that none of its capping surfaces lies entirely in  $D$ . Although we insist that  $\mathbf{F}$  be smooth in  $D$ , no conditions are imposed upon it elsewhere, so that outside the region it may not fulfill the requirements of smoothness that ensure the validity of Stokes' theorem. The relation between the line integral over  $C$  and the surface integral over  $S$  asserted by the theorem can, and in many cases does, break down if  $\mathbf{F}$  is not smooth on  $S$ .

Mathematicians refer to regions such as the interior of a sphere or the space between two concentric spheres as *simply connected*, whereas the interior of a torus is not simply connected. By definition, a region  $D$  is simply connected if any closed curve lying entirely in  $D$  can shrink down to a point without leaving  $D$ . Using this definition, you should be able to verify that the interior of a sphere and the region between two concentric spheres are both simply connected, but that the interior of a torus is not. With the concept of simple connectedness available to us, we can easily specify the conditions under which Stokes' theorem holds throughout a region: The vector function  $\mathbf{F}$  must

be smooth everywhere in a *simply connected* region  $D$ . Then Stokes' theorem [Equation (III-13)] is valid for any closed curve  $C$  and any capping surface  $S$  of  $C$ , both of which lie entirely in  $D$ .

Most of the time we'll assume that the functions we work with are smooth and that the regions of interest are simply connected. There are situations, however, like the one discussed in the next section, where simple connectedness plays an essential role, and we'll point them out as we come to them.

## *Path Independence and the Curl*

In our discussion of the differential form of the circulation law, we showed that because the line integral of an electrostatic field  $\mathbf{E}$  is zero over any closed path, the curl of  $\mathbf{E}$  is zero. The same is true of any vector function  $\mathbf{F}$ ; that is, if

$$\oint_C \mathbf{F} \cdot \hat{\mathbf{t}} \, ds = 0$$

for all closed paths  $C$ , then

$$\nabla \times \mathbf{F} = 0.$$

The proof of this fact is precisely the same as the one given on pages 90–91 with  $\mathbf{E}$  replaced everywhere by  $\mathbf{F}$ .

Is the converse of this statement also true? That is, if  $\nabla \times \mathbf{F} = 0$ , does this imply that the circulation of  $\mathbf{F}$  is zero over all closed paths? At first glance it might appear that the answer to this question is yes. All we have to do is use Stokes' theorem and observe that since by assumption  $\nabla \times \mathbf{F} = 0$ ,

$$\oint_C \mathbf{F} \cdot \hat{\mathbf{t}} \, ds = \iint_S \hat{\mathbf{n}} \cdot \nabla \times \mathbf{F} \, dS = 0.$$

However, there is a flaw in this line of reasoning. Recall that the validity of Stokes' theorem requires that  $\mathbf{F}$  be smooth *in a simply connected region*. If the region is not simply connected, Stokes' theorem may not hold, at least for some closed paths lying in the region, and the fact that  $\nabla \times \mathbf{F} = 0$  does not guarantee that the circulation of  $\mathbf{F}$  is zero over all closed paths. The closest we can come to a converse is to say that if  $\nabla \times \mathbf{F} = 0$  *everywhere in a*

*simply connected region*, then the circulation of  $\mathbf{F}$  is zero for all closed paths in that region. The two statements “circulation equals zero” and “curl equals zero” are equivalent only in a simply connected region.

There is a slightly different, but often useful, way to state this connection between circulation and curl; namely, if  $\int_C \mathbf{F} \cdot \hat{\mathbf{t}} \, ds$  is independent of path, then  $\nabla \times \mathbf{F} = 0$ , and if  $\nabla \times \mathbf{F} = 0$  in a simply connected region, then  $\int_C \mathbf{F} \cdot \hat{\mathbf{t}} \, ds$  is independent of path. You should have no difficulty in establishing this for yourself.


## PROBLEMS

**III-1** Use an argument like the one given in the text for the Coulomb force (pages 71–73) to show that  $\int_C \mathbf{F} \cdot \hat{\mathbf{t}} \, ds$  is independent of path for any central force  $\mathbf{F}$ .

**III-2** In the text we obtained the result

$$(\nabla \times \mathbf{F})_z = \frac{\partial F_y}{\partial x} - \frac{\partial F_x}{\partial y}$$

by integrating over a small rectangular path. As an example of the fact that this result is independent of the path, rederive it, using the triangular path shown in the figure.



**III-3** Calculate the curl of each of the following functions using Equation (III-7b):

- $\mathbf{i}z^2 + \mathbf{j}x^2 - \mathbf{k}y^2$ .
- $3\mathbf{i}xz - \mathbf{k}x^2$ .


## Problems

**III-4** (a) Calculate  $\oint \mathbf{F} \cdot \hat{\mathbf{t}} \, ds$  for the function in Problem III-3(a) over a square path of side  $s$  centered at  $(x_0, y_0, 0)$ , lying in the  $xy$ -plane, and oriented so that each side is parallel to the  $x$ - or  $y$ -axis.  
 (b) Divide the result of part (a) by the area of the square and take the limit of the quotient as  $s \rightarrow 0$ . Compare your result with the  $z$ -component of the curl found in Problem III-3(a).  
 (c) Repeat parts (a) and (b) for the functions in Problem III-3(b), (c), and (d). (You may find it interesting to try paths of different orientations and/or shapes.)

**III-5** (a) Calculate  $\oint \mathbf{F} \cdot \hat{\mathbf{t}} \, ds$  where

$$\mathbf{F} = \mathbf{k}(y + y^2)$$

over the perimeter of the triangle shown in the figure (integrate in the direction indicated by the arrows).



(b) Divide the result of part (a) by the area of the triangle and take the limit as  $a \rightarrow 0$ .  
 (c) Show that the result of part (b) is  $\hat{\mathbf{n}} \cdot \nabla \times \mathbf{F}$  evaluated at  $(0, 0, 0)$  where  $\hat{\mathbf{n}}$  is the unit vector normal to the triangle and directed away from the origin.

**III-6** Show that

$$\nabla \times \frac{\mathbf{A} \times \mathbf{r}}{2} = \mathbf{A},$$

where  $\mathbf{r} = \mathbf{i}x + \mathbf{j}y + \mathbf{k}z$  and  $\mathbf{A}$  is a constant vector.













*III-17* (a) Consider the function given in cylindrical coordinates by

$$\mathbf{F}(r, \theta, z) = \frac{\hat{\mathbf{e}}_\theta}{r}.$$

Show that Stokes' theorem does not hold for this function if  $C$  is the circle of radius  $R$  in the  $xy$ -plane centered at the origin, and  $S$  is the portion of the  $xy$ -plane enclosed by  $C$ . Why does the theorem fail in this case?

(b) Consider the region  $D$  that consists of all of three-dimensional space with the  $z$ -axis removed. Is the function  $\mathbf{F}$  defined in (a) smooth in  $D$ ? Does Stokes' theorem hold in  $D$ ? Is  $D$  a simply connected region?

*III-18* The electromotive force  $\mathcal{E}$  in a circuit  $C$  is equal to the circulation of the electric field  $\mathbf{E}$  around the circuit:

$$\mathcal{E} = \oint_C \mathbf{E} \cdot \hat{\mathbf{t}} \, ds.$$

Faraday discovered that in a stationary circuit an electromotive force is induced by a changing magnetic flux. That is,

$$\mathcal{E} = -\frac{d\Phi}{dt},$$

where

$$\Phi = \iint_S \mathbf{B} \cdot \hat{\mathbf{n}} \, dS,$$

$t$  is time (don't confuse it with the tangent vector  $\hat{\mathbf{t}}$ ), and  $S$  is any capping surface of  $C$ . Use this information and Stokes' theorem to derive the equation

$$\nabla \times \mathbf{E} = -\frac{\partial \mathbf{B}}{\partial t},$$

which is one of Maxwell's equations.

*III-19* Determine the value of the line integral  $\int_C \mathbf{F} \cdot \hat{\mathbf{t}} \, ds$ , where

$$\mathbf{F} = (e^{-y} - ze^{-x})\mathbf{i} + (e^{-z} - xe^{-y})\mathbf{j} + (e^{-x} - ye^{-z})\mathbf{k}$$

and  $C$  is the path

$$\left. \begin{aligned} x &= \frac{1}{\ln 2} \ln(1+p), \\ y &= \sin \frac{\pi p}{2}, \\ z &= \frac{1-e^p}{1-e}, \end{aligned} \right\} \quad 0 \leq p \leq 1$$

*III-20* Maxwell's equations are

$$\nabla \cdot \mathbf{E} = \rho/\epsilon_0, \quad \nabla \cdot \mathbf{B} = 0,$$

$$\nabla \times \mathbf{E} = -\frac{\partial \mathbf{B}}{\partial t}, \quad \text{and} \quad \nabla \times \mathbf{B} = \epsilon_0 \mu_0 \frac{\partial \mathbf{E}}{\partial t} + \mu_0 \mathbf{J},$$

where  $\mathbf{E}$  is the electric field,  $\mathbf{B}$  the magnetic field,  $\rho$  the charge density, and  $\mathbf{J}$  the current density. Use Maxwell's equations to derive the continuity equation

$$\nabla \cdot \mathbf{J} + \frac{\partial \rho}{\partial t} = 0.$$

Interpret this equation.

*III-21* The electromagnetic field stores energy, and it is possible to show that in a volume  $V$  the amount of electromagnetic energy is

$$\iiint_V \rho_E dV,$$

where the energy density

$$\rho_E = \frac{1}{2}(\epsilon_0 \mathbf{E} \cdot \mathbf{E} + \mathbf{B} \cdot \mathbf{B}/\mu_0) = \frac{1}{2}(\epsilon_0 E^2 + B^2/\mu_0).$$

Use Maxwell's equations (see Problem III-20) to show that

$$\frac{\partial \rho_E}{\partial t} + \nabla \cdot \left( \frac{\mathbf{E} \times \mathbf{B}}{\mu_0} \right) = -\mathbf{J} \cdot \mathbf{E}.$$

Interpret this equation.


*III-22 (a)* Apply the divergence theorem to the function

$$\mathbf{G}(x, y) = \mathbf{i}G_x(x, y) + \mathbf{j}G_y(x, y),$$

using for  $V$  and  $S$  the volume and surface shown in the diagram; its bottom is a region  $R$  of the  $xy$ -plane, its top has the same shape as, and is parallel to, the bottom, and its side is parallel to the  $z$ -axis. In this way obtain the relation

$$\oint_C G_x dy - G_y dx = \iint_R \left( \frac{\partial G_x}{\partial x} + \frac{\partial G_y}{\partial y} \right) dx dy,$$

which is the divergence theorem in two dimensions.



(b) Apply Stokes' theorem to the function

$$\mathbf{F}(x, y) = \mathbf{i}F_x(x, y) + \mathbf{j}F_y(x, y)$$

using for  $C$  a closed curve lying entirely in the  $xy$ -plane and for  $S$  the region  $R$  of the  $xy$ -plane enclosed by  $C$ . In this way obtain the relation

$$\oint_C F_x \, dx + F_y \, dy = \iint_R \left( \frac{\partial F_y}{\partial x} - \frac{\partial F_x}{\partial y} \right) dx \, dy,$$

which is Stokes' theorem in two dimensions.

(c) Show that in two dimensions the divergence theorem and Stokes' theorem are identical.

*III-23* (a) Let  $C$  be a closed curve lying in the  $xy$ -plane. What condition must the function  $\mathbf{F}$  satisfy in order that

$$\oint_C \mathbf{F} \cdot \hat{\mathbf{t}} \, ds = A,$$

where  $A$  is the area enclosed by  $C$ ? [Hint: See Problem III-22.]

(b) Give some examples of functions  $\mathbf{F}$  having the property described in (a).

(c) Use line integrals to find formulas for the area of

- (i) a rectangle.
- (ii) a right triangle.
- (iii) a circle.

(d) Show that the area enclosed by the plane curve  $C$  is the magnitude of

$$\frac{1}{2} \oint_C \mathbf{r} \times \hat{\mathbf{t}} \, ds,$$

where  $\mathbf{r} = \mathbf{i}x + \mathbf{j}y$ .

*III-24* (a) There is an important theorem in vector calculus that says  $\nabla \cdot \mathbf{G} = 0$  (where  $\mathbf{G}$  is some differentiable vector function) implies and is implied by  $\mathbf{G} = \nabla \times \mathbf{H}$  (where  $\mathbf{H}$  is another differentiable function). To prove this we note first of all that  $\mathbf{G} = \nabla \times \mathbf{H}$  implies that  $\nabla \cdot \mathbf{G} = 0$  (see Problem III-7). To show that  $\nabla \cdot \mathbf{G} = 0$  implies that we can write  $\mathbf{G} = \nabla \times \mathbf{H}$ , the simplest procedure is to give  $\mathbf{H}$ :

$$H_x = 0,$$

$$H_y = \int_{x_0}^x G_z(x', y, z) \, dx',$$

$$H_z = - \int_{x_0}^x G_y(x', y, z) \, dx' + \int_{y_0}^y G_x(x_0, y', z) \, dy',$$

where  $x_0$  and  $y_0$  are arbitrary constants. Show by direct calculation that if  $\nabla \cdot \mathbf{G} = 0$ , then  $\mathbf{G} = \nabla \times \mathbf{H}$ .


(b) Is the vector function  $\mathbf{H}$  specified in (a) unique? That is, can we alter it in any way without invalidating the relation  $\mathbf{G} = \nabla \times \mathbf{H}$ ?

- (d)  $\mathbf{G} = 2\mathbf{i}x - \mathbf{j}y - \mathbf{k}z$ .
- (e)  $\mathbf{G} = 2\mathbf{i}x - \mathbf{j}y + \mathbf{k}z$ .

**III-26** Since the divergence of any magnetic field  $\mathbf{B}$  is zero, we can write  $\mathbf{B} = \nabla \times \mathbf{A}$  (see Problem III-24). **III-27** Prove the statement made in Problem III-24(a) by applying Stokes' theorem and the divergence theorem. [Hint: See the diagram below.]



**III-28** (a) What is the integral form of the equation  $\mathbf{G} = \nabla \times \mathbf{H}$ ? [Hint: Compare the differential and integral forms of Ampère's circuital law.]  
 (b) Verify your result in part (a) using for  $\mathbf{G}$  and  $\mathbf{H}$  functions selected from Problem III-25, and paths and surfaces of integration of your own choice.

**III-29** In the text we defined the curl as the limit of a certain ratio. An alternative definition is provided by the equation

$$\nabla \times \mathbf{F} = \lim_{\Delta V \rightarrow 0} \frac{1}{\Delta V} \iint_S \hat{\mathbf{n}} \times \mathbf{F} dS,$$

where  $\mathbf{F}$  is a vector function of position, the integration is carried out over a closed surface  $S$  which encloses the volume  $\Delta V$ , and  $\hat{\mathbf{n}}$  is the unit vector normal to  $S$  pointing outward from the enclosed volume. (This definition does not display the geometric significance of the curl as well as the one given in the text. Nonetheless, in one respect at least it may be preferable: it gives the  $\nabla \times \mathbf{F}$  rather than just a component of it.)

- (a) Following a procedure similar to the one used in the text in treating the divergence, integrate over a “cuboid” and show that the definition given above yields Equation (III-7b).


## Problems

(b) Arguing as we did in the text in establishing the divergence theorem, use the above expression for the curl to derive the equation

$$\iint_S \hat{\mathbf{n}} \times \mathbf{F} dS = \iiint_V \nabla \times \mathbf{F} dV,$$

where  $V$  is the volume enclosed by  $S$ .

(c) Derive the equation of part (b) directly from the divergence theorem. [Hint: In the divergence theorem [Equation (II-30)] replace  $\mathbf{F}$  by  $\mathbf{e} \times \mathbf{F}$ , where  $\mathbf{e}$  is an arbitrary constant vector.]  
 (d) Verify the equation of part (b) for  $\mathbf{F} = iy - jz + kx$  and  $V$  the unit cube shown in the figure.




### III-30 The result

$$(\nabla \times \mathbf{F})_z = \frac{\partial F_y}{\partial x} - \frac{\partial F_x}{\partial y}$$

has been established by calculating the circulation of  $\mathbf{F}$  around a rectangle (see the text, pages 75 ff.) and around a right triangle (see Problem III-2). In this problem you will show that the result holds when the circulation is calculated around *any* closed curve lying in the  $xy$ -plane.

(a) Approximate an arbitrary closed curve  $C$  in the  $xy$ -plane by a polygon  $P$  as shown in the figure. Subdivide the area enclosed by  $P$  into  $N$  patches of which the  $l$ th has area  $\Delta S_l$ . Convince yourself by means of a sketch that this subdivision can be made with only two kinds of patches: rectangles and right triangles.



(b) Letting  $C(x, y) = \partial F_y / \partial x - \partial F_x / \partial y$ , use Taylor series to show that for  $N$  large and each  $\Delta S_l$  small,

$$\begin{aligned} \oint_P \mathbf{F} \cdot \hat{\mathbf{t}} \, ds &= \sum_{l=1}^N \oint_{C_l} \mathbf{F} \cdot \hat{\mathbf{t}} \, ds \\ &\cong C(x_0, y_0) \Delta A + \left( \frac{\partial C}{\partial x} \right)_{x_0, y_0} \sum_{l=1}^N (x_l - x_0) \Delta S_l \\ &\quad + \left( \frac{\partial C}{\partial y} \right)_{x_0, y_0} \sum_{l=1}^N (y_l - y_0) \Delta S_l + \dots, \end{aligned}$$

where  $C_l$  is the perimeter of the  $l$ th patch,  $(x_0, y_0)$  is some point in the region enclosed by  $P$ , and  $\Delta A$  is the area enclosed by  $P$ .

(c) Show that

$$\begin{aligned} \lim_{\substack{N \rightarrow \infty \\ \text{each } \Delta S_l \rightarrow 0}} \oint_P \mathbf{F} \cdot \hat{\mathbf{t}} \, ds &= \oint_C \mathbf{F} \cdot \hat{\mathbf{t}} \, ds \\ &= \left[ C(x_0, y_0) + (\bar{x} - x_0) \left( \frac{\partial C}{\partial x} \right)_{x_0, y_0} \right. \\ &\quad \left. + (\bar{y} - y_0) \left( \frac{\partial C}{\partial y} \right)_{x_0, y_0} + \dots \right] \Delta S, \end{aligned}$$

where  $\Delta S$  is the area of the region  $R$  enclosed by  $C$  and  $(\bar{x}, \bar{y})$  are the coordinates of the centroid of the region  $R$ ; that is,

$$\bar{x} = \frac{1}{\Delta S} \iint_R x \, dx \, dy \quad \text{and} \quad \bar{y} = \frac{1}{\Delta S} \iint_R y \, dx \, dy.$$

(d) Finally, calculate

$$(\nabla \times \mathbf{F})_z = \lim_{\substack{\Delta S \rightarrow 0 \\ \text{about } x_0, y_0}} \frac{1}{\Delta S} \oint_C \mathbf{F} \cdot \hat{\mathbf{t}} \, ds.$$

## *Chapter IV*

# The Gradient

*For mostly they goes up and down . . .*

*P. R. Chalmers*

## *Line Integrals and the Gradient*

We have now investigated the relationship between the following two statements:

1.  $\oint_C \mathbf{F} \cdot \hat{\mathbf{t}} \, ds = 0$  for any closed curve  $C$ .
2.  $\nabla \times \mathbf{F} = 0$ .

We saw in the last chapter that the first of these statements implies the second and is equivalent to the assertion that the line integral of  $\mathbf{F} \cdot \hat{\mathbf{t}}$  is independent of the path. We also saw that the second statement implies the first if  $\mathbf{F}$  is smooth in a simply connected region. You might think that two ways of saying something would be enough, but there is a *third* way, as we shall now see.

Let us suppose that a given vector function  $\mathbf{F}(x, y, z)$  has associated with it a scalar function  $\psi(x, y, z)$  and that the two functions are related as follows:

$$F_x = \frac{\partial \psi}{\partial x}, \quad F_y = \frac{\partial \psi}{\partial y}, \quad \text{and} \quad F_z = \frac{\partial \psi}{\partial z}. \quad (\text{IV-1})$$

If the preceding relations hold, then the line integral of  $\mathbf{F} \cdot \hat{\mathbf{t}}$  is independent of path. To show this, we use the three relations given in Equation (IV-1) and the formula for the unit tangent vector to get

$$\mathbf{F} \cdot \hat{\mathbf{t}} = \frac{\partial \psi}{\partial x} \frac{dx}{ds} + \frac{\partial \psi}{\partial y} \frac{dy}{ds} + \frac{\partial \psi}{\partial z} \frac{dz}{ds} = \frac{d\psi}{ds}$$

where the second equality follows from a familiar chain rule of multivariate calculus. Suppose now that the path  $C$  joins the two points  $(x_0, y_0, z_0)$  and  $(x_1, y_1, z_1)$ . Then

$$\begin{aligned} \int_C \mathbf{F} \cdot \hat{\mathbf{t}} \, ds &= \int_C \frac{d\psi}{ds} \, ds = \int_C d\psi \\ &= \psi(x_1, y_1, z_1) - \psi(x_0, y_0, z_0). \end{aligned}$$

You can see that this result depends only on the points at which the path  $C$  begins and ends. We'd get the same result for *any* path joining these two points. This proves our assertion: with  $\mathbf{F}$  and  $\psi$  related as in Equations (IV-1), the line integral of  $\mathbf{F} \cdot \hat{\mathbf{t}}$  is independent of path. We shall now show that the converse of this statement is also true; that is, if the line integral of  $\mathbf{F} \cdot \hat{\mathbf{t}}$  is independent of path, there is a scalar function  $\psi(x, y, z)$  related to  $\mathbf{F}$  as specified in Equations (IV-1).

We begin with the observation that, because the line integral  $\int_C \mathbf{F} \cdot \hat{\mathbf{t}} \, ds$  is independent of path, if we integrate from some *fixed* point  $P_0(x_0, y_0, z_0)$  to a second point  $P(x, y, z)$ , the result is a scalar function of the coordinates  $(x, y, z)$ :

$$\psi(x, y, z) = \int_{(x_0, y_0, z_0)}^{(x, y, z)} \mathbf{F} \cdot \hat{\mathbf{t}} \, ds. \quad (\text{IV-2})$$

It is important to understand that this would not be true if the integral depended on path, for then its value would depend not only on the coordinates  $(x, y, z)$  of the point  $P$  but also on the path joining  $P_0$  and  $P$ , and the integral would not then be a function within the standard definition of the term.

Since the integral we're examining is path independent, we are free to select any curve as the path of integration. We choose the one shown in Figure IV–1. It consists of two parts. The first,  $C_0$ ,



connects  $P_0$  to an intermediate point  $P_1$  whose coordinates are  $(a, y, z)$ , where  $a$  is some constant. Beyond fixing its two end points and requiring it to be reasonably smooth, we do not need to specify anything more about  $C_0$ . The second part of the curve,  $C_1$ , is the straight-line segment from  $P_1$  to  $P$ . Thus, Equation (IV–2) becomes

$$\psi(x, y, z) = \int_{P_0}^{P_1} \mathbf{F} \cdot \hat{\mathbf{t}} \, ds + \int_{P_1}^P F_x(x', y, z) \, dx'.$$

The first term on the right-hand side of this equation is independent of the variable  $x$ . The second term is, effectively, nothing more than an ordinary one-dimensional integral, since  $y$  and  $z$  are constant on  $C_1$  and just come along for the ride. That is,

$$\int_{P_1}^P F_x(x', y, z) \, dx' = \int_a^x F_x(x', y = \text{const.}, z = \text{const.}) \, dx',$$

and so

$$\begin{aligned} \frac{\partial \psi}{\partial x} &= \frac{d}{dx} \int_a^x F_x(x', y = \text{const.}, z = \text{const.}) \, dx' \\ &= F_x(x, y, z), \end{aligned}$$

where we use the fact that the derivative of an integral with respect to its upper limit is merely the integrand evaluated at that

limit. This establishes one of the three relations we sought. The other two,  $F_y = \partial\psi/\partial y$  and  $F_z = \partial\psi/\partial z$ , can be obtained by the same sort of reasoning, and you should carry out the derivations yourself. Figure IV-2(a) and (b) will be helpful.





You have probably recognized by now that we have here another use for the del notation. That is,

$$F_x = \frac{\partial\psi}{\partial x}, \quad F_y = \frac{\partial\psi}{\partial y}, \quad \text{and} \quad F_z = \frac{\partial\psi}{\partial z}$$

can be combined to give

$$\begin{aligned} \mathbf{F} &= \mathbf{i} \frac{\partial\psi}{\partial x} + \mathbf{j} \frac{\partial\psi}{\partial y} + \mathbf{k} \frac{\partial\psi}{\partial z} \\ &= \left( \mathbf{i} \frac{\partial}{\partial x} + \mathbf{j} \frac{\partial}{\partial y} + \mathbf{k} \frac{\partial}{\partial z} \right) \psi = \nabla\psi, \end{aligned}$$

which is read “del psi.” This operator is called the *gradient* and is sometimes written  $\text{grad}\psi$ . However, we shall always write  $\nabla\psi$  in keeping with modern usage. The gradient of  $\psi$  is a *vector function* of position. Its geometric significance will be discussed in detail later.

We have now established the relationship between path independence and the existence of a scalar function  $\psi(x, y, z)$  such that  $\mathbf{F} = \nabla\psi$ . Since there is also a relationship between path independence and the fact that  $\nabla \times \mathbf{F} = 0$ , you may suspect that  $\nabla \times \mathbf{F} = 0$  and  $\mathbf{F} = \nabla\psi$  are also related. Indeed, if  $\mathbf{F} = \nabla\psi$ , then under suitable conditions,  $\nabla \times \mathbf{F} = 0$ . This is easily established. Consider, for example, the  $x$ -component of  $\nabla \times \mathbf{F}$ :

$$\begin{aligned} (\nabla \times \mathbf{F})_x &= \frac{\partial F_z}{\partial y} - \frac{\partial F_y}{\partial z} = \frac{\partial}{\partial y} \left( \frac{\partial \psi}{\partial z} \right) - \frac{\partial}{\partial z} \left( \frac{\partial \psi}{\partial y} \right) \\ &= \frac{\partial^2 \psi}{\partial y \partial z} - \frac{\partial^2 \psi}{\partial z \partial y} = 0. \end{aligned}$$

This last equality follows if  $\psi$  and its first and second derivatives are continuous, for then  $\partial^2 \psi / \partial y \partial z = \partial^2 \psi / \partial z \partial y$ . Obviously, the other two components of  $\nabla \times \mathbf{F}$  can be shown to vanish in exactly the same way. Thus,

$$F_q = \frac{\partial \psi}{\partial q} \quad (q = x, y, z) \quad \Rightarrow \quad \nabla \times \mathbf{F} = 0.$$

The converse of what we have just shown would assert that if  $\nabla \times \mathbf{F} = 0$ , then there exists a scalar function  $\psi$  such that  $\mathbf{F} = \nabla\psi$ , a statement that is true, provided the region of interest is simply connected. To understand this, we can consult Figure IV-3, which shows how path independence of the line integral of  $\mathbf{F} \cdot \hat{\mathbf{t}}$ ,  $\nabla \times \mathbf{F} = 0$ , and  $\mathbf{F} = \nabla\psi$  are related. The solid arrows in the diagram represent implications that hold in general, provided  $\mathbf{F}$  is smooth. The dashed arrows represent implications requiring not only that  $\mathbf{F}$  be smooth, but that the region of interest be simply connected. We have already shown that (1) implies both (2) and (3) and that (3) implies (1) in a simply connected region. Combining these two statements, we see that (3) implies (2) in a simply connected region.

In practice, just as the functions we deal with usually have continuous first derivatives (and are therefore smooth), the regions we work with are simply connected. In such circumstances we can relax a bit and regard the three statements summarized in Fig-



ure IV-3 as equivalent: each implies and is implied by each of the others. However, you should be aware of simple connectedness and its implications for the relations among the three statements.

To give a simple example of the ideas we have been discussing, consider the vector function

$$\mathbf{F}(x, y, z) = \mathbf{i}y + \mathbf{j}x.$$

This function is smooth everywhere, and we have already noted that its curl is zero (page 91). According to what we have just said, this means there must be a scalar function  $\psi(x, y, z)$  such that  $\mathbf{F}$  is its gradient. Thus,  $\psi$  must satisfy

$$F_x = y = \frac{\partial \psi}{\partial x}, \quad F_y = x = \frac{\partial \psi}{\partial y}, \quad F_z = 0 = \frac{\partial \psi}{\partial z}.$$

Clearly,  $\psi(x, y, z) = xy + C$ , where  $C$  is an arbitrary constant, satisfies these relations. This should be contrasted with the case of the function  $\mathbf{F} = \mathbf{i}y - \mathbf{j}x$ , the curl of which does *not* vanish (page 92). If this function were the gradient of a scalar function  $\psi$ , we should have

$$F_x = y = \frac{\partial \psi}{\partial x}, \quad F_y = -x = \frac{\partial \psi}{\partial y}, \quad F_z = 0 = \frac{\partial \psi}{\partial z},$$

but, as you should be able to convince yourself, there is no function  $\psi$  that satisfies these three equations.

The expression we have written for the gradient of a scalar function  $\psi(x, y, z)$ , namely,

$$\nabla\psi = \mathbf{i} \frac{\partial\psi}{\partial x} + \mathbf{j} \frac{\partial\psi}{\partial y} + \mathbf{k} \frac{\partial\psi}{\partial z},$$

is really just the form of this operator in Cartesian coordinates. To find the form of the gradient in other coordinate systems, if you go about it straightforwardly, is a tedious job. For example, to find the gradient in cylindrical coordinates, we would first have to express the Cartesian unit vectors  $\mathbf{i}$ ,  $\mathbf{j}$ , and  $\mathbf{k}$  in terms of the analogous quantities  $\hat{\mathbf{e}}_r$ ,  $\hat{\mathbf{e}}_\theta$ , and  $\hat{\mathbf{e}}_z$  in cylindrical coordinates. Then, using  $x = r \cos \theta$ ,  $y = r \sin \theta$ , and the chain rule for differentiation, we would have to express derivatives with respect to  $x$ ,  $y$ , and  $z$  in terms of those with respect to  $r$ ,  $\theta$ , and  $z$ . We shall not pursue this matter here because later (see pages 141 ff.) an easier and faster method will be available to us. For the present we merely quote the form of the gradient in cylindrical and in spherical coordinates.

*Cylindrical:*

$$\nabla\psi = \hat{\mathbf{e}}_r \frac{\partial\psi}{\partial r} + \hat{\mathbf{e}}_\theta \frac{1}{r} \frac{\partial\psi}{\partial\theta} + \hat{\mathbf{e}}_z \frac{\partial\psi}{\partial z}. \quad (\text{IV-3})$$

*Spherical:*

$$\nabla\psi = \hat{\mathbf{e}}_r \frac{\partial\psi}{\partial r} + \hat{\mathbf{e}}_\phi \frac{1}{r} \frac{\partial\psi}{\partial\phi} + \hat{\mathbf{e}}_\theta \frac{1}{r \sin\phi} \frac{\partial\psi}{\partial\theta} \quad (\text{IV-4})$$

A coordinate-free definition of the gradient analogous to the ones given for the divergence [Equation (II-17)] and the curl [Equation (III-8)] is discussed in Problem IV-25.

## *Finding the Electrostatic Field*

We began our discussion of vector calculus with a search for some convenient method for finding the electrostatic field. Our investigations led us to the differential form of Gauss' law,

Even this expression is not often useful for finding  $\mathbf{E}$  because it is one equation in three unknowns ( $E_x$ ,  $E_y$ , and  $E_z$  in Cartesian coordinates). Now, at last, we are able to complete our discussion and write down the equations that are often the most useful of all known methods for finding the field.

This final step rests on the observation that since

$$\oint_C \mathbf{E} \cdot \hat{\mathbf{t}} \, ds = 0$$

for any closed path  $C$ , the field  $\mathbf{E}$  can be written as the gradient of a scalar function. Conventionally, this function, called the electrostatic potential, is designated  $\Phi(x, y, z)$ , and we write<sup>1</sup>

$$\mathbf{E} = -\nabla\Phi.$$

Combining this equation with the differential form of Gauss' law [Equation (II-17)], we get

$$\nabla \cdot (-\nabla\Phi) = \rho/\epsilon_0,$$

or

$$\nabla \cdot (\nabla\Phi) = -\rho/\epsilon_0.$$

When we write out the left-hand side of this equation in detail, we find

$$\begin{aligned} \nabla \cdot (\nabla\Phi) &= \left( \mathbf{i} \frac{\partial}{\partial x} + \mathbf{j} \frac{\partial}{\partial y} + \mathbf{k} \frac{\partial}{\partial z} \right) \cdot \left( \mathbf{i} \frac{\partial\Phi}{\partial x} + \mathbf{j} \frac{\partial\Phi}{\partial y} + \mathbf{k} \frac{\partial\Phi}{\partial z} \right) \\ &= \frac{\partial^2\Phi}{\partial x^2} + \frac{\partial^2\Phi}{\partial y^2} + \frac{\partial^2\Phi}{\partial z^2}, \end{aligned}$$

and so

$$\frac{\partial^2\Phi}{\partial x^2} + \frac{\partial^2\Phi}{\partial y^2} + \frac{\partial^2\Phi}{\partial z^2} = -\rho/\epsilon_0. \quad (\text{IV-5})$$

Equation (IV-5) can be written more compactly by introducing a new operator, called the *Laplacian*, which is denoted, for

<sup>1</sup> The negative sign in this equation is not put there just to make life more difficult; there is a good reason for it. See the discussion on page 139.

fairly obvious reasons, by the symbol  $\nabla^2$  (read “del squared”). That is,

$$\begin{aligned}\nabla^2 = \nabla \cdot \nabla &= \left( \mathbf{i} \frac{\partial}{\partial x} + \mathbf{j} \frac{\partial}{\partial y} + \mathbf{k} \frac{\partial}{\partial z} \right) \cdot \left( \mathbf{i} \frac{\partial}{\partial x} + \mathbf{j} \frac{\partial}{\partial y} + \mathbf{k} \frac{\partial}{\partial z} \right) \\ &= \frac{\partial^2}{\partial x^2} + \frac{\partial^2}{\partial y^2} + \frac{\partial^2}{\partial z^2}.\end{aligned}\quad (\text{IV-6})$$

In this new notation Equation (IV-5) becomes

$$\nabla^2 \Phi = -\rho/\epsilon_0. \quad (\text{IV-7})$$

Equation (IV-6) provides the form of the Laplacian in Cartesian coordinates; its forms in cylindrical and spherical coordinates will be given in the next section. The best definition of the Laplacian is probably

$$\nabla^2 f = \nabla \cdot (\nabla f),$$

where  $f$  is some suitably continuous scalar function of position. This definition has the important advantage of being independent of the coordinate system.

Equation (IV-7) is called Poisson’s equation. It is a linear, second-order partial differential equation in *one* unknown, the scalar function  $\Phi(x, y, z)$ , and is the culmination of our long search for a method of determining the electrostatic field. A great body of work exists describing the many elegant mathematical schemes that have been devised to solve it, and a few simple examples are given in the next section. In any problem, once we have  $\Phi$ , the field is trivial to find using  $\mathbf{E} = -\nabla\Phi$ .

At any point in space where there is no electric charge, the density  $\rho$  is zero and Poisson’s equation reduces to

$$\nabla^2 \Phi = 0.$$

This is called *Laplace’s equation* and is more often used than Poisson’s equation. The reason for this is that usually charges are distributed over various objects; this gives rise to a field, and we are interested in finding the potential (and from it, the field) in the charge-free space between the objects. In the simplest of situations it is possible to specify “boundary conditions,” that is, the value of the potential on the surfaces of these objects (Figure



IV-4). We then find that solution of Laplace's equation which takes on the given values on the surfaces. This is illustrated in the next section.

## *Using Laplace's Equation*<sup>2</sup>

Whether solving Laplace's equation is or is not a topic in vector calculus is a moot point, but the basis of our entire discussion has been a search for a method to calculate electric fields. Since Laplace's equation is the end product of that search, we can scarcely omit a few examples to show how it works.

We begin with an especially simple problem. Imagine we have two very large ("infinite") parallel plates separated by a distance  $s$  (Figure IV-5). Choosing a coordinate system as shown in the figure, let the plate at  $x = 0$  be held at zero potential and that at  $x = s$  at  $V_0$ . Our object is to find the potential and the electric field in the space between the two plates. Because the plates are infinitely large, there is nothing to distinguish a point  $(x, y, z)$  from any other point  $(x, y', z')$  having the same  $x$ -coordinate. It follows that the potential  $\Phi$  depends on  $x$  but not on  $y$  or  $z$ . Thus,  $\nabla^2\Phi$  reduces in this case simply to  $d^2\Phi/dx^2$ , and so Laplace's equation and the associated boundary conditions are

$$\frac{d^2\Phi}{dx^2} = 0$$



and

$$\Phi = \begin{cases} 0 & \text{at } x = 0 \\ V_0 & \text{at } x = s. \end{cases}$$

This is a trivial problem and the solution is

$$\Phi(x) = \frac{V_0 x}{s}.$$

The electric field is found using  $\mathbf{E} = -\nabla\Phi$ , which yields

$$E_x = \frac{-V_0}{s} \quad \text{and} \quad E_y = E_z = 0.$$

Thus, the field is a constant vector normal to the plates. This is an excellent approximation to the potential and field between, but far from the edges of, two plates whose linear dimensions are large compared with their separation. You may recognize this arrangement as a parallel plate capacitor.

Our second example is a spherical capacitor, that is, two concentric spheres having radii  $R_1$  and  $R_2$  with the inner one maintained at a potential  $V_0$  and the outer at zero (Figure IV-6). We are required to find the potential and field everywhere between the spheres. In this situation we would obviously do well to work



in spherical coordinates  $r$ ,  $\theta$ , and  $\phi$ , in which Laplace's equation between the spheres has the imposing form

$$\nabla^2 \Phi = \frac{1}{r^2} \frac{\partial}{\partial r} \left( r^2 \frac{\partial \Phi}{\partial r} \right) + \frac{1}{r^2 \sin \phi} \frac{\partial}{\partial \phi} \left( \sin \phi \frac{\partial \Phi}{\partial \phi} \right) + \frac{1}{r^2 \sin^2 \phi} \frac{\partial^2 \Phi}{\partial \theta^2} = 0.$$

(See Problem IV-23.) Fortunately, we need not work with this equation as it stands; a little thought will convince you that  $\Phi$  can only be a function of  $r$ , since there is no way to distinguish a point  $(r, \theta, \phi)$  from another  $(r, \theta', \phi')$  with the same  $r$  but different  $\theta$  and  $\phi$ . Thus,

$$\frac{\partial \Phi}{\partial \theta} = \frac{\partial \Phi}{\partial \phi} = 0,$$

and Laplace's equation reduces to

$$\frac{1}{r^2} \frac{d}{dr} \left( r^2 \frac{d\Phi}{dr} \right) = 0. \quad (\text{IV-8})$$

We are interested in the solution of this equation that is valid for  $R_1 < r < R_2$  and satisfies the boundary conditions

$$\Phi(r) = \begin{cases} V_0 & \text{at } r = R_1 \\ 0 & \text{at } r = R_2. \end{cases}$$

**Using Laplace's Equation**

Multiplying Equation (IV-8) by  $r^2$  and putting  $\psi = d\Phi/dr$ , we get

$$\frac{d}{dr}(r^2\psi) = 0,$$

and so

$$r^2\psi = c_1,$$

where  $c_1$  is a constant. Hence,

$$\psi = \frac{d\Phi}{dr} = \frac{c_1}{r^2},$$

and it follows that

$$\Phi = -\frac{c_1}{r} + c_2, \quad (\text{IV-9})$$

where  $c_2$  is another constant. Imposing the boundary conditions, we find

$$-\frac{c_1}{R_1} + c_2 = V_0 \quad \text{and} \quad -\frac{c_1}{R_2} + c_2 = 0,$$

whence

$$c_1 = \frac{V_0 R_1 R_2}{R_1 - R_2} \quad \text{and} \quad c_2 = \frac{V_0 R_1}{R_1 - R_2}.$$

Substituting these in the expression for the potential [Equation (IV-9)], we get

$$\Phi(r) = \frac{V_0 R_1}{R_1 - R_2} \left( 1 - \frac{R_2}{r} \right), \quad R_1 < r < R_2.$$

To get the electric field, we must take the gradient of  $\Phi$ , and this is clearly most conveniently done in spherical coordinates [see Equation (IV-4)]. However, since in this case  $\Phi$  depends only on  $r$ , we get only a radial component:

$$E_r = -\frac{d\Phi}{dr} = -\frac{V_0 R_1 R_2}{R_1 - R_2} \frac{1}{r^2},$$



Our third and last example is more complicated (and more interesting) than the foregoing. If a potential difference is maintained between two “infinite” parallel plates  $P$  and  $P'$  (Figure IV-7), then we know from our first example that the field between them is a constant vector normal to the plates. Choosing a coordinate system as shown in the figure (with the  $z$ -axis out of the plane of the paper), we have  $\mathbf{E} = E_0 \mathbf{i}$ , where  $E_0$  is a constant. Let an “infinitely” long cylinder held at zero potential be situated between the plates with its axis along the  $z$ -axis. Let its radius  $R$  be small compared with the plate separation. What are the potential and the electric field outside the cylinder and between the plates? Here, clearly, we should use cylindrical coordinates  $(r, \theta, z)$ , in which case Laplace’s equation reads

$$\nabla^2 \Phi = \frac{1}{r} \frac{\partial}{\partial r} \left( r \frac{\partial \Phi}{\partial r} \right) + \frac{1}{r^2} \frac{\partial^2 \Phi}{\partial \theta^2} + \frac{\partial^2 \Phi}{\partial z^2} = 0.$$

(See Problem IV-21.) You should convince yourself that  $\Phi$  in this case must be independent of  $z$ , so this equation simplifies somewhat to

$$\frac{1}{r} \frac{\partial}{\partial r} \left( r \frac{\partial \Phi}{\partial r} \right) + \frac{1}{r^2} \frac{\partial^2 \Phi}{\partial \theta^2} = 0. \quad (\text{IV-10})$$

There are two boundary conditions, of which the first is

$$\Phi(r, \theta) = 0 \quad \text{at} \quad r = R.$$

The second condition has to do with the fact that at large values of  $r$ , the influence of the cylinder is negligible and the field must

be, to a good approximation, what it would be if the cylinder were not present at all, that is,  $E_0\mathbf{i}$ . To put this in terms of the potential, we note that

$$\Phi = -E_0x$$

will provide just such a field. Since  $x = r \cos \theta$ , we can write the second boundary condition

$$\Phi(r, \theta) = -E_0r \cos \theta, \quad r \gg R. \quad (\text{IV-11})$$

Let's try to solve Laplace's equation for this problem [Equation (IV-10)] by assuming we can write

$$\Phi(r, \theta) = f(r) \cos \theta, \quad (\text{IV-12})$$

where  $f(r)$  is an as yet unknown function. What prompts us to do this is the fact that the second boundary condition [Equation (IV-11)] has precisely this form—a function of  $r$  multiplied by  $\cos \theta$ . If we substitute Equation (IV-12) into Equation (IV-10), the result is a differential equation for the function  $f(r)$ :

$$\frac{d^2f}{dr^2} + \frac{1}{r} \frac{df}{dr} - \frac{1}{r^2}f = 0.$$

Putting  $f(r) = r^\lambda$  where  $\lambda$  is a constant leads to

$$\lambda(\lambda - 1)r^{\lambda-2} + \lambda r^{\lambda-2} - r^{\lambda-2} = 0,$$

or

$$\lambda^2 = 1,$$

and  $\lambda = \pm 1$ . Hence we get

$$f(r) = Ar + \frac{B}{r},$$

where  $A$  and  $B$  are constants. Thus, our solution is

$$\Phi(r, \theta) = \left( Ar + \frac{B}{r} \right) \cos \theta.$$

$$AR + \frac{B}{R} = 0,$$

or

$$B = -AR^2.$$

Hence,

$$\Phi(r, \theta) = Ar \cos \theta - \frac{AR^2}{r} \cos \theta.$$

To impose the second condition, we note that for  $r$  large, the second term in this last equation is negligible compared with the first. Thus,

$$\Phi(r, \theta) \simeq Ar \cos \theta, \quad r \text{ large.}$$

We satisfy the second boundary condition by choosing  $A = -E_0$ . The complete solution is thus

$$\Phi(r, \theta) = -E_0 r \left( 1 - \frac{R^2}{r^2} \right) \cos \theta.$$

To find the electric field, we proceed as usual with  $\mathbf{E} = -\nabla\Phi$ . Using Equation (IV-3), we get

$$E_r = -\frac{\partial \Phi}{\partial r} = E_0 \left[ 1 + \left( \frac{R}{r} \right)^2 \right] \cos \theta,$$

$$E_\theta = -\frac{1}{r} \frac{\partial \Phi}{\partial \theta} = -E_0 \left[ 1 - \left( \frac{R}{r} \right)^2 \right] \sin \theta,$$

$$E_z = -\frac{\partial \Phi}{\partial z} = 0.$$

You should verify that for large  $r$ , this field reduces to  $E_0 \mathbf{i}$  as required.

You may find this last example disquieting, since a certain amount of clever guesswork is used in finding the potential. Actually, there are standard procedures that, in problems of this kind, lead more or less straightforwardly to the solution. A discussion of these

procedures, however, would be very lengthy and (in the well-worn phrase) beyond the scope of this text. Before moving on, however, one further point is worth making: A solution of Laplace's equation that satisfies appropriate boundary conditions is *unique*. That is to say, there is one and only one such solution, so that if we solve a problem by guesswork and skullduggery, and someone else solves it with refined and elegant mathematical techniques, the two solutions, in spite of their disparate pedigrees, must be the same. In Problem IV-24 you will be led through a proof of this remarkable fact.

## *Directional Derivatives and the Gradient*

We have introduced the gradient as a sort of mathematical artifice useful in discussing path-independent line integrals. We now turn to a more detailed examination of the gradient in order to describe its geometrical significance.

Before beginning our discussion, we make a few comments on Taylor series, since these are needed in what follows. For a scalar function of one variable that is suitably continuous and differentiable, we have

$$f(x + \Delta x) = f(x) + \Delta x f'(x) + \frac{1}{2}(\Delta x)^2 f''(x) + \dots$$

This says that the value of the function at some point  $x + \Delta x$  can be written as the sum of (usually) infinitely many terms that involve the function and its derivatives at some other point  $x$ . Among other things, this Taylor series is useful for calculation, for if the two points are close together (that is, if  $\Delta x$  is small), then we can truncate the series after a certain number of terms (which we hope is small), since the neglected terms, each proportional to some large power of the small number  $\Delta x$ , will sum to a value that is negligible.

Taylor series can also be formed for functions of several variables. Thus, for a function of two variables we have

$$f(x + \Delta x, y + \Delta y)$$

$$= f(x, y) + \Delta x \frac{\partial f}{\partial x} + \Delta y \frac{\partial f}{\partial y} + \dots \quad (\text{IV-13})$$

This says that the value of the function at some point  $(x + \Delta x, y + \Delta y)$  can be written as a sum of (usually) infinitely many terms that involve the function and its derivatives at some other point

$(x, y)$ . We shall never need the explicit form of the remaining terms of this series [represented by the dots in Equation (IV-13)]. We should know, however, that these terms involve higher powers of the “small” numbers  $\Delta x$  and  $\Delta y$  (for example,  $\Delta x^2$ ,  $\Delta y^2$ ,  $\Delta x\Delta y$ ,  $\Delta x^3$ ,  $\Delta y^3$ ,  $\Delta x^2 \Delta y$ , and so on). With these simple ideas in mind we turn now to our main task.

Consider some function  $z = f(x, y)$ . Geometrically, this represents a surface as shown in Figure IV-8(a). Let  $(x, y)$  be the coordinates of a point  $P$  in the  $xy$ -plane. The height of the surface above this point is represented by the length of the dotted line  $PQ$ ; that is,  $PQ = z = f(x, y)$ . Suppose now we take a short step in the  $xy$ -plane to a new point  $P'$  with coordinates  $(x + \Delta x, y + \Delta y)$ . The height of the surface above this point is  $P'Q' = f(x + \Delta x, y + \Delta y)$ . Let  $\Delta s$  be the length of the step ( $\Delta s = PP'$ ).



We next ask how much the function  $f$  has changed as a result of taking this step. Clearly, this change is the difference in the two heights  $PQ$  and  $P'Q'$ , and

$$P'Q' - PQ \equiv \Delta f = f(x + \Delta x, y + \Delta y) - f(x, y).$$

Applying the Taylor series formula stated above [Equation (IV-13)], we get

$$\Delta f = f(x, y) + \Delta x \frac{\partial f}{\partial x} + \Delta y \frac{\partial f}{\partial y} + \dots - f(x, y)$$

$$= \Delta x \frac{\partial f}{\partial x} + \Delta y \frac{\partial f}{\partial y} + \dots$$

We now recast this expression by what at first may seem an unnecessary elaboration of the notation. Let  $\Delta s$  be a vector that has magnitude  $\Delta s$  and points from  $P$  to  $P'$ . Clearly,

$$\Delta s = \mathbf{i} \Delta x + \mathbf{j} \Delta y.$$

But the gradient of  $f$  is

$$\nabla f = \mathbf{i} \frac{\partial f}{\partial x} + \mathbf{j} \frac{\partial f}{\partial y}$$

(an obvious specialization of the gradient notation to a function of two, rather than three, variables). It follows at once that

$$\Delta f = (\Delta s) \cdot (\nabla f) + \dots$$

Complicating matters slightly more, let  $\hat{\mathbf{u}}$  be a unit vector in the direction of  $\Delta s$ . Then

$$\Delta s = \hat{\mathbf{u}} \Delta s$$

and

$$\Delta f = (\hat{\mathbf{u}} \cdot \nabla f) \Delta s + \dots,$$

so that

$$\frac{\Delta f}{\Delta s} = \hat{\mathbf{u}} \cdot \nabla f + \dots.$$

We now take the limit of this equation to get

$$\frac{df}{ds} \equiv \lim_{\Delta s \rightarrow 0} \frac{\Delta f}{\Delta s} = \hat{\mathbf{u}} \cdot \nabla f. \quad (\text{IV-14})$$

There is no longer any need for “ $+ \dots$ ,” since the dots represented terms that go to zero as  $\Delta s$  goes to zero.

This new expression [Equation (IV-14)] has a simple interpretation: it is the *rate* of change of the function  $f(x, y)$  in the direction of  $\Delta s$  (that is, of  $\hat{\mathbf{u}}$ ). Redrawing Figure IV-8(a) and passing a plane through  $P$  and  $P'$  parallel to the  $z$ -axis [Figure IV-8(b)], we see that it cuts the surface  $z = f(x, y)$  in a curve  $C$ . The quantity  $df/ds$  defined in Equation (IV-14) is the slope of this curve at the point  $Q$ .



The quantity  $df/ds$  is called the *directional derivative* of  $f$ . Although the analysis given earlier that led to this derivative was for functions of two variables, the results all apply to functions of three (or more) variables. Thus,

$$\frac{d}{ds} F(x, y, z) = \hat{\mathbf{u}} \cdot \nabla F$$

is the rate of change of the function  $F(x, y, z)$  in the direction specified by the unit vector  $\hat{\mathbf{u}}$ .

An example of the directional derivative may be amusing here. We'll work with a function of two variables so that we can draw pictures. Thus, let's consider

$$z = f(x, y) = (x^2 + y^2)^{1/2},$$

which is an inverted right circular cone whose axis coincides with the  $z$ -axis [see Figure IV-9(a)]. We ask for the directional derivative of this function at some point  $x = a$  and  $y = b$  and in the direction specified by  $\hat{\mathbf{u}} = \mathbf{i} \cos \theta + \mathbf{j} \sin \theta$  [see Figure IV-9(b)]. First we need the gradient of  $f(x, y)$ . But

$$\frac{\partial f}{\partial x} = \frac{x}{z} \quad \text{and} \quad \frac{\partial f}{\partial y} = \frac{y}{z},$$

as you can easily verify. Thus,

$$\nabla f = \frac{\mathbf{i}x + \mathbf{j}y}{z}$$





and

$$\frac{df}{ds} = \hat{\mathbf{u}} \cdot \nabla f = \frac{x \cos \theta + y \sin \theta}{z} \rightarrow \frac{a \cos \theta + b \sin \theta}{\sqrt{a^2 + b^2}}.$$

Suppose  $\theta$  is chosen so that  $\hat{\mathbf{u}}$  is in the radial direction as indicated in Figure IV-9(c). This means

$$\cos \theta = \frac{a}{(a^2 + b^2)^{1/2}},$$

$$\sin \theta = \frac{b}{(a^2 + b^2)^{1/2}},$$

and so

$$\frac{df}{ds} = \frac{a}{\sqrt{a^2 + b^2}} \cdot \frac{a}{\sqrt{a^2 + b^2}} + \frac{b}{\sqrt{a^2 + b^2}} \cdot \frac{b}{\sqrt{a^2 + b^2}} = 1.$$





A second interesting case is that in which  $\hat{\mathbf{u}}$  is chosen perpendicular to the direction of the previous example [see Figure IV-9(e)]. We then have

$$\cos \theta = \frac{-b}{(a^2 + b^2)^{1/2}},$$

$$\sin \theta = \frac{a}{(a^2 + b^2)^{1/2}},$$

and so

$$\begin{aligned} \frac{df}{ds} &= \frac{a}{\sqrt{a^2 + b^2}} \left( -\frac{b}{\sqrt{a^2 + b^2}} \right) \\ &\quad + \frac{b}{\sqrt{a^2 + b^2}} \left( \frac{a}{\sqrt{a^2 + b^2}} \right) = 0. \end{aligned}$$





## Geometric Significance of the Gradient

With the concept of the directional derivative at our disposal, we are now in a position to give a geometric interpretation of the gradient. At some point  $P_0$  with coordinates  $(x_0, y_0, z_0)$  we have

$$\left( \frac{dF}{ds} \right)_0 = \hat{u} \cdot (\nabla F)_0,$$

where the subscript 0 means the quantity is to be evaluated at the point  $(x_0, y_0, z_0)$ . Now  $(\nabla F)_0$ , the gradient of  $F$  evaluated at  $P_0$ , may be represented by an arrow emanating from that point as shown in Figure IV-10(a). If we ask in what direction we must move to make  $(dF/ds)_0$  as large as possible, it is clear that  $\hat{u}$  should be in the same direction as  $(\nabla F)_0$ . This is because if we let  $\alpha$  be the angle between  $\hat{u}$  and  $(\nabla F)_0$ , then  $(dF/ds)_0 = |\nabla F|_0 \cos \alpha$ , and this is as large as it can be when  $\alpha = 0$ . Thus, *the gradient of*



a scalar function  $F(x, y, z)$  is a vector that is in the direction in which  $F$  undergoes the greatest rate of increase and that has magnitude equal to the rate of increase in that direction.

To illustrate this interpretation of the gradient, let us go back to the inverted cone  $z = f(x, y) = (x^2 + y^2)^{1/2}$  we discussed earlier. We learned that

$$\nabla f = \frac{\mathbf{i}x + \mathbf{j}y}{z}$$

and

$$\frac{df}{ds} = \frac{a \cos \theta + b \sin \theta}{\sqrt{a^2 + b^2}} \equiv D(\theta).$$

To find the direction in which  $f(x, y)$  undergoes the greatest rate of change, we set

$$\frac{dD}{d\theta} = \frac{-a \sin \theta + b \cos \theta}{\sqrt{a^2 + b^2}} = 0.$$

This gives  $\tan \theta = b/a$ , whence  $\cos \theta = a/(a^2 + b^2)^{1/2}$  and  $\sin \theta = b/(a^2 + b^2)^{1/2}$ . So  $(df/ds)_{\max} = 1$ . On the other hand,

$$|\nabla f| = \left[ \frac{x^2 + y^2}{z^2} \right]^{1/2} = 1,$$

since  $z^2 = x^2 + y^2$ . Furthermore,  $\tan \theta = b/a$  corresponds to the direction  $a\mathbf{i} + b\mathbf{j}$ , while at the point  $(a, b)$ ,

$$\nabla f = \frac{a\mathbf{i} + b\mathbf{j}}{(a^2 + b^2)^{1/2}},$$

which is a vector in the same direction. Thus both properties of the gradient are illustrated; it's in the direction of maximum rate of increase, and its magnitude is equal to the rate of increase in that direction.

As a second example of the interpretation of the gradient, we consider the plane  $z = f(x, y) = 1 - x - y$  shown in Figure IV-10(b). It's easy to see that  $\nabla f = -\mathbf{i} - \mathbf{j}$ . Using  $\hat{\mathbf{u}} = \mathbf{i} \cos \theta + \mathbf{j} \sin \theta$  as before, we find  $df/ds = \hat{\mathbf{u}} \cdot \nabla f = -\cos \theta - \sin \theta \equiv D(\theta)$ . Thus

$$\frac{dD}{d\theta} = \sin \theta - \cos \theta = 0,$$



which yields  $\theta = \pi/4$  or  $5\pi/4$ . The second derivative test shows that  $\pi/4$  corresponds to a minimum and  $5\pi/4$ , to a maximum. It can be seen from Figure IV-10(b) that the greatest rate of increase is indeed at an angle of  $5\pi/4$ . Moreover, the greatest rate of increase is

$$\left( \frac{df}{ds} \right)_{\max} = D(5\pi/4) = \sqrt{2},$$

whereas  $|\nabla f| = |-\mathbf{i} - \mathbf{j}| = \sqrt{2}$ . Again, both properties of the gradient are illustrated by this example.

With this geometric interpretation of the gradient at our disposal, we can now see the reason for the negative sign in the equation  $\mathbf{E} = -\nabla\Phi$ : Since  $\nabla\Phi$  is a vector in the direction of increasing  $\Phi$ , the force on a *positive* charge  $q$  is  $\mathbf{F} = q\mathbf{E} = -q\nabla\Phi$ , which is in the direction of *decreasing*  $\Phi$ . Thus, the negative sign ensures that a positive charge moves “downhill” from a higher to a lower potential.

There is another property of the gradient useful in understanding its geometric significance. To make this discussion concrete, let  $T(x, y, z)$  be a scalar function that gives the temperature at



any point  $(x, y, z)$ . The locus of all points having the same temperature  $T_0$  is (in the simplest case) a surface whose equation is  $T(x, y, z) = T_0$  (Figure IV-11). This is called an isothermal surface. We now show that  $\nabla T$  is a vector normal to the isothermal surface. Let  $C$  be any curve lying in the isothermal surface and let  $P$  be any point on  $C$ . Let  $\hat{u}$  be the unit vector tangent to  $C$  at  $P$  (it doesn't matter which direction along  $C$  we take). The directional derivative in the direction  $\hat{u}$  is

$$\left( \frac{dT}{ds} \right) = \hat{u} \cdot \nabla T = 0$$

because  $T$  does not change as we move along the isothermal surface. If the scalar product of two vectors, neither of them zero, vanishes, the two vectors are perpendicular. Thus  $\nabla T$  is perpendicular to  $C$  at  $P$ . By the same argument it is perpendicular to *any* curve on the surface through  $P$  (such as  $C'$  in Figure IV-11). But this can be true only if  $\nabla T$  is normal to the isothermal surface at  $P$ . In general then,  $\nabla f(x, y, z)$ , where  $f(x, y, z)$  is a scalar function, is normal to the surface  $f(x, y, z) = \text{constant}$ .<sup>3</sup>

A simple example of this property of the gradient is provided by the function  $F(x, y, z) = x^2 + y^2 + z^2$ . The surface  $F(x, y, z) = \text{constant}$  is, of course, a sphere (assuming the constant is positive). As you should verify for yourself,  $\nabla F = 2(\mathbf{i}x + \mathbf{j}y + \mathbf{k}z) = 2\mathbf{r}$ . Thus, we have a familiar result: A vector normal to a spherical surface is in the radial direction. We'll leave it to you to ponder the geometric relation between the electrostatic field  $\mathbf{E}$  and its *equipotential surfaces*  $\Phi(x, y, z) = \text{constant}$ .

<sup>3</sup> The connection between this property of the gradient and our earlier expression for the unit vector normal to a surface [Equation (II-4)] is the subject of Problem IV-20.

We can make a simple connection between the property of the gradient just discussed and the fact that it is in the direction of the greatest rate of increase. Any displacement from the surface  $f(x, y, z) = \text{constant}$ , regarded as a vector  $\mathbf{s}$ , can be resolved into a component along the surface ( $s_{\parallel}$ ) and one normal to it ( $s_{\perp}$ ), as shown in Figure IV-12. That part of the displacement along the surface is “wasted motion” if our aim in moving is to cause a change in the value of  $f(x, y, z)$ . Only the normal component carries us away from the surface and causes a change in  $f$ . From this it is clear that the greatest increase possible for a given magnitude of displacement should occur when we move away from the surface in the normal direction. But we have already established that the greatest rate of increase occurs in the direction of the gradient. Thus the gradient is normal to the surface.



## *The Gradient in Cylindrical and Spherical Coordinates*

A by-product of our discussion of the directional derivative is the “easier and faster” method for calculating the gradient in spherical and cylindrical coordinates mentioned earlier (see page 120). To determine this method, we begin by outlining our derivation of  $df/ds$ :<sup>4</sup>

1. Our first step is to consider a scalar function of three Cartesian coordinates  $f(x, y, z)$  and use Taylor series to determine the change in  $f$  caused by a displacement from the point  $(x, y, z)$  to a second point  $(x + \Delta x, y + \Delta y, z + \Delta z)$ . We find for this change

$$\Delta f = \frac{\partial f}{\partial x} \Delta x + \frac{\partial f}{\partial y} \Delta y + \frac{\partial f}{\partial z} \Delta z + \dots$$

<sup>4</sup> The calculation outlined here pertains to a function of three variables and is a simple generalization of the calculation on pages 130–133, which deals with a function of two variables.

2. We next write  $\Delta f$  in terms of  $\Delta \mathbf{s}$ , the vector displacement from  $(x, y, z)$  to  $(x + \Delta x, y + \Delta y, z + \Delta z)$ . Clearly (see Figure IV-13),

$$\Delta \mathbf{s} = \mathbf{i} \Delta x + \mathbf{j} \Delta y + \mathbf{k} \Delta z,$$

so that

$$\Delta f = \left( \mathbf{i} \frac{\partial f}{\partial x} + \mathbf{j} \frac{\partial f}{\partial y} + \mathbf{k} \frac{\partial f}{\partial z} \right) \cdot \Delta \mathbf{s} + \dots$$



3. Finally, we write  $\Delta \mathbf{s} = \hat{\mathbf{u}} \Delta s$ , divide by  $\Delta s$ , and take the limit:

$$\lim_{\Delta s \rightarrow 0} \frac{\Delta f}{\Delta s} \equiv \frac{df}{ds} = \left( \mathbf{i} \frac{\partial f}{\partial x} + \mathbf{j} \frac{\partial f}{\partial y} + \mathbf{k} \frac{\partial f}{\partial z} \right) \cdot \hat{\mathbf{u}}.$$

The quantity that is dotted into  $\hat{\mathbf{u}}$  in this last expression is then recognized as the gradient of  $f$  in Cartesian coordinates.

To obtain the gradient of a scalar function in cylindrical coordinates we proceed in much the same way:

1. We consider a scalar function of three cylindrical coordinates,  $f(r, \theta, z)$ . Using Taylor series, we find the change in  $f$  due to a displacement from the point  $(r, \theta, z)$  to a second point  $(r + \Delta r, \theta + \Delta \theta, z + \Delta z)$ :

$$\Delta f = \frac{\partial f}{\partial r} \Delta r + \frac{\partial f}{\partial \theta} \Delta \theta + \frac{\partial f}{\partial z} \Delta z + \dots$$

2. Next, we write  $\Delta f$  in terms of  $\Delta \mathbf{s}$ . This is the heart of the calculation. From Figure IV-14 we have

$$\Delta \mathbf{s} = \hat{\mathbf{e}}_r \Delta r + \hat{\mathbf{e}}_\theta r \Delta \theta + \hat{\mathbf{e}}_z \Delta z.$$




Figure IV-14

Two features of this expression require some discussion. First, the displacement in the direction of increasing  $\theta$  (of magnitude  $r \Delta\theta$ ) is an arc of a circle rather than a straight line segment. However, since we will eventually pass to the limit as  $\Delta s \rightarrow 0$ , we may regard  $\Delta\theta$  (as well as  $\Delta r$  and  $\Delta z$ ) as arbitrarily small, in which case the arc is arbitrarily close to its subtending chord. Thus, as indicated in Figure IV-15,  $\Delta r$ ,  $r \Delta\theta$ , and  $\Delta z$



approximate to any desired degree of accuracy three mutually perpendicular displacements, the analogs of the three Cartesian displacements  $\Delta x$ ,  $\Delta y$ , and  $\Delta z$  (see Figure IV-13).

The second feature of our expression for  $\Delta s$  that requires comment also has to do with the displacement in the direction of increasing  $\theta$ . It is this: Since the arc is part of a circle of radius  $r + \Delta r$ , we should, strictly speaking, write the displacement as  $(r + \Delta r) \Delta\theta$ , not  $r \Delta\theta$ . But the additional term  $\Delta r \Delta\theta$  is “second order”; that is, it is the product of two small quantities and therefore negligible compared with  $r \Delta\theta$ .

If we now write our expression for  $\Delta f$  in terms of  $\Delta s$ , we get

$$\Delta f = \left( \hat{\mathbf{e}}_r \frac{\partial f}{\partial r} + \hat{\mathbf{e}}_\theta \frac{1}{r} \frac{\partial f}{\partial \theta} + \hat{\mathbf{e}}_z \frac{\partial f}{\partial z} \right) \cdot \Delta s + \dots$$

Note the factor  $1/r$  in the second term to compensate for the factor  $r$  in  $\hat{\mathbf{e}}_\theta r \Delta\theta$  in  $\Delta s$ .

3. Finally, putting  $\Delta s = \hat{\mathbf{u}} \Delta s$ , we find

$$\lim_{\Delta s \rightarrow 0} \frac{\Delta f}{\Delta s} \equiv \frac{df}{ds} = \left( \hat{\mathbf{e}}_r \frac{\partial f}{\partial r} + \hat{\mathbf{e}}_\theta \frac{1}{r} \frac{\partial f}{\partial \theta} + \hat{\mathbf{e}}_z \frac{\partial f}{\partial z} \right) \cdot \hat{\mathbf{u}}.$$

The quantity in the preceding expression dotted into  $\hat{\mathbf{u}}$  is the gradient of  $f$  in cylindrical coordinates.

An analogous procedure can be used to find the gradient in spherical coordinates; this has been left as an exercise (see Problem IV-22).

## PROBLEMS

**IV-1** (a) Calculate  $\mathbf{F} = \nabla f$  for each of the following scalar functions:

- (i)  $f = xyz$ .
- (ii)  $f = x^2 + y^2 + z^2$ .
- (iii)  $f = xy + yz + xz$ .
- (iv)  $f = 3x^2 - 4z^2$ .
- (v)  $f = e^{-x} \sin y$ .

(b) Verify that

$$\oint_C \mathbf{F} \cdot \hat{\mathbf{t}} \, ds = 0$$

for one or more of the functions  $\mathbf{F}$  determined in part (a) choosing for the curve  $C$ :

- (i) the square in the  $xy$ -plane with vertices at  $(0, 0)$ ,  $(1, 0)$ ,  $(1, 1)$ , and  $(0, 1)$ .
- (ii) the triangle in the  $yz$ -plane with vertices at  $(0, 0)$ ,  $(1, 0)$ , and  $(0, 1)$ .
- (iii) the circle of unit radius centered at the origin and lying in the  $xz$ -plane.
- (c) Verify by direct calculation that  $\nabla \times \mathbf{F} = 0$  for one or more of the functions  $\mathbf{F}$  determined in part (a).

**IV-2** Verify the following identities in which  $f$  and  $g$  are arbitrary differentiable scalar functions of position, and  $\mathbf{F}$  and  $\mathbf{G}$  are arbitrary differentiable vector functions of position.

- (a)  $\nabla(fg) = f \nabla g + g \nabla f$ .
- (b)  $\nabla(\mathbf{F} \cdot \mathbf{G}) = (\mathbf{G} \cdot \nabla)\mathbf{F} + (\mathbf{F} \cdot \nabla)\mathbf{G} + \mathbf{F} \times (\nabla \times \mathbf{G}) + \mathbf{G} \times (\nabla \times \mathbf{F})$ .
- (c)  $\nabla \cdot (f\mathbf{F}) = f \nabla \cdot \mathbf{F} + \mathbf{F} \cdot \nabla f$ .
- (d)  $\nabla \cdot (\mathbf{F} \times \mathbf{G}) = \mathbf{G} \cdot (\nabla \times \mathbf{F}) - \mathbf{F} \cdot (\nabla \times \mathbf{G})$ .
- (e)  $\nabla \times (f\mathbf{F}) = f \nabla \times \mathbf{F} + (\nabla f) \times \mathbf{F}$ .
- (f)  $\nabla \times (\mathbf{F} \times \mathbf{G}) = (\mathbf{G} \cdot \nabla)\mathbf{F} - (\mathbf{F} \cdot \nabla)\mathbf{G} + \mathbf{F}(\nabla \cdot \mathbf{G}) - \mathbf{G}(\nabla \cdot \mathbf{F})$ .
- (g)  $\nabla \times (\nabla \times \mathbf{F}) = \nabla(\nabla \cdot \mathbf{F}) - \nabla^2 \mathbf{F}$ .

**IV-3** Show that  $\nabla \times \nabla f = 0$  where  $f(x, y, z)$  is an arbitrary differentiable scalar function. Assume that mixed second-order partial derivatives are independent of the order of differentiation. For example,  $\partial^2 f / \partial x \partial z = \partial^2 f / \partial z \partial x$ .


**IV-4** (a) Each of the following functions is smooth in a simply connected region. Determine which of them may be written as the gradient of a scalar function, and for those that can, use Equation (IV-2) to find that scalar function.

- (i)  $\mathbf{F} = \mathbf{i}y$ .
- (ii)  $\mathbf{F} = C\mathbf{k}$ ,  $C$  a constant.
- (iii)  $\mathbf{F} = \mathbf{i}yz + \mathbf{j}xz + \mathbf{k}xy$ .
- (iv)  $\mathbf{F} = \mathbf{i}x + \mathbf{j}y + \mathbf{k}z$ .
- (v)  $\mathbf{F} = \mathbf{i}e^{-z} \sin y + \mathbf{j}e^{-y} \sin z + \mathbf{k}e^{-x} \sin y$ .

(b) Neither of the following functions is smooth everywhere. Nonetheless each can be written as the gradient of a scalar function. Use Equation (IV-2) to find that scalar function.


- (i)  $\mathbf{F} = \mathbf{r}/r^2$ ,  $\mathbf{r} = \mathbf{i}x + \mathbf{j}y$ .
- (ii)  $\mathbf{F} = \mathbf{r}/r^{1/2}$ ,  $\mathbf{r} = \mathbf{i}x + \mathbf{j}y + \mathbf{k}z$ .

**IV-5** The function  $\mathbf{F}(r, \theta, z)$  defined in Problem III-17 is smooth and has zero curl in a nonsimply connected region consisting of all of three-dimensional space with the  $z$ -axis removed. Show that there is no scalar function  $\psi$  such that  $\mathbf{F} = \nabla\psi$  by evaluating the line integral of  $\mathbf{F} \cdot \hat{\mathbf{t}}$  from the point  $P_1(0, -1, 0)$  to the point  $P_2(0, 1, 0)$  over two different paths:  $C_R$ , the right-hand side of the circle of radius 1 lying in the  $xy$ -plane and centered at the origin (see figure), and  $C_L$ , the left-hand side of the same circle. Orient the paths as shown. Why does the fact that the two paths give different results imply that there is no scalar function  $\psi$  such that  $\mathbf{F} = \nabla\psi$ ?



**IV-6** (a) An electric dipole of strength  $p$  situated at the origin and oriented in the positive  $z$ -direction gives rise to an electrostatic field

$$\mathbf{E}(r, \theta, \phi) = \frac{1}{4\pi\epsilon_0 r^3} \frac{p}{r^3} (2\hat{\mathbf{e}}_r \cos \phi + \hat{\mathbf{e}}_\phi \sin \phi)$$



Use Equation (IV-2) to show that the dipole potential is given by

$$\Phi(r, \theta, \phi) = \frac{1}{4\pi\epsilon_0} \frac{p \cos \phi}{r^2}$$

Useful information: In spherical coordinates,

$$\hat{\mathbf{t}} = \hat{\mathbf{e}}_r \frac{dr}{ds} + \hat{\mathbf{e}}_\phi r \frac{d\phi}{ds} + \hat{\mathbf{e}}_\theta r \sin \phi \frac{d\theta}{ds}$$

- (b) Calculate the flux of the dipole field through a sphere of radius  $R$  centered at the origin.
- (c) What is the flux of the dipole field over *any* closed surface that does not pass through the origin?

**IV-7** Here is a “proof” that there is no such thing as magnetism. One of Maxwell’s equations tells us that

$$\nabla \cdot \mathbf{B} = 0,$$

where  $\mathbf{B}$  is any magnetic field. Then using the divergence theorem, we find

$$\iint_S \mathbf{B} \cdot \hat{\mathbf{n}} \, dS = \iiint_V \nabla \cdot \mathbf{B} \, dV = 0.$$

Because  $\mathbf{B}$  has zero divergence, we know (see Problem III-24) there exists a vector function, call it  $\mathbf{A}$ , such that

$$\mathbf{B} = \nabla \times \mathbf{A}.$$

Combining these last two equations, we get

$$\iint_S \hat{\mathbf{n}} \cdot \nabla \times \mathbf{A} \, dS = 0.$$

Next we apply Stokes’ theorem and the preceding result to find

$$\oint_C \mathbf{A} \cdot \hat{\mathbf{t}} \, ds = \iint_S \hat{\mathbf{n}} \cdot \nabla \times \mathbf{A} \, dS = 0.$$

Thus we have shown that the circulation of  $\mathbf{A}$  is path independent. It follows that we can write  $\mathbf{A} = \nabla \psi$ , where  $\psi$  is some scalar function.

## Problems

Since the curl of the gradient of a function is zero, we arrive at the remarkable fact that

$$\mathbf{B} = \nabla \times \nabla \psi = 0;$$

that is, all magnetic fields are zero! Where did we go wrong? [Taken from G. Arfken, *Amer. J. Phys.*, **27**, 526 (1959).]

*IV-8* Fick's law states that in certain diffusion processes the current density  $\mathbf{J}$  is proportional to the negative of the gradient of the density  $\rho$ ; that is,  $\mathbf{J} = -k \nabla \rho$ , where  $k$  is a positive constant. If a substance of density  $\rho(x, y, z, t)$  and velocity  $\mathbf{v}(x, y, z, t)$  diffuses according to Fick's law, show that the flow is *irrotational* (that is,  $\nabla \times \mathbf{v} = 0$ ).

*IV-9* (a) A substance diffuses according to Fick's law (see Problem IV-8). Assuming the diffusing matter is conserved, derive the diffusion equation

$$\frac{\partial \rho}{\partial t} = k \nabla^2 \rho.$$

(b) Bacteria of density  $\rho$  diffuse in a medium according to Fick's law and reproduce at a rate  $\lambda \rho$  per unit volume ( $\lambda$  is a positive constant). Show that

$$\frac{\partial \rho}{\partial t} = k \nabla^2 \rho + \lambda \rho.$$

*IV-10* (a) A fluid is said to be *incompressible* if its density  $\rho$  is a constant (that is, is independent of  $x, y, z$ , and  $t$ ). Use the continuity equation to show that the velocity  $\mathbf{v}$  of an incompressible fluid satisfies the equation  $\nabla \cdot \mathbf{v} = 0$ .

(b) If  $\nabla \times \mathbf{v} = 0$ , the fluid flow is said to be *irrotational*. Show that for an incompressible fluid undergoing irrotational flow,

$$\nabla^2 \phi = 0,$$

where  $\phi$ , a scalar function called the *velocity potential*, is so defined that  $\mathbf{v} = \nabla \phi$ .

*IV-11* The heat  $Q$  in a body of volume  $V$  is given by

$$Q = c \iiint_V T \rho \, dV,$$

where  $c$  is a constant called the specific heat of the body, and  $T(x, y, z, t)$  and  $\rho(x, y, z)$  are, respectively, the temperature and density of the body. (Note that we are assuming the density to be independent of time.) The rate at which heat flows through  $S$ , the bounding surface of the body, is given by

$$\frac{dQ}{dt} = k \iint_S \hat{\mathbf{n}} \cdot \nabla T \, dS,$$

where  $k$  (assumed constant) is the thermal conductivity of the body, and the integral is taken over the surface  $S$  bounding the body. Use these facts to derive the heat flow equation

$$\nabla^2 T = \alpha \frac{\partial T}{\partial t},$$

where  $\alpha = c\rho/k$ .

**IV-12** In nonrelativistic quantum mechanics a particle of mass  $m$  moving in a potential  $V(x, y, z)$  is described by the Schrödinger equation

$$-\frac{\hbar^2}{2m} \nabla^2 \psi + V\psi = i\hbar \frac{\partial \psi}{\partial t},$$

where  $\hbar$  is Planck's constant divided by  $2\pi$  and  $\psi(x, y, z, t)$ , which is complex, is called the wave function. The quantity  $\rho = \psi^* \psi$  is interpreted as the probability density.

(a) Use the Schrödinger equation to derive an equation of the form

$$\frac{\partial \rho}{\partial t} + \nabla \cdot \mathbf{J} = 0$$

and obtain thereby an expression for  $\mathbf{J}$  in terms of  $\psi$ ,  $\psi^*$ ,  $m$ , and  $\hbar$ .

(b) Give an interpretation of  $\mathbf{J}$  and of the equation derived in (a).

**IV-13** (a) Find the charge density  $\rho(x, y, z)$  that produces the electric field

$$\mathbf{E} = g(\mathbf{i}x + \mathbf{j}y + \mathbf{k}z),$$

where  $g$  is a constant.

(b) Find an electrostatic potential  $\Phi$  such that  $-\nabla\Phi$  is the field  $\mathbf{E}$  given in (a).

(c) Verify that  $\nabla^2\Phi = -\rho/\epsilon_0$ .

**IV-14** (a) Starting with the divergence theorem, derive the equation

$$\iint_S \hat{\mathbf{n}} \cdot (u \nabla v) dS = \iiint_V [u \nabla^2 v + (\nabla u) \cdot (\nabla v)] dV,$$

where  $u$  and  $v$  are scalar functions of position and  $S$  is a closed surface enclosing the volume  $V$ . This is sometimes called the first form of Green's theorem.

(b) If  $\nabla^2 u = 0$  use the first form of Green's theorem to show that

$$\iint_S \hat{\mathbf{n}} \cdot (u \nabla u) dS = \iiint_V |\nabla u|^2 dV,$$

where  $|\nabla u|^2 = (\nabla u) \cdot (\nabla u)$ .

(c) Use the first form of Green's theorem to show that

$$\iint_S \hat{\mathbf{n}} \cdot (u \nabla v - v \nabla u) dS = \iiint_V (u \nabla^2 v - v \nabla^2 u) dV.$$

$$\nabla^2 f = \frac{1}{v^2} \frac{\partial^2 f}{\partial t^2},$$

where  $f$  is a twice-differentiable function of position and time, is called a wave equation. It describes a wave propagating in space with velocity  $v$ . Use Maxwell's equations (Problem III-20) to show that in the absence of charges and currents (that is,  $\rho$  and  $\mathbf{J}$  both zero), all three Cartesian components of both  $\mathbf{E}$  and  $\mathbf{B}$  satisfy a wave equation with  $v = c$ , where  $c = 1/\sqrt{\epsilon_0 \mu_0}$  is the velocity of light. For example,

$$\nabla^2 E_x = \frac{1}{c^2} \frac{\partial^2 E_x}{\partial t^2}.$$


Thus, the existence of electromagnetic waves traveling in empty space with the velocity of light is a consequence of Maxwell's equations.

IV-16 (a) In the text we found the potential and field for the case of an infinite cylinder between parallel plates with the cylinder held at zero potential. How must the solution be modified if the cylinder is held at a potential  $V_0 \neq 0$ ?  
 (b) Show that there is no net charge on the cylinder.

IV-17 (a) A sphere of radius  $R$  is situated between two very large parallel plates that are separated by a distance  $s$ . A potential difference is maintained between the plates and the sphere is held at zero potential. Find the potential and field everywhere outside the sphere and between the plates. Assume that  $R \ll s$ .  
 (b) Show that there is no net charge on the sphere.  
 (c) Repeat part (a) assuming the sphere is held at a potential  $V_0 \neq 0$ .

IV-18 Let  $f(x, y)$  be a differentiable scalar function of  $x$  and  $y$ , and let  $\hat{\mathbf{u}} = \mathbf{i} \cos \theta + \mathbf{j} \sin \theta$ . Transform to a rotated coordinate system  $x', y'$  such that  $x'$  is parallel to  $\hat{\mathbf{u}}$  (see the figure). Show that the directional derivative in the direction of  $\hat{\mathbf{u}}$  is given by.

$$\frac{df}{ds} = \hat{\mathbf{u}} \cdot \nabla f = \frac{\partial f}{\partial x'}.$$



$$z = (r^2 - x^2 - y^2)^{1/2} \quad (z \geq 0).$$

Assuming both  $a$  and  $b$  are positive, in what direction must you move

- (a) so that the rate of change of  $z$  will be zero?
- (b) so that the rate of increase of  $z$  will be greatest?
- (c) so that the rate of decrease of  $z$  will be greatest?

Draw a sketch to show the geometric significance of your answers.

IV-20 The unit vector normal to the surface  $z = f(x, y)$  is given by

$$\hat{\mathbf{n}} = \left( -\mathbf{i} \frac{\partial f}{\partial x} - \mathbf{j} \frac{\partial f}{\partial y} + \mathbf{k} \right) \Bigg/ \sqrt{1 + \left( \frac{\partial f}{\partial x} \right)^2 + \left( \frac{\partial f}{\partial y} \right)^2}$$

[see Equation (II-4)]. We have also established that  $\nabla F$  is a vector normal to the surface  $F(x, y, z) = \text{const.}$  (page 140) so that  $\nabla F / |\nabla F|$  is a unit vector normal to the surface  $F(x, y, z) = \text{const.}$  Show that these two expressions for the unit normal vector are identical if  $F(x, y, z) = \text{const.}$  and  $z = f(x, y)$  describe the same surface.

IV-21 Use the results of Problem II-18 and the expression for the gradient in cylindrical coordinates (see page 144) to obtain the form of the Laplacian in cylindrical coordinates given on page 129.

IV-22 Using the procedure outlined in the text (pages 141–144) obtain the expression for the gradient of  $\psi$  in spherical coordinates:

$$\nabla \psi = \hat{\mathbf{e}}_r \frac{\partial \psi}{\partial r} + \hat{\mathbf{e}}_\phi \frac{1}{r} \frac{\partial \psi}{\partial \phi} + \hat{\mathbf{e}}_\theta \frac{1}{r \sin \phi} \frac{\partial \psi}{\partial \theta}$$


IV-23 Use the results of Problem II-19 and the expression for the gradient in spherical coordinates derived in Problem IV-22 to obtain the form of the Laplacian in spherical coordinates given on page 126.

IV-24 Suppose you find a solution of Laplace's equation that satisfies certain boundary conditions. Is this solution unique or are there others? This problem will answer that question in certain simple cases. Consider the region of space completely enclosed by a surface  $S_0$  and containing in its interior objects 1, 2, 3, ... (two of which are pictured in the diagram). Suppose that  $S_0$  is maintained at a constant potential  $\Phi_0$ , object no. 1 at  $\Phi_1$ , object no. 2 at  $\Phi_2$ , and so on. Then in the charge-free region  $R$  enclosed by  $S_0$  and between the objects, the potential must satisfy Laplace's equation

$$\nabla^2 \Phi = 0$$

and the boundary conditions

$$\Phi = \begin{cases} \Phi_0 & \text{on } S_0 \\ \Phi_1 & \text{on } S_1 \\ \Phi_2 & \text{on } S_2 \\ \vdots & \end{cases}$$



The following steps will guide you through a proof that  $\Phi$  is unique.

- Assume that there are two potentials  $u$  and  $v$ , both of which satisfy Laplace's equation and the boundary conditions listed earlier. Form their difference  $w = u - v$ . Show that  $\nabla^2 w = 0$  in  $R$ .
- What are the boundary conditions satisfied by  $w$ ?
- Apply the divergence theorem to

$$\iint_S \hat{\mathbf{n}} \cdot (w \nabla w) dS,$$

where the integration is carried out over the surface  $S_0 + S_1 + S_2 + \dots$ , and show thereby that

$$\iiint_V |\nabla w|^2 dV = 0,$$

where  $V$  is the volume of the region  $R$ .

- From the result of (c) argue that  $\nabla w = 0$  and that this, in turn, means  $w$  is a constant.
- If  $w$  is a constant, what is its value? (Use the boundary conditions on  $w$  to answer this.) What does this say about  $u$  and  $v$ ?
- The uniqueness proof outlined in (a) to (e) involves specifying the value of the potential on various surfaces. Might we have specified a different kind of boundary condition and still proved uniqueness? If so, in what way or ways would the proof and the result differ from those given above?

IV-25 In the text we defined the gradient in terms of certain partial derivatives. It is possible to give an alternative definition similar in form to our definitions of the divergence and the curl. Thus,

$$\nabla f = \lim_{\Delta V \rightarrow 0} \frac{1}{\Delta V} \iint_S \hat{\mathbf{n}} f dS.$$

Here  $f$  is a scalar function of position,  $S$  a closed surface, and  $\Delta V$  the volume it encloses. As usual,  $\hat{\mathbf{n}}$  is a unit vector normal to  $S$  and pointing out from the enclosed volume.

- Following a procedure similar to the one used in the text in treating the divergence, integrate over a "cuboid" and show that the preceding definition yields the expression

$$\nabla f = \mathbf{i} \frac{\partial f}{\partial x} + \mathbf{j} \frac{\partial f}{\partial y} + \mathbf{k} \frac{\partial f}{\partial z}.$$


(b) Use the alternative definition of the gradient given above to show that the directional derivative of  $f$  in the direction specified by the unit vector  $\hat{\mathbf{u}}$  is given by

$$\frac{df}{ds} = \hat{\mathbf{u}} \cdot \nabla f.$$

[Hint: Evaluate

$$\hat{\mathbf{u}} \cdot \iint_S \hat{\mathbf{n}} f dS = \iint_S \hat{\mathbf{u}} \cdot \hat{\mathbf{n}} f dS$$

over a small cylinder (length  $\Delta s$ , cross-sectional area  $\Delta A$ ; see figure) whose axis is in the direction of the constant unit vector  $\hat{\mathbf{u}}$ . Then divide by the volume of the cylinder ( $\Delta s \Delta A$ ) and take the limit as the volume approaches zero.]




(c) Arguing as we did in the text in establishing the divergence theorem, use the alternative definition of the gradient to show that

$$\iint_S \hat{\mathbf{n}} f dS = \iiint_V \nabla f dV,$$

where  $S$  is a closed surface enclosing the volume  $V$ .

(d) Obtain the relation stated in (c) directly from the divergence theorem. [Hint: In  $\iint_S \mathbf{F} \cdot \hat{\mathbf{n}} dS = \iiint_V \nabla \cdot \mathbf{F} dV$  put  $\mathbf{F} = \hat{\mathbf{e}} f$  where  $\hat{\mathbf{e}}$  is a constant unit vector.]



(e) Verify the relation stated in (c) for the scalar function

$$f = x^2 + y^2 + z^2$$

integrating over the unit cylinder shown in the figure.

**IV-26** (a) Consider a surface  $z = f(x, y)$ . Let  $\mathbf{u}$  be a vector of arbitrary length tangent to the surface at a point  $P(x, y, z)$  in the direction of the unit vector  $\hat{\mathbf{p}} = \mathbf{i}p_x + \mathbf{j}p_y$  as indicated in the figure. Use the directional derivative to show that

$$\mathbf{u} = \hat{\mathbf{p}} + \mathbf{k}(\hat{\mathbf{p}} \cdot \nabla f),$$

where  $\nabla f$  is evaluated at  $(x, y)$ . [Note: Since the length of  $\mathbf{u}$  is arbitrary, your result may differ from the preceding by some positive multiplicative constant.]


(b) Let  $\mathbf{v}$  be a second vector of arbitrary length tangent to the surface at  $P$  but in the direction of the unit vector  $\hat{\mathbf{q}} = \mathbf{i}q_x + \mathbf{j}q_y$  ( $\hat{\mathbf{p}} \neq \hat{\mathbf{q}}$ ). Then from (a) we have

$$\mathbf{v} = \hat{\mathbf{q}} + \mathbf{k}(\hat{\mathbf{q}} \cdot \nabla f).$$

Show that

$$\mathbf{u} \times \mathbf{v} = [\mathbf{k} \cdot (\hat{\mathbf{p}} \times \hat{\mathbf{q}})](\mathbf{k} - \nabla f)$$

and use this to rederive Equation (II-4) for the unit vector  $\hat{\mathbf{n}}$  normal to the surface  $z = f(x, y)$  at  $(x, y, z)$ . This shows that the result derived in the text for  $\hat{\mathbf{n}}$  is unique (apart from sign) even though it was obtained with the special choices  $\hat{\mathbf{p}} = \mathbf{i}$  and  $\hat{\mathbf{q}} = \mathbf{j}$ .



**IV-27** (a) Using Maxwell's equations (see Problem III-20), show that we can write

$$\mathbf{B} = \nabla \times \mathbf{A},$$

$$\mathbf{E} = -\nabla\Phi - \frac{\partial \mathbf{A}}{\partial t},$$

where  $\mathbf{A}$  (called the vector potential) is some vector function of position and time, and  $\Phi$  (the scalar potential) is some scalar

function of position and time, provided  $\mathbf{A}$  and  $\Phi$  satisfy the equations

$$\nabla^2\Phi + \frac{\partial}{\partial t}(\nabla \cdot \mathbf{A}) = -\rho/\epsilon_0,$$

$$\nabla^2\mathbf{A} - \mu_0\epsilon_0 \frac{\partial^2\mathbf{A}}{\partial t^2} = -\mu_0\mathbf{J} + \nabla \left[ \nabla \cdot \mathbf{A} + \mu_0\epsilon_0 \frac{\partial\Phi}{\partial t} \right].$$

(b) Show that if we define two new potentials

$$\mathbf{A}' = \mathbf{A} + \nabla\chi,$$

$$\Phi' = \Phi - \frac{\partial\chi}{\partial t},$$

where  $\chi$  is an arbitrary scalar function of position and time, then

$$\mathbf{B} = \nabla \times \mathbf{A}',$$

$$\mathbf{E} = -\nabla\Phi' - \frac{\partial\mathbf{A}'}{\partial t}.$$

That is, the fields  $\mathbf{E}$  and  $\mathbf{B}$  are not modified by the change in the potentials  $\mathbf{A}$  and  $\Phi$ . The change from  $(\mathbf{A}, \Phi)$  to  $(\mathbf{A}', \Phi')$  is called a *gauge transformation*.

(c) Show that if we require  $\chi$  to satisfy the equation

$$\nabla^2\chi - \epsilon_0\mu_0 \frac{\partial^2\chi}{\partial t^2} = -\left[ \nabla \cdot \mathbf{A} + \epsilon_0\mu_0 \frac{\partial\Phi}{\partial t} \right],$$

then

$$\nabla \cdot \mathbf{A}' + \epsilon_0\mu_0 \frac{\partial\Phi'}{\partial t} = 0.$$

(d) If  $\chi$  satisfies the equation given in (c), show that  $\mathbf{A}'$  and  $\Phi'$  satisfy the equations

$$\nabla^2\Phi' - \epsilon_0\mu_0 \frac{\partial^2\Phi'}{\partial t^2} = -\frac{\rho}{\epsilon_0}$$

and

$$\nabla^2\mathbf{A}' - \epsilon_0\mu_0 \frac{\partial^2\mathbf{A}'}{\partial t^2} = -\mu_0\mathbf{J}.$$

The point to all of this is that we can make a gauge transformation [as in (b)], impose the condition given in (c), and thereby obtain a scalar and a vector potential that satisfy the equations in part (d), which are wave equations with source terms proportional to  $\rho$  and  $\mathbf{J}$ .

IV-28 The equation of motion of an ideal fluid can be written

$$\iiint_V \rho \mathbf{f}_{\text{ext}} \, dV - \iint_S \hat{\mathbf{n}} \cdot \mathbf{p} \, dS = \iint_V \rho \left[ \frac{\partial \mathbf{v}}{\partial t} + (\mathbf{v} \cdot \nabla) \mathbf{v} \right] \, dV$$

where  $V$  is the volume of the fluid and  $S$  is its surface. Here  $\mathbf{f}_{\text{ext}}(x, y, z)$  is the external force per unit mass acting on the fluid,  $\mathbf{p}(x, y, z)$  is the

pressure of the fluid, and  $\rho(x, y, z)$  is its density, all at a point  $(x, y, z)$  in the fluid, and  $\mathbf{v}(x, y, z, t)$  is the velocity of the fluid at the point  $(x, y, z)$  and at time  $t$ .

(a) Use the form of the divergence theorem given in Problem IV-25(c) to rewrite the equation of motion of an ideal fluid in the form

$$\mathbf{f}_{\text{ext}} - \frac{1}{\rho} \nabla p = \frac{\partial \mathbf{v}}{\partial t} + (\mathbf{v} \cdot \nabla) \mathbf{v}.$$







### GRADIENT

$$\begin{aligned} \operatorname{grad} f & \quad (\nabla f)_x = \frac{\partial f}{\partial x} & (\nabla f)_r = \frac{\partial f}{\partial r} \\ \nabla f & \quad (\nabla f)_y = \frac{\partial f}{\partial y} & (\nabla f)_\theta = \frac{1}{r} \frac{\partial f}{\partial \theta} \\ & \quad (\nabla f)_z = \frac{\partial f}{\partial z} & (\nabla f)_z = \frac{\partial f}{\partial z} \end{aligned}$$


### CURL

$$\begin{aligned} \operatorname{curl} \mathbf{F} & \quad (\nabla \times \mathbf{F})_x = \frac{\partial F_z}{\partial y} - \frac{\partial F_y}{\partial z} & (\nabla \times \mathbf{F})_r = \frac{1}{r} \frac{\partial F_z}{\partial \theta} - \frac{\partial F_\theta}{\partial z} \\ \nabla \times \mathbf{F} & \quad (\nabla \times \mathbf{F})_y = \frac{\partial F_x}{\partial z} - \frac{\partial F_z}{\partial x} & (\nabla \times \mathbf{F})_\theta = \frac{\partial F_r}{\partial z} - \frac{\partial F_z}{\partial r} \\ & \quad (\nabla \times \mathbf{F})_z = \frac{\partial F_y}{\partial x} - \frac{\partial F_x}{\partial y} & (\nabla \times \mathbf{F})_z = \frac{1}{r} \frac{\partial}{\partial r} (r F_\theta) - \frac{1}{r} \frac{\partial F_r}{\partial \theta} \end{aligned}$$

### LAPLACIAN

$$\begin{aligned} \nabla^2 f & \quad \frac{\partial^2 f}{\partial x^2} + \frac{\partial^2 f}{\partial y^2} + \frac{\partial^2 f}{\partial z^2} \\ & \quad \frac{1}{r} \frac{\partial}{\partial r} \left( r \frac{\partial f}{\partial r} \right) + \frac{1}{r^2} \frac{\partial^2 f}{\partial \theta^2} + \frac{\partial^2 f}{\partial z^2} \end{aligned}$$

SPHERICAL



$$\frac{1}{r^2} \frac{\partial}{\partial r} (r^2 F_r) + \frac{1}{r \sin \phi} \frac{\partial}{\partial \phi} (\sin \phi F_\phi) + \frac{1}{r \sin \phi} \frac{\partial F_\theta}{\partial \theta}.$$

$$(\nabla f)_r = \frac{\partial f}{\partial r}$$

$$(\nabla f)_\phi = \frac{1}{r} \frac{\partial f}{\partial \phi}$$

$$(\nabla f)_\theta = \frac{1}{r \sin \phi} \frac{\partial f}{\partial \theta}$$

$$(\nabla \times \mathbf{F})_r = \frac{1}{r \sin \phi} \frac{\partial}{\partial \phi} (\sin \phi F_\theta) - \frac{1}{r \sin \phi} \frac{\partial F_\phi}{\partial \theta}$$

$$(\nabla \times \mathbf{F})_\phi = \frac{1}{r \sin \phi} \frac{\partial F_r}{\partial \theta} - \frac{1}{r} \frac{\partial}{\partial r} (r F_\theta)$$

$$(\nabla \times \mathbf{F})_\theta = \frac{1}{r} \frac{\partial}{\partial r} (r F_\phi) - \frac{1}{r} \frac{\partial F_r}{\partial \phi}$$

$$\frac{1}{r^2} \frac{\partial}{\partial r} \left( r^2 \frac{\partial f}{\partial r} \right) + \frac{1}{r^2 \sin \phi} \frac{\partial}{\partial \phi} \left( \sin \phi \frac{\partial f}{\partial \phi} \right) + \frac{1}{r^2 \sin^2 \phi} \frac{\partial^2 f}{\partial \theta^2}$$
